Opinion

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

General

The IBM Benefits Plan for Retired Employees (the “Plan”) is a contributory health and welfare plan providing life insurance, medical, dental and vision benefits to eligible retired employees of International Business Machines Corporation (“IBM”) and their eligible dependents as well as IBM employees who are eligible for benefits under the IBM Long Term Disability Plan (“LTD Plan”) or the IBM Medical Disability Income Plan (“MDIP Plan”) (and their eligible dependents). Employees hired after July 31, 1990 are eligible for Plan benefits if, at termination of employment, they have at least 15 years of IBM service and are at least age 55 or, for certain employees, have 30 years of service at any age. Eligible individuals may elect to enroll in a health maintenance organization and a dental maintenance alternative. Employees retired as of June 30, 1999, and those within five years of retirement eligibility on that date, are eligible for company paid premiums up to certain capped amounts described in Note 6. Employees hired prior to January 1, 2004 and not within five years of retirement eligibility on June 30, 1999 are eligible to participate in the Future Health Account (“FHA”) also described in Note 6. In 2013, IBM amended the Plan such that employees hired prior to January 1, 2004 who remain continuously employed by IBM and retire from IBM on or after January 1, 2015 are not eligible for group life insurance coverage under the Plan after they terminate employment with IBM, even if they retire.

Effective January 1, 2023, Medicare-eligible Plan participants (including retirees, surviving spouses, and Plan participants receiving benefits under the LTD Plan or MDIP Plan) and their eligible Medicare-eligible dependents may enroll in Plan coverage under one of two fully insured group Medicare Advantage options. Those eligible for an IBM subsidy who enroll in one of the plan options receive, depending on their retirement date, a subsidy under the Plan in the form of either (i) access to their FHA converted to a Health Reimbursement Arrangement (HRA), or (ii) either a premium reduction or a contribution to an HRA in an amount determined based on their selected plan option and whether they previously elected survivor coverage. The HRA can be used to fund eligible 213(d) expenses incurred by the participant or eligible tax dependents.

Participants should refer to the Plan’s summary plan description for a more complete description of the Plan’s provisions.

Plan assets are held in a sub-account of the IBM Medical Benefits Trust (the “Master Trust”). The assets of the Master Trust consist of assets of the Plan and assets of the IBM Medical & Dental Benefits Plan for Regular and Part-Time Employees (the “Active Plan”).

Administration

The IBM Retirement Plans Committee and the Plan Administrator, as defined in the Plan (the “Plan Administrator”), are named fiduciaries under the Plan. The Plan Administrator is responsible for the administration of the Plan. IBM has entered into a trust agreement with JPMorgan Chase Bank (the “Trustee”) for the safeguarding of the assets of the Plan. Group life insurance benefits are insured by Metlife, Inc. IBM medical, dental and vision plan benefits are processed by various contract administrators under Administrative Services Only (“ASO”) contracts.

The Plan utilizes a prescription benefit manager (“PBM”) which periodically makes refunds to the Plan based on the Plan’s utilization pattern of specific drugs.

Funding Policy

IBM either makes payments from the Master Trust or directly from general IBM assets to the Master Trust, to cover payment of benefit claims. Retiree contributions are also a source of funding and together with IBM assure timely liquidity, and a minimum fund balance of approximately 1-2 months of claims. Any deficiency of the Plan’s net assets over benefit obligations is funded by IBM on a pay-as-you-go basis.

Plan Termination

The Plan may be terminated, in whole or in part, upon resolution of the IBM Board of Directors, or any individual or committee to whom the power to terminate has been duly delegated. In the event of termination, no action will be taken to divert any funds of the Plan prior to the satisfaction of all liabilities under the Plan. Should federal, state or comparable governmental legislation or regulation not presently in existence duplicate payments made under the Plan then payments may be discontinued. Any funds remaining may be used to pay for certain nonretirement benefits for active employees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting, with the exception of benefit payments which are recorded when paid.

Basis of Presentation

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust, plus actual contributions and the Plan's share of investment gains or losses, less actual distributions and allocated administrative expenses. For financial reporting purposes, income on Plan assets and realized or unrealized gains or losses on such assets, as well as administrative expenses, are allocated to the Plan based on its proportionate share of the Master Trust assets. Certain Plan contributions are made in the form of US Treasury Bills, which are sold a short time later and converted to cash. Interest income and realized gains or losses related to these US Treasury Bills are credited directly to the Plan sub account of the Master Trust. Within the financial tables presented, certain columns and rows may not add due to the use of rounded numbers for disclosure purposes.

Valuation of Investment

The Plan's investment in the Master Trust is recorded at an amount equal to the Plan's interest in the underlying investments of the Master Trust. The investment in the Master Trust is stated at fair value. Accounting guidance defines fair value as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Under this guidance, the Plan is required to classify certain assets and liabilities based on the following fair value hierarchy:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities that can be accessed at the measurement date; and
- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly; and
- Level 3 – Unobservable inputs for the asset or liability.

The guidance requires the use of observable market data if such data is available without undue cost and effort.

Assets are classified within the fair value hierarchy according to the lowest level input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered investment companies (mutual funds) are valued at the net asset value per share using available inputs to measure fair value of such companies or funds as of the valuation date. Generally, mutual funds have a quoted market price in an active market and are classified as Level 1.

Net appreciation (depreciation) in fair value in investment of the Master Trust includes realized gains and losses on investments that were both purchased and sold during the period as well as unrealized appreciation (depreciation) resulting from changes in Master Trust investment values.

Securities Transactions and Related Investment Income and Expenses

The Master Trust records securities transactions on a trade date basis and interest income on the accrual basis.

IBM may pay administrative costs of the Plan or, at IBM's option, administrative costs may be paid from the Plan's share of the Master Trust assets. In 2024 and 2023, trustee and investment manager fees and certain other administrative costs were paid by the Plan's share of the Master Trust assets.

Postretirement Benefit Obligation

The following is a discussion of the Plan benefits that support the retiree participants. The accumulated postretirement benefit obligation represents the actuarial present value of those estimated future benefits provided by IBM that are attributable to employee service rendered prior to the valuation date, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits are future benefits expected to be paid for (1) currently retired participants and their eligible beneficiaries and dependents; and (2) active participants and beneficiaries and dependents after retirement from IBM.

The actuarial present value of the accumulated postretirement benefit obligation is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims per participant. Such estimates are adjusted for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, retirement and termination of employment) between the valuation date and the expected date of payment, and to reflect the portion of those benefits expected to be borne by Medicare, retired participants and other providers.

For measurement purposes at December 31, 2024, IBM reviews external data consistent with the type of options provided under the Plan to determine the healthcare cost trend rates. The U.S healthcare cost trend rate assumption for 2025 in medical, surgical and hospital per capita costs is 6.47% and is expected to decrease to 4.5% over approximately 13 years. For measurement purposes at December 31, 2023, the annual rate of increase in medical, surgical and hospital per capita costs was expected to increase by 6.69% in 2024 grading to 4.5% over a 14 year period. The effect of a 1% increase in these assumed cost trend rates would increase the accumulated postretirement benefit obligation by approximately \$5 million and \$19 million respectively at December 31, 2024 and 2023.

The following were other significant assumptions used in the valuations as of December 31, 2024 and December 31, 2023:

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Benefit Payments and Plan Expenses

Group life insurance premiums are paid by the Plan to the insurance company based on claims experience plus administrative expenses, retention and contingencies. Medical, dental and vision benefits are paid directly to the service providers by the ASO representatives based on claims processed and approved by the ASO representatives and submitted to the Plan for reimbursement. Benefit payments are recorded upon distribution. Any rebates, refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Rebates from the Plan's PBM are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset netted against claims paid. Pharmacy rebates totaling \$1.7M and \$2.3M have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 respectively.

Plan expenses, such as administrative service fees, are paid by the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make use of estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures at the date of the financial statements. Actual results could differ from the estimates that were used.

Risks and Uncertainties

The Master Trust invests in a money market mutual fund which is exposed to various risks, such as interest rate and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

3. Federal Income Taxes

Plan assets were held in the IBM Retiree Benefit Trust (the "Retiree Trust") through December 31, 2010. Effective January 1, 2011 the assets of the Plan are held in a sub-account of the Master Trust.

The Internal Revenue Service ("IRS") determined and informed management by a notification of tax exemption letter dated February 15, 1977 that the Retiree Trust was designed in accordance with the applicable sections of the Internal Revenue Code ("IRC") and was therefore tax exempt under the IRC. IBM filed the IRS Form 1024, Application for Recognition of Exemption, with respect to the Master Trust, was filed with the IRS on April 26, 2013. Based upon its review of the application, on June 18, 2014, the IRS informed tax counsel that the predecessor trust's tax exemption letter remains valid and applicable to the current Master Trust. Therefore, the IRS will not issue an updated exemption letter to the Master Trust's existing taxpayer identification number. For the tax years 2024 and 2023, the Master Trust and the Plan sub-account of the Master Trust did not incur any unrelated business income tax. The Plan has been amended since receiving the notification of tax exemption letter. However, the Plan Administrator and tax counsel believe that the Master Trust is designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examination for years prior to 2020.

4. Master Trust

As discussed in Notes 1 and 2, the Plan participates in the Master Trust. The Trustee holds the Master Trust's investment assets and provides administrative functions for each of the plans participating in the Master Trust. The assets of the Master Trust consist of assets of the Plan and assets of the Active Plan. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 40 percent and 54 percent, respectively.

6. Accumulated Plan Benefit Obligations

It is expected that the Plan's unfunded liability at December 31, 2024 will be funded through future payments from IBM general corporate assets.

Retirements after December 31, 1991

IBM's aggregate annual liability is limited to \$7,000 times the number of retirees not yet eligible for Medicare. This limit is used to pay medical, dental and vision benefits, as well as administrative costs. For retirees eligible for Medicare, IBM's liability is as per the Plan terms (summarized in the Plan Description in Note 1), but not more than \$3,000 times the number of retirees and is used to pay all benefits and administrative costs other than for the Special Health Assistance Provision and dental benefits.

Effective January 1, 2014, IBM's aggregate annual liability for retirees eligible for Medicare and their Medicare-eligible dependents is limited to the amounts contributed to Health Reimbursement Arrangements (HRAs). IBM also contributes an additional amount for non-Medicare-eligible dependents of these retirees, for other benefits under the Plan for these retirees and their Medicare-eligible dependents (including coverage for significant prescription drug expenses), and for administrative expenses of the Plan (the Additional Amounts).

Pre-1992 retirements

Starting in 2001, IBM's aggregate annual liability is limited to \$7,500 times the number of retirees not yet eligible for Medicare, and for retirees eligible for Medicare, IBM's liability is as per the Plan terms (summarized in the Plan Description in Note 1), but not more than \$3,500.

Effective January 1, 2014, IBM's aggregate annual liability for retirees eligible for Medicare and their Medicare-eligible dependents is limited to the amounts contributed to HRAs and the Additional Amounts.

Future Health Account (FHA)

Effective July 1, 1999, a FHA was established for all employees hired before January 1, 2004 who (i) were at least 40 years of age and with one year of service and who were not within five years of earliest retirement eligibility as of June 30, 1999, or (ii) who turn age 40 with one year of service after June 30, 1999. The FHA provides for transition credits based on attained age at July 1, 1999 (for those in clause (i) above), monthly credits based on a maximum of \$2,500 per year for 10 years or date of departure if earlier and interest credits that accumulate in an unfunded, unvested notional account. Employees leaving IBM at age 55 or older with at least 15 years of service and certain employees who have completed at least 30 years of service may apply any or all of the balance in their FHA towards IBM health plan coverage premiums under the Plan. For eligible employees, the FHA replaces the capped IBM contribution amounts described in the previous paragraphs. Effective January 1, 2004, new hires and rehires are no longer eligible for the FHA. Effective January 1, 2014, FHAs for Medicare-eligible participants are converted to HRAs.

Retiree Life Insurance

For employees hired prior to January 1, 2004 and who remain continuously employed by IBM and retire from IBM prior to January 1, 2015, retiree life insurance coverage is equal to one half of the amount in force immediately prior to retirement to a maximum of \$25,000. At age 65, life insurance reduces to \$5,000. Employees hired prior to January 1, 2004 who remain continuously employed by IBM and retire on or after January 1, 2015 are not eligible for retiree life insurance coverage under the Plan after they terminate employment with IBM. Effective January 1, 2004, new hires and rehires are no longer eligible for retiree life insurance.
