Report of Independent Auditors

To the Administrator of the IBM Medical Plan for Regular Full-time and Regular Part-time Employees

Opinion

We have audited the accompanying financial statements of the IBM Medical Plan for Regular Full-time and Regular Part-time Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, including the related notes (collectively referred to as the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

General

The IBM Medical Plan for Regular Full-time and Regular Part-time Employees (the "Plan") provides certain benefits to regular full-time and part-time employees of International Business Machines Corporation ("IBM") and certain of its domestic subsidiaries, as well as their spouses, and eligible domestic partners and eligible dependent children. Certain non-regular employees of IBM and certain of its domestic subsidiaries are also eligible. The Plan includes various Plan options.

Participants should refer to the Plan's summary plan description for a more complete description of the Plan's provisions.

Plan assets are held in a sub-account of the IBM Medical Benefits Trust (the "Master Trust"). The assets of the Master Trust consist of assets of the Plan and assets of the IBM Benefits Plan for Retired Employees (the "Retiree Plan").

Administration

The Plan is administered by the IBM Plan Administrator. IBM has entered into a trust agreement with JPMorgan Chase Bank (the "Trustee") for the safeguarding of the assets of the Plan. Benefits for self-insured medical Plan options are processed under Administrative Service Only ("ASO") contracts with various vendors and are paid directly from the Master Trust. The Plan also has fully insured HMO, dental and vision Plan options. Premiums for these insured options are paid from the Master Trust and the insurer pays Plan benefits to eligible participants.

The Plan also provides a health care flexible spending account (HCSA). Plan participants may elect to enroll and defer up to \$3,200 annually in 2024 compared to \$3,050 in 2023, for reimbursement of qualified medical expenses. HCSA contributions in the amount of \$5.2M and \$5.0M were made via pretax payroll deductions for the year ended December 31, 2024 and 2023 respectively. Participants must normally submit claims for qualified expenses incurred as of the Plan year, by June 30 subsequent to the Plan year. All remaining amounts are forfeited.

The Plan utilizes a prescription benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's utilization pattern of specific drugs.

Funding Policy

Benefit costs are based upon actual benefit payments throughout the Plan year and are adjusted by internal projections which include an estimate of unpaid and unasserted claims incurred in the Plan year which will be paid in subsequent years. Historical and economic trend assumptions are factors included within the internal projections. IBM and the Plan participants contribute the funds necessary to meet current obligations of the Plan. Any deficiency of the Plan's net assets over benefit obligations is funded by IBM on a pay-as-you-go basis.

Plan participants are generally required to contribute towards the costs of their selected Plan option via pretax payroll deductions. The amount participants pay is set annually by IBM and varies with the number of dependents and the Plan option selected by the participant. IBM contributes the funds necessary to meet current Plan obligations to the extent they exceed total amounts contributed by the

participants. Certain Plan benefits also are paid to employees by IBM as taxable income. Employees who enroll in certain Plan options and have opened a Health Savings Account receive tax free contributions to their Health Savings Account from IBM.

Effective July 2022, the HCSA Administrator now requires a funding deposit which is used to reimburse employees daily and is replenished weekly with IBM general funds representing employee contributions to the program. The deposit balance was \$86K for the year ended December 31, 2024, compared to \$123K for the year ended December 31, 2023.

Plan Termination

The Plan may be terminated, in whole or in part, upon resolution of the IBM Board of Directors, or any individual or committee to whom the power to terminate has been duly delegated. In the event of termination, no action will be taken to divert any funds of the Plan prior to the satisfaction of all liabilities under the Plan. Should federal, state or comparable governmental legislation or regulation not presently in existence duplicate payments made under the Plan, then payments may be discontinued. Any funds remaining may be used to pay for certain nonretirement benefits for active employees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting, with the exception of benefit payments which are recorded when paid.

Basis of Presentation

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust, plus actual contributions and the Plan's share of investment gains or losses, less actual distributions and allocated administrative expenses. For financial reporting purposes, income on Plan assets and realized or unrealized gains or losses on such assets, as well as administrative expenses, are allocated to the Plan based on its proportionate share of the Master Trust assets. Certain Plan contributions are made in the form of US Treasury Bills, which are sold a short time later and converted to cash. Interest income and realized gains or losses related to these US Treasury Bills are credited directly to the Plan sub account of the Master Trust. Within the financial tables presented, certain columns and rows may not add due to the use of rounded numbers for disclosure purposes.

Valuation of Investment

The Plan's investment in the Master Trust is recorded at an amount equal to the Plan's interest in the underlying investments of the Master Trust. The investment of the Master Trust is stated at fair value. Accounting guidance defines fair value as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Under this guidance, the Plan is required to classify certain assets and liabilities based on the following fair value hierarchy:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities that can be accessed at the measurement date; and

- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly; and
- Level 3 – Unobservable inputs for the asset or liability.

The guidance requires the use of observable market data if such data is available without undue cost and effort.

Assets are classified within the fair value hierarchy according to the lowest level input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered investment companies (mutual funds) are valued at the net asset value per share using available inputs to measure fair value of such companies or funds as of the valuation date. Generally, mutual funds have a quoted market price in an active market and are classified as Level 1.

Net appreciation (depreciation) in fair value in investment of the Master Trust includes realized gains and losses on investments that were both purchased and sold during the period as well as unrealized appreciation (depreciation) resulting from changes in Master Trust investment values.

Securities Transactions and Related Investment Income and Expenses

The Master Trust records securities transactions on a trade date basis and interest income on the accrual basis.

IBM may pay the administrative costs of the Plan or, at IBM's option, administrative costs may be paid from the Plan's share of the Master Trust assets. In 2024 and 2023, trustee and investment manager fees and certain other administrative costs were paid by the Plan's share of the Master Trust assets.

Benefit Payments and Plan Expenses

For self-insured Plan options, medical benefits are paid directly to participants, or to service providers on their behalf, based upon claims processed and approved by the respective ASO representatives. Benefit payments are recorded upon distribution. Except for certain rebates from the PBM, any rebates, refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments. For insured Plan options, the Plan pays an insurance premium to the HMO or insurance company who manage payment of Plan benefits.

Rebates from the Plan's PBM are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset netted against claims paid. Pharmacy rebates totaling \$22.5M and \$20.6M have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 respectively.

Plan expenses, such as administrative service fees, are paid by the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make use of estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not yet

reported, claims payable and disclosures at the date of the financial statements. Actual results could differ from the estimates that were used.

Risks and Uncertainties

The Master Trust invests in a money market mutual fund which is exposed to various risks, such as interest rate and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

3. Federal Income Taxes

Plan assets were held in the IBM Corporation Medical and Dental Benefits Trust ("Active Trust") through December 31, 2010. Effective January 1, 2011, the assets of the Plan are held in a sub-account of the Master Trust.

The Internal Revenue Service determined and informed management by a notification of tax exemption letter dated January 26, 1988, that the Active Trust was designed in accordance with the applicable sections of the Internal Revenue Code ("IRC") and was therefore tax exempt under the IRC. Form 1024, Application for Recognition of Exemption, with respect to the Master Trust, was filed with the IRS on April 26, 2013. Based upon its review of the application, on June 18, 2014, the IRS informed tax counsel that the predecessor trust's tax exemption letter remains valid and applicable to the current Master Trust. Therefore, the IRS will not issue an updated exemption letter to the Master Trust's existing taxpayer identification number.

For tax years 2024 and 2023, the Master Trust and the Plan sub-account of the Master Trust did not incur any unrelated business taxable income tax. The Plan has been amended since receiving the notification of tax exemption letter. However, the Plan Administrator and tax counsel believe that the Master Trust is designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examination for years prior to 2020.

4. Master Trust

As discussed in Notes 1 and 2, the Plan participates in the Master Trust. The Trustee holds the Master Trust's investment assets and provides administrative functions for each of the plans participating in the

Master Trust. The assets of the Master Trust consist of assets of the Plan and assets of the Retiree Plan. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 60 percent and 46 percent, respectively.
