To the Trustees of the

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Northeastern Supply, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 **DESCRIPTION OF PLAN**

The following brief description of the Northeastern Supply, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan documents or the Summary Plan Description for more complete information.

GENERAL

The Plan is a defined contribution plan open to all employees of Northeastern Supply, Inc. (Company). Employees shall become eligible participants of the Plan following completion of 45 days of service, as defined by the Plan. Eligible employees' entry date will be the first day of the month coinciding with or next following the date of satisfaction. Leased employees are not eligible. Upon becoming eligible Plan participants, employees will be automatically enrolled in the Plan, barring an affirmative election to the contrary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code (IRC). The Company may make matching contributions for active participants in the Plan based on a discretionary percentage determined annually by the Company. The Company may also make special discretionary contributions to the Plan.

PARTICIPANT ACCOUNTS

Each participant account is credited with the participant's contribution, any Company matching contribution, any special contribution, and an allocation of any Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS

Upon enrollment in the Plan, a participant may direct contributions to specified investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow an amount from the Plan collateralized by their account balances. The maximum loan permitted is the lesser of (1) \$50,000 or (2) 50% of the participant's vested account balance. Principal and interest are paid ratably through payroll deductions.

(See Independent Auditors' Report)

Loans mature within five years or within a period to be determined by the Company for the purchase of a primary residence.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. A participant's interest in Company matching and special discretionary contributions becomes fully vested and nonforfeitable upon six years of service, retirement, disability (as defined by the Plan), or death of the participant.

PAYMENT OF BENEFITS

In the case of normal retirement, retirement due to permanent disability, or termination of employment, a participant may elect to receive the value of the participant's account in a lump-sum distribution or mutually agreed upon alternative manner. If a participant dies before retirement, the beneficiary will receive the value of the participant's account in a lump-sum distribution or mutually agreed upon alternative manner.

ADMINISTRATIVE EXPENSES

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

FORFEITED ACCOUNTS

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,343 and \$13,995, respectively. In 2024, \$55,661 of forfeitures were used to pay Plan expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

ACCOUNTING STANDARDS CODIFICATION

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements

and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

BASIS OF ACCOUNTING

The accompanying financial statements were prepared on the accrual basis of accounting.

VALUATION OF INVESTMENTS

Investments are stated at fair value except for fully benefit responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

PAYMENTS OF BENEFITS

Benefits are recorded when paid.

RISK AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 11, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

The Plan's investments were held by the Custodian, Principal Trust Company, at December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate

NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

(See Independent Auditors' Report)

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There was no change in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Pooled Separate Accounts: Valued using NAV per unit. The NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 **GUARANTEED INTEREST ACCOUNT**

The Plan has an investment in the Principal Fixed Income Guaranteed Option Account (Principal), which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

NOTE 6 **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

NOTE 7 **TAX STATUS**

The Plan adopted a volume submitter profit-sharing plan with a cash or deferred arrangement developed by Coastal Pension Services, Inc. The volume submitter plan received an opinion letter from the Internal Revenue Service dated November 30, 2020 determining the volume submitter plan's qualified status.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

NOTE 8 **RELATED-PARTY TRANSACTIONS**

The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$148,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
