Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1: Description of the Plan

The following description of the Advanced Orthopaedic Associates, PA 401(K) Plan (the Plan), provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of Advanced Orthopaedic Association, P.A. (the Company). An employee becomes eligible to enroll in the Plan on the first day of the month following the completion of one year of service and attainment of age 21. Employees must have 1,000 hours of service in the current Plan year in order to be eligible for profit sharing contributions. Part-time employees are eligible to contribute to the Plan starting January 1, 2021, if they meet the 500 hours of service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and later amendments.

Plan investments were in the custody of John Hancock Life Insurance Company from January 1, 2024 - September 30, 2024 and Principal Trust Company from October 1, 2024 - December 31, 2024 (the Custodian). These assets consist primarily of shares in various mutual funds.

Participant Contributions - Self Directed

Participating employees may elect to enter into a contribution reduction agreement to reduce compensation up to 75% of compensation not to exceed IRS limits, which will be contributed to the Plan in their name. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, collective investment trusts and a guaranteed investment option as investment options for participants.

The Plan may accept a proper rollover from another qualified plan.

Employer Contributions

The Company will make a safe harbor non-elective contributions up to 3% of the participants compensation, exclusive of reimbursements or expense allowances, fringe benefits, moving expenses, deferred compensation, welfare benefit, and severance payments.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make a profit sharing contribution, as defined in the Plan document. This additional contribution is allocated to eligible participants based upon the completion of 1,000 or more hours of service and are allocated based on Plan year compensation. If a participant does not elect to make salary reduction contributions to the Plan, the participant shall be deemed to have elected to contribute 3% of the participant's compensation to the Plan. This contribution is invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. All costs, fees, and expenses associated with the participant's account maybe charged or deducted from the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Employer safe harbor contributions are 100% vested. Profit sharing is subject to a 6 year vesting period.

Participant Loans

Loans are not permitted.

Benefits

Distributions are made upon death, disability, retirement or termination of employment. The participant may receive a lump-sum amount equal to the value of their vested interest or as an annuity payment. In-service distributions are permitted from the participant's account upon attaining age 59 1/2. Benefits are recorded when paid.

Forfeitures

The Plan is a safe harbor plan and as such, forfeitures do not apply to employer matches. Elective profit sharing contributions are not safe harbor contributions and subject to a 6 year vesting period. Forfeitures can be used to reduce employer contributions, or can be reallocated to the participants, or pay Plan expenses. For the Plan years ending December 31, 2024 and 2023, forfeitures totaled \$72,477 and \$10,417, respectively. For the Plan year ending December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$10,417 and \$11,679, respectively. The balances of the forfeitures accounts was \$72,477 and \$10,425 for the years ending December 31, 2024 and 2023, respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of the participants accounts or distributions are charged directly to the participant's account. Other expenses such as John Hancock and Principal administrative fees are included in administrative expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employee's payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by the Custodian as of the Plan year-end. Shares of mutual funds and the collective investment trusts are valued at the net asset value (NAV) of shares held by the Plan at year-end. Investment contracts are reported at contract value.

Net appreciation (depreciation) includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Money Market Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds

Valued at the net assets value (NAV) of units of the bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Note 4: Related Party and Party in Interest Transactions

The Plan Sponsor absorbs some administrative expenses of the Plan, cost of audit fees and the cost of fiduciary bonds. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements.

Certain Plan investments are shares in proprietary funds managed by the Custodian, for which they are paid a minimal fee. Investment related expenses are included in the administrative expenses. The TPA, EGPS, Show Me Pension and the investment advisor, UBS Financial Services, Inc., are paid fees through revenue sharing with John Hancock and Principal. These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Company. Additional party-in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time subject to the provisions of ERISA. In the event of termination, each participant will have a non-forfeitable interest in his/her entire individual account.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8: Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian. The custodian certifying the investments was John Hancock Life Insurance Company for all of 2023 and from January 1, 2024 - September 30, 2024. The Plan changed custodians to Principal Trust Company on October 1, 2024 and they certified the investments from October 1, 2024 - December 31, 2024.

Note 9: Reconciliation of Financial Statements to Form 5500

The net assets available for benefits per the financial statements at December 31, 2024 and 2023 reconcile to Schedule H of Form 5500.

Note 10: Subsequent Events

Management has evaluated subsequent events through September 25, 2025, the date on which the financial statements were available to be issued.
