Independent Auditors' Report

To the Participants and Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JYG Innovations 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JYG Innovations 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of the JYG Innovations 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by JYG Innovations LLC (the Company, Employer or Plan Sponsor) and covers substantially all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Under the terms of the Plan, covered employees are eligible to become participants on the first day of the month following or coincident with attainment of age 18.

Contributions

- (a) *Participant's voluntary salary reductions.* Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to IRS limitations. Pre-tax elective deferrals and after-tax Roth contributions are available. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan also provides for catch-up contributions for participants over the age of 50.
- (b) *Safe harbor employer matching contributions.* The Plan is a safe harbor plan. Under the safe harbor provisions, the Plan Sponsor is required to provide a matching contribution. The Plan Sponsor matches 100% of the first 3% of eligible compensation contributed by the participant plus 50% of the next 2% not to exceed 5% of the participant's annual compensation. The Plan Sponsor accrued a safe harbor matching contribution of \$213,397 for the year ended December 31, 2024.
- (c) *A discretionary employer-matching contribution.* The matching contribution, if any, will be determined each year by the Company at its sole discretion. The matching contribution is equal to a uniform percentage of each tier of the employee's salary deferrals; the percentage is determined by the Company each year. There was no additional discretionary employer-matching contribution authorized for the year ended December 31, 2024.
- (d) *A discretionary non-elective profit sharing contribution.* The non-elective profit sharing contribution, if any, will be determined each year by the Company at its sole discretion. This amount will be allocated based on compensation of all participants eligible to share in the discretionary amount. To qualify, a participant must have completed at least 1,000 hours of service and be employed on the last day of the Plan Year. There was no non-elective profit sharing contribution authorized for the year ended December 31, 2024.

NOTE A - DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited or charged with the above contributions, rollover contributions, Plan earnings thereon, and an allocation of Plan expenses.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions and the employer contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, and collective investment trusts as investment options for participants.

Vesting

Participant vesting is based on service years. A year of service is defined as at least 1,000 hours worked. Participant's contributions and safe harbor matching contributions plus actual earnings are 100% vested immediately. The discretionary employer contributions vest according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 or more	100%

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,831 and \$20,589, respectively. These accounts are used to reduce future employer contributions or to pay Plan expenses. In 2024, forfeitures of \$4,313 were used to pay Plan expenses and the 2023 employer contribution was reduced by \$20,655 from forfeited non-vested accounts. The employer contribution receivable at December 31, 2024, was reduced by \$13,446 of forfeitures to be applied.

NOTE A - DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

Participants become eligible for benefit payments upon retirement, termination of employment, disability or death. Additionally, the Plan provides for in-service distributions after a participant has reached age 59½ or anytime from their rollover balance. Participants may also receive distributions for qualified financial hardships. Distributions may be made as a single lump-sum payment. All involuntary distributions greater than \$1,000 and less than \$5,000 are paid as a direct rollover to an individual retirement plan. Rollovers are not included when determining whether a cash-out distribution may be paid to a terminated participant. If a participant has terminated employment, he or she must begin receiving benefits no later than April 1 of the calendar year following the year in which he or she reaches age 72.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Unit Values

Individual participant accounts for the pooled separate accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the funds are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are allocated to the participants' accounts and are included in administrative expenses. Certain withdrawal expenses are paid for by the affected participant. Investment related expenses are included in net appreciation (depreciation) of fair value investments.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (the Custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price reported on the active market on which the individual securities are traded.

Pooled Separate Accounts - Investments represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles valued using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAVs of the underlying investments are quoted in an active market. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments. As of December 31, 2024, there were no redemption restrictions or unfunded commitments on these investments.

Collective Investment Trusts - Valued based on the NAV of units of the trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. As of December 31, 2024, the Plan's collective investment trusts have no unfunded purchase commitments and immediate redemption frequency.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INCOME TAX STATUS

The Company has adopted DATAIR Employee Benefit Systems Inc Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan which has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype Plan Document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative services are provided by the Plan Sponsor at no cost to the Plan, and certain administrative costs incurred by the Plan are paid by the Plan Sponsor.

The Plan's administrative expenses result from services rendered by parties-in-interest.

Certain investments offered by the Plan are managed by affiliates of Principal Trust Company. Principal Trust Company is the Plan custodian; therefore, these transactions qualify as party-in-interest transactions.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become one hundred percent (100%) vested in their accounts.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

Subsequent events were evaluated through September 22, 2025, which is the date the financial statements were available to be issued.
