1. DESCRIPTION OF PLAN

The following description of the Navmar Applied Sciences Corporation (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering all employees of the company who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and subject to Internal Revenue Code restriction. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Certain participants are also eligible to make “catch-up” contributions in accordance with Internal Revenue Code regulations. The Company contributes 25% of elective deferrals up to 8% of earnings. The matching Company contribution is invested pursuant to the participant direction. Additional profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant's account is credited with the contributions and allocation of Plan earnings in accordance with their investment direction. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

*Participant Loans*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by the balance in the participants’ account and bear interest at the prime rate. Principal and interest is paid ratably through payroll deductions.

*Payment of Benefits*

On termination of service due to death, disability, retirement or termination, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments in accordance with the Plan document.

*Forfeited Accounts*

At December 31, 2024 and 2023, the forfeiture account totaled \$1,365 and \$2,564, respectively. These accounts will be used to reduce future employer contributions and/or applied to reduce administrative expenses in accordance with the Plan documents. Forfeitures used by the employer to reduce the employer's contributions for the years ended December 31, 2024 and 2023 were \$18,454 and 18,548, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is required on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains on losses on investments bought and sold as well as held during the year.

*Risk and Uncertainties*

The assets of the Plan are primarily financial instruments which are monetary in nature. Investments in funds are subject to risk conditions of the individual fund objectives, stock and bond market fluctuation, interest rate changes, economic conditions and world affairs.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying financial statement of changes in net assets available for benefits. Other expenses of maintaining the Plan are paid by the company.

*Subsequent Events*

Management has evaluated events and transactions occurring subsequent to the period end for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

3. INVESTMENTS

During years ended 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the period) appreciated (depreciated) in value by \$3,227,624 and \$3,810,215, respectively.

4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 and 2 inputs were not available.

The fair value of registered investment companies and money market accounts are based on quoted net asset values of the shares held by the Plan at year-end.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The financial information included in the Plan financial statements, except for contributions receivable, contributions, and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by AdvisorTrust Inc., the Trustee, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate, amend, modify or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

7. TAX STATUS

The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of registered investment companies held by AdvisorTrust Inc. which is the custodial trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment custodial services amounted to \$17,186 and \$14,308 for the years ended 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. PLAN CHANGES AND AMENDMENTS

There were no significant Plan changes or amendments adopted during the year.
