NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Shuman Physical Therapy Assoc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Shuman Physical Therapy Associates for the benefit of the eligible employees of Shuman Physical Therapy Associates, P.C. and Iceplex Fitness, LLC (collectively, the Company). The Plan contains both 401(k) and profit-sharing provisions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is sponsored and administered by the Company. Rimkus, Marciano, and Associates, Inc. (Rimkus) is the recordkeeper and third-party administrator of the Plan. Nationwide Trust Company, FSB (Nationwide) is the custodian of the Plan's assets. Five employees of the Company serve as trustees.

Eligibility

Employees are generally eligible to participate in the Plan on the first date of the Plan year quarter after meeting the eligibility requirements: three months of employment, 250 hours of service, and the attainment of twenty-one years of age. Employees are eligible to participate in the employer safe harbor match and discretionary profit-sharing contributions on the first day of the Plan year quarter following one year of service (1,000 hours of service) and the attainment of age twenty-one.

Contributions

Participants may contribute a percentage of annual compensation, as defined in the Plan, on a pretax basis or Roth after tax basis (collectively, Elective Deferrals), not to exceed the maximum contribution limits established by the Internal Revenue Code (IRC). Participants may also rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Additionally, the plan has safe harbor contributions equal to the sum of 100% of the amount of the participant's Elective Deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's Elective Deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. The Company may also decide each Plan year to make a discretionary profit-sharing contribution on behalf of the eligible participants. The Company did not make any discretionary profit-sharing contributions in either 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and (c) an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary and safe harbor matching contributions plus actual earnings thereon. Participants vest in the Plan's discretionary profit-sharing contributions 20% after two years of service and an additional 20% each year until full vesting after six years of service.

Benefits Paid to Participants

The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for disability, death and termination benefits for those participants who are eligible to receive such benefits. Upon termination of service, participants can elect to have a qualified rollover of their vested balance or receive a lump-sum distribution, as defined in the Plan Document. The Plan also allows for certain in-service withdrawals, provided that the participant has obtained the age of 59 ½ and meets the requirements, as established within the Plan Document. The Plan provides for mandatory distribution of a participant's vested account balance following severance from employment when an account balance is less than \$5,000. The mandatory distribution is subject to automatic rollover if it exceeds \$1,000.

Forfeitures

Forfeitures of non-vested account balances are used to pay plan expenses or to reduce Company contributions. During 2024 and 2023, forfeitures used by the Plan to reduce Company contributions totaled \$538 and \$535. Amounts forfeited by participants totaled \$730 during the year ended December 31, 2024. There were no amounts forfeited by participants during the year ended December 31, 2023. Accordingly, the balance in the forfeiture account for the years ended December 31, 2024 and 2023 totaled \$455 and \$263, respectively.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable are payable over a period not to exceed 5 years, except when used to acquire a principal residence, in which case notes receivable are payable over a period set by the Plan Administrator. The notes receivable are secured by the remaining vested account balance and bear interest at 1% above the prime rate at the time of loan issuance, which remains fixed for the duration of the loan. A participant may only have one outstanding loan at any time. All outstanding loan balances will become due and payable in their entirety upon severance of employment unless directly rolled over to another employer's plan. Principal and interest are paid ratably through payroll deductions over the term of the loan.

Administrative Expense

Certain Plan expenses are paid from the Plan's assets. These expenses are assessed against an individual participant's account either proportionately based on value of account balances or as an equal dollar amount based on the number of participants in the Plan. Expenses specifically incurred by or attributable to individuals are allocated directly to participant accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investments and Income Recognition

Investments are stated at fair value, with the exception of the Plan's investment in the group annuity contract that is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used during 2024 and 2023.

4. FAIR VALUE MEASUREMENTS (Continued)

Mutual funds: Valued at the net asset value of the underlying investment held in mutual funds. The underlying net assets have observable level 1 pricing inputs, which are used to determine the unit value of the underlying investment. However, since the calculation of the unit value of the investments is based on the observable underlying investment in the mutual fund, the item is classified as level 2 in the fair value hierarchy.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GROUP FIXED ANNUITY CONTRACT

The Plan invests in a guaranteed investment contract (GIC) that is a group fixed annuity contract backed by the assets of the general account of Nationwide. This GIC is considered a fully benefit responsive investment contract and is measured, presented and disclosed at contract value. Participant transactions are executed using contract value without adjustment.

The GIC issuer guarantees to pay a specified interest rate which is reset quarterly on January 1, April 1, July 1, and October 1.

The GIC is reported at contract value as it meets the fully benefit-responsive investment contract criteria. Contract value is calculated as contributions, plus earnings, less withdrawals and administrative expenses. Participant transactions are executed at contract value less surrender charges, if applicable, which is the relevant measure for fully benefit-responsive investment contracts.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the issuer's ability to meet its financial obligation, which may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan Sponsor and/or Plan participants to transact at contract value with Nationwide. Examples of these events would include (but would not be limited to) premature termination of this contract and termination of the Plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds. The Plan administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable.

6. PARTY-IN-INTEREST TRANSACTIONS

Nationwide is the custodian of the Plan assets. As such, transactions involving Nationwide and the Plan qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

7. TAX STATUS

The Plan adopted a pre-approved plan offered by Rimkus, Marciano, & Associates, Inc. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits per the financial statements agreed to Form 5500 in total as of December 31, 2024 and 2023 and changes in net assets available for benefits per the financial statements agreed to Form 5500 for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to include any entity or business the Company acquires whether by asset or stock purchase in eligibility, contribution allocation, and vesting, but only with respect to individuals who are employees of the acquired entity at the time of acquisition.

Effective January 1, 2025, the Plan was amended to included Anne, Shuman, and Associates PT Athletic Trainer, PLLC, as a participating employer.
