### OPINION

### BASIS FOR OPINION

### RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Bright MLS, Inc. Employee Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the Bright MLS, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

**General** - A health care benefits plan and a related trust was established January 1, 2017 and did not hold any assets prior to this date. The Bright MLS, Inc. Employee Benefit Plan provides health care benefits covering substantially all active employees of Bright MLS, Inc. (the Sponsor). Certain Plan assets are held in the Bright MLS, Inc. Health Benefits Trust (the trust), a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Benefits** - The Plan provides health (medical and prescription drug) benefits to full-time employees of the Sponsor (with at least 30 hours of service each week) and eligible spouses and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Self-Insured Benefits** - The Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processor pays claims directly to the healthcare providers and are then reimbursed by either the Plan's VEBA trust or the general assets of the Sponsor. Despite the Plan's utilization of third-party claims processor, ultimate responsibility for payments to providers is retained by the Plan.

**Stop Loss Coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Sponsor pays the full cost of the stop loss insurance.

**Contributions** - Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. A terminated participant who elects to continue coverage under COBRA pays contributions to the Plan equal to 102% of the terminated participant's projected monthly Plan cost.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

**Basis Of Accounting And Use Of Estimates** - The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

NOTE B - SUMMARY OF ACCOUNTING POLICIES - CONTINUED

**Payment Of Benefits** - Premiums paid by the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

**Administrative Expenses** - The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Sponsor on behalf of the Plan.

**Cash And Cash Equivalents** - The Plan maintains its cash and trust account with one financial institution. Account balances may exceed federally insured limits insured by the Federal Deposit Insurance Corporation (FDIC). The Organization has not had any losses related to FDIC limit exposure.

**Subsequent Events** - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through September 25, 2025, the date the financial statements were available to be issued.

NOTE C - CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 - Quoted prices in markets that are not active, or inputs which are observable, either directly or indirectly, for substantially the full term of the asset or liability;
- Level 3 - Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e., supported by little or no market activity).

***Interest Bearing Cash*** - The cash account is valued at cost which equals fair value.

NOTE E - TAX STATUS

The Trust established under the Plan has qualified for tax-exempt status under provisions of Section 501(c)(9) of the Code. Under this provision of the Code, income earned by the trust is not taxable. The Plan Administrator believes that the Trust, qualifies to operate in compliance with the requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize an income tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. Management of the Plan has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities. However, currently no audits are in progress for any tax period.

NOTE F - TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE G - RELATED PARTY TRANSACTIONS

The Plan has several arrangements with third party service providers. These transactions are party-in-interest transactions under ERISA.

NOTE H - DIFFERENCES BETWEEN FINANCIAL STATEMENTS AND IRS FORM 5500

The Plan does not reflect as liabilities in the statement of net assets available for benefits the estimated liability for benefits payable including IBNR claims. The U.S. Department of Labor, however, requires that these amounts be reported as a liability on IRS Form 5500, Annual Return/Report of Employee Benefit Plan (Form 5500).
