Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Ascensus, LLC 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Ascensus, LLC 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ascensus, LLC 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: Description of the Plan

Ascensus, LLC (“Ascensus”, the “Company” or the “Employer”), a single member limited liability company formed under Delaware law is a plan sponsor for the Ascensus, LLC 401(k) Savings Plan (the “Plan”). The Company is an indirect wholly-owned subsidiary of Mercury Parent Holdings, Inc. (“Ultimate Parent”). The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on August 1, 2007. The Plan is intended to conform to and qualify under Section 401 and 501 of the Internal Revenue Code of 1986 (“IRC”), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration

The Plan’s Committee is responsible for oversight of the Plan. The Company provides recordkeeping services for the Plan. Ascensus Trust Company (the “Trustee”), an affiliated entity that is indirectly wholly-owned by the Ultimate Parent is responsible for the custody and management of the Plan’s assets. The Trustee is considered a related party to the Company.

Plan Changes

Effective August 2024, pursuant to the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, the Plan has implemented certain optional provisions which include: (i) permitting penalty-free withdrawals from the Plan for domestic abuse; (ii) allowing participants to self-certify their eligibility for hardship distributions; and (iii) increasing the dollar limit of automatic force-outs for account balances of separated participants to \$7,000 from \$5,000.

Eligibility

All eligible employees, as defined by the Plan, are eligible to join the Plan on the first of the month following or coinciding with the employee’s date of hire.

Contributions

Participants may contribute up to 50% of their annual compensation, as defined by the Plan. Roth elective deferrals are permitted. Participants who are age 50 or older can make additional contributions (catch-up contributions). The Plan includes an auto-enrollment and auto-escalation provision whereby all newly eligible participants are automatically enrolled in the Plan on the first of the month following their first month of eligibility. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their deferral rate is increased by 1% annually, up to a maximum of 8%.

Participants may also contribute amounts representing pre-tax distributions from other qualified retirement plans or individual retirement accounts (rollover contributions). Rollover contributions from other qualified plans for Roth deferrals are also permitted. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

The Company may make a discretionary match for each qualifying contributing participant. The allocation formula and the percentage of the dollar amount limit are at the discretion of the Company. For contributions that were made for the year ended December 31, 2024, the Company matched 50% of each participant’s elective deferrals, excluding catch up contributions, up to a maximum of 8%. The Company made matching contributions to the Plan totaling \$13,398,881 for the year ended December 31, 2024.

The Company may make an employer profit sharing contribution based on a discretionary formula of a flat dollar amount for each qualifying participant. Each qualifying participant must complete at least 500 hours and be an employee of the Company on the last day of the Plan year, as defined in the Plan Document. There was no profit sharing contribution for the year ended December 31, 2024.

Investment Options

Participants direct contributions into various investment options offered by the Plan. Participant investment elections can be changed daily.

Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's profit sharing contribution, if any, and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on Plan earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service, except in cases of death, disability, or separation from service due to divestiture, where participants are immediately vested in Company contributions. In all other instances, participants will become fully vested after five years of credited service, as follows:

Payment of Benefits

On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may elect to receive distributions in the form of lump sum payments of vested account balances and are recorded when paid. Individual vested account balances less than or equal to \$1,000 will be a lump sum distribution. Vested account balances between \$1,000 and \$7,000 will roll over into an individual retirement account unless otherwise instructed. In-service and hardship withdrawals are permitted, as defined in the Plan Document.

Notes Receivable from Participants

Participants may borrow from their account up to 50% of the participant's vested account balance up to a maximum amount of \$50,000. The term of notes receivable is five years (up to fifteen years if the receivable is for the purchase of a primary residence). Existing loan agreements previously rolled into the Plan from previous Plan acquisitions include certain loan terms of up to thirty years. Notes receivable are collateralized by the balance in a participant's account and bear interest at prime plus 1% at the date of origination. Principal and interest are paid ratably through automatic payroll deductions. As of December 31, 2024, participant loans had maturities through 2049 at interest rates ranging from 3.50% to 11.50%.

Forfeitures

Forfeitures are used to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested amounts held by the Plan were \$124,561 and \$85,255, respectively. During the year ended December 31, 2024, the Company used \$486,599 to reduce employer matching contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Presentation

The financial statements and accompanying notes have been prepared in accordance with accounting principles generally accepted in the United States (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 *Fair Value Measurements* for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions on the basis of the terms of the Plan.

Contributions

Contributions from Plan participants and the Company matching contributions are recorded in the year in which the participant contributions are withheld from amounts paid. Profit-sharing contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All participant and employer contributions are participant-directed.

Payment of Benefits

Benefits are recorded when paid. There were no participants, who elected to withdraw from the Plan, but had not yet been paid as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant’s account and certain recordkeeping and investment advisory fees paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

Note 3: Fair Value Measurements

The Plan measures its investments at fair value on a recurring basis in accordance with GAAP. Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that the authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value of measurement. The levels of the fair value hierarchy are as follows:

Level 1: Quoted prices (unadjusted) in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2: Significant observable inputs other than quoted prices included within Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets or liabilities, quoted market prices in inactive markets for identical or similar assets, and other observable inputs.

Level 3: Significant unobservable inputs. Examples of valuation methodologies that would result in Level 3 classification include option pricing models, discounted cash flows, and similar techniques.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in fair value methodologies used as of December 31, 2024 and 2023. There have been no changes in level classification during 2024 or 2023.

Registered investment companies: The Plan's registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trusts: The Plan invests in the Vanguard Target Retirement Trusts II ("Target Retirement Trusts"), a series of asset allocation funds following a targeted maturity approach designed for investors retiring or leaving the workforce in or within a few years of the specified date. Each trust invests in a collection of Vanguard mutual funds and collective investment trusts according to an asset allocation strategy that becomes more conservative as the target year approaches. The fair value of these investments is determined by the net asset value based on the fair value of the underlying investments held by the fund less its liabilities. The net asset value, as provided by the Trustee, is used as a practical expedient to estimate fair value.

Pooled separate account: The Plan invests in the New York Life Insurance Company Anchor Account ("NYL AA"), which is a pooled separate account issued by New York Life Insurance Company. The NYL AA has been valued at the net asset value or equivalent based on units of the pooled separate account. The net asset value, as provided by the insurance company, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported net asset value.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Investments Valued at Net Asset Value

The Target Retirement Trusts are designed for investors who are seeking a simple approach to investing for retirement. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the common collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly manner. There are no further imposed restrictions as to the redemption of these investments.

The NYL AA seeks to provide a low-risk stable investment option. Participants may ordinarily deposit and withdraw on a daily basis. No direct transfers from the NYL AA to a competing fund are allowed. The NYL AA is generally redeemable at net asset value. However, it is possible that these redemption rights may be restricted in the future in accordance with underlying agreements. Due to the nature of the investments held by the NYL AA, changes in market conditions and the economic environment may significantly impact the net asset value of the NYL AA, and consequently, the fair value of the Plan's interest in the NYL AA. Furthermore, changes in the liquidity provisions of the NYL AA may significantly impact the fair value of the Plan's interest in the NYL AA. If the Plan does not provide twelve months written notice of an intent to exit the NYL AA, the Plan's balance in the NYL AA may be subject to a market value adjustment.

Note 5: Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 6: Related Party and Exempt Party-in-Interest Transactions

The Trustee provides custodial and management services to the Plan. Refer to Note 1 *Description of Plan*. The Plan did not incur direct fees for services provided by the Trustee or the Company during the year ended December 31, 2024. The Plan issues loans to participants, which are secured by the participant's account balances. These qualify as exempt party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Employer contributions.

Note 8: Income Tax Status

Effective August 31, 2023, through the adoption of the Company's pre-approved defined contribution plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution Plan Document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9: Subsequent Events

The Company has evaluated subsequent events through September 25, 2025, the date of this report, and except as stated below the Company is not aware of any events or transactions that occurred subsequent to December 31, 2024 through September 25, 2025 that would require recognition or disclosure in the financial statements.

Effective April 1, 2025, the Plan was amended and restated to change the maximum deferral rate percentage from 50% to 75%.
