INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Meyer-Hestan 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Meyer-Hestan 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions users made based on these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of Plan

The following description of the Meyer-Hestan 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Meyer Corporation U.S. is the Plan Sponsor.

The Plan also covers employees of participating affiliates including:

- Meyer Cookware Industries, Inc.
- Meyer Commericalware, Inc.
- Cookware Concepts, Inc.
- Polymathic Properties, Inc.
- Acolyte, Ltd.
- Hestan Vineyards, LLC
- Hestan Commercial Corp.
- Hestan Smart Cooking, Inc.

General: The Plan is a defined contribution plan established on March 26, 1987, amended and restated with an effective date of July 15, 2021 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provides benefits for all eligible employees of the Plan Sponsor and participating affiliates, collectively the “Company”.

The Plan Sponsor is the Plan administrator and the trustee. The Plan Sponsor retains the services of a third party to assist in the administration of the Plan. Through December 31, 2023, the Plan’s custodian was Minnesota Life Insurance Company (“Minnesota Life”), and the Plan’s third party administrator was Securian Financials’ Participant Recordkeeping (“Securian”), the parent of Minnesota Life Insurance Company. As of May 20, 2024, the third-party administration was transferred to Standard Retirement Services, Inc. (“The Standard”). Through December 31, 2024, the Plan’s custodian was The Standard, as a result of The Standard acquiring Securian. The Plan’s third party administrator was The Standard Insurance Company, the parent of Standard Retirement Services, Inc.

Eligibility: Except for excluded employees, all employees who have reached eighteen years of age and who have completed three months of service are eligible to participate in the Plan. Eligibility requirements exclude employees who are residents of Puerto Rico, leased employees, interns, and temporary employees working less than 1,000 hours.

Newly eligible employees are automatically enrolled into the Plan at an initial deferral rate of 4% of eligible compensation into a default investment fund until changed by the participant. Participants automatically enrolled in the Plan are subject to annual scheduled deferral percentage increases of 1% on the first day of each proceeding Plan year, up to a maximum of 10% of eligible compensation. An employee may elect not to participate in the Plan.

Participant contributions: Each year, participants may elect to contribute up to 100% of their eligible compensation to the Plan, up to the maximum allowed under section 401(k) of the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions, subject to statutory limits. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the allocation of their contributions to various investment options offered by the Plan.

Employer contributions: The Company may make a safe harbor matching contribution of up to 100% of the first 4% of a participant’s deferred salary contributions. The Company may also make discretionary employer matching contributions equal to a discretionary percentage, to be determined by the Company. During the year ended December 31, 2024, the Company matched an additional 2% of a participant’s deferred salary contribution up to a maximum of 6% of total eligible compensation. For the year ended December 31, 2024, the Company made matching contributions of approximately \$1,769,000, net of forfeitures.

Participant accounts: Each participant’s account is credited with the participant’s contribution and Company contributions and allocations of Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Investments options: The Plan provides for investments to be directed by participants into a number of investment options held by the custodian. All Plan investments are units of funds managed by the custodian; therefore, these investments and all investment transactions are party-in-interest transactions. Earnings of each investment fund are allocated to participant’s accounts in proportion to each participant’s share of that fund.

Vesting: Participants are immediately vested in their contributions, including rollovers of funds from other qualified retirement plans and earnings thereon, and in safe harbor matching contributions. Participants become vested in the Company’s discretionary employer matching contributions over a four-year graded vesting schedule.

Notes receivable from participants: Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at the prime rate plus 2% for short-term loans (5 years or less) and the prime rate plus 1% for residential loans. A participant may have no more than two loans outstanding at any time, and is restricted to a lifetime maximum of four. Effective November 20, 2024, the lifetime maximum was removed and a participant may have no more than two loans outstanding at any time, provided one is for the purchase of a primary residence and one is a general loan. Principal and interest was paid ratably through payroll deductions through April 30, 2022. Effective May 1, 2022, principal and interest payments are paid ratably by participants through Automatic Clearing House (“ACH”) payments.

Payment of benefits: The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, or termination of employment. In-service distributions of participant's vested account balance are permitted providing the participant has attained the age of 65. Participants may also request financial hardship distributions, as defined by the Plan, from the participant's fully vested account balances. Upon termination, participants may elect to leave their account balance in the Plan, or receive their total benefits in a lump sum amount equal to the value of the participant's vested interest in their account. The Plan allows for automatic lump sum distributions of participant's vested interest account balances that do not exceed \$1,000.

Forfeited accounts: Forfeitures are retained in the Plan and will first be used to pay administrative expenses. Any remaining forfeitures are then used to reduce employer contributions, respectively. Forfeitures remaining in the Plan as of December 31, 2024 and 2023 were approximately \$12,000 and \$8,000, respectively. For the years ended December 31, 2024 and 2023, approximately \$1,000 and \$15,000 of forfeitures were used to reduce employer contributions, respectively. For the years ended December 31, 2024 and 2023, approximately \$8,000 and \$7,000 of forfeitures were used to pay administrative expenses, respectively.

Administrative expense: Substantially all administrative expenses of the Plan are paid by the Plan. Separate fees for loan processing and certain investments as specified in the service agreement, are charged to individual participant's accounts.

Note 2: Significant accounting policies

Basis of accounting: The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted ("GAAP") in the United States of America. Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at their fair value, including the guaranteed investment contract, based on the quoted market prices of the underlying securities within each fund. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The custodian has concluded that the guaranteed investment contract is not fully-benefit responsive and therefore should be reported at fair value. Additionally, the custodian has determined the fair value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net appreciation (depreciation) in fair value of investments: The earnings, expenses, realized gains and losses, and unrealized appreciation (depreciation) in pooled separate accounts and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Fair value measurements: The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

Subsequent events: The Plan has evaluated subsequent events through the date that the financial statements were made available to be issued which is the date of the independent auditors' report.

Note 3: Fair value

The Plan performs fair value measurement in accordance with ASC 820. ASC 820 defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities that the entity has the ability to access;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Investment contract with insurance company

In 2006, the Plan entered into a non-benefit-responsive investment contract with Minnesota Life. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, the guaranteed investment contract is not fully benefit-responsive, and is therefore reported at fair value. Fair value as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Transfers, at the Plan level are restricted in any 12 month period from movements out of the guaranteed investment contract of the greater of \$2,000 or 20% of the guaranteed investment contract assets.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate was approximately 0% for 2024.

Note 6: Party-in-interest transactions

At December 31, 2024 and 2023, the Plan held for investment approximately \$75,099,000 and \$64,846,000, respectively, in The Standard funds. The Standard is the Plan's investment broker and has custodial responsibility for investments held in The Standard's investment accounts.

Note 7: Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer matching account balances.

Note 8: Income tax status

The prototype plan adopted by the Plan Sponsor obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not received a separate opinion letter however the Plan administrator believes that the prototype plan, as adopted by the sponsor, is operating in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and uncertainties

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.
