We have performed audits of the financial statements of Omaha Truck Center, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Plan Description

---

The following brief description of the Omaha Truck Center, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Omaha Truck Center, Inc. (the Company).

The Plan is administered by the Company and included a participating plan agreement for SelecTrucks of Omaha, LLC. Effective May 1, 2024, SelecTrucks of Omaha, LLC is no longer a participating employer.

Employees are eligible to contribute to the Plan and eligible to receive employer discretionary matching and discretionary profit-sharing contributions upon completing six months of service. Employees are eligible to enter the Plan on the first day of the quarter, coinciding with or following the date eligibility requirements are met.

In order to receive employer discretionary profit-sharing contributions, participants must be employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year.

#### **Contributions**

Participants may make voluntary pre-tax and Roth after-tax contributions up to the maximum amount allowed by law. Participants may also contribute amounts representing distributions from other qualified plans. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions.

All employees with a hire date on or after July 1, 2020 are automatically enrolled with a 4% deferral contribution once they become eligible for the Plan (3% prior to July 1, 2024). All employees with a hire date prior to July 1, 2020 were automatically enrolled with a 2% deferral contribution once they became eligible for the Plan. Participants may elect not to contribute, may increase or decrease their deferral rate quarterly, or may elect out of the automatic deferral.

The Company may elect to make discretionary matching and discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions contributed to the Plan during 2024 and 2023.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's discretionary matching and discretionary profit-sharing contributions, b) Plan earnings and losses and c) an allocation of administrative expenses paid by the Plan. The Company's discretionary matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated based on the eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts maintained by John Hancock Trust Company LLC (John Hancock).

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's contributions credited to participant's accounts are vested based on years of service. A participant is 25% vested after one year of credited service and vesting increases 25% per year until a participant is 100% vested after four years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at 2% over the prime interest rate. Principal and interest payments must be repaid through payroll deductions, ACH, or check.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump sum, installment payments, or partial withdrawals equal to the value of the vested funds allocated to the participant's account. Distribution payments under \$7,000 (\$5,000 prior to January 1, 2024) are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may receive in-service and hardship distributions, as permitted in the Plan document. Benefit payments are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Company's discretionary matching and profit-sharing contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce Plan administrative expenses or employer contributions. During 2024 and 2023, \$156,996 and \$0 of forfeitures were used to reduce employer contributions, respectively. As of December 31, 2024 and 2023, forfeited, non-vested amounts totaled \$25,565 and \$124,478, respectively.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

**Other**

Certain administrative expenses and audit fees are paid by the Company and are excluded from these financial statements. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 23, 2025, noting no items requiring disclosure.

### 3. Information Certified by John Hancock

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at fair value as determined by quoted market prices in active markets, which represents the net asset value (NAV) of shares held by the Plan at year end.

*Common Collective Trust:* Valued at the NAV based on the market value of its underlying investments, FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that this fund meets those requirements. Were the Plan to initiate a full redemption of the applicable collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Participants can redeem the trust at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

### 7. Related-Party Transactions

---

Certain plan investments are shares of mutual funds and a common collective trust managed by John Hancock. John Hancock is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.
