## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the  
K&L Gates Partner Cash Balance Pension Plan Beta

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the K&L Gates Partner Cash Balance Pension Plan Beta (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Plan administration, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Plan administration has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Plan administration determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Plan Administration for the Financial Statements**

Plan administration is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan administration's election of the ERISA Section 103(a)(3)(C) audit does not affect their responsibility for the financial statements.

In preparing the financial statements, Plan administration is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan administration is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the K&L Gates Partner Cash Balance Pension Plan Beta (Plan) provides only general information. Participants should refer to the individual Summary Plan Description or Plan Document for a complete description of the Plan's provisions.

General - The Plan is sponsored by K&L Gates LLP, a Delaware limited liability partnership (Firm). The Firm's Benefits and Investment Committee (Committee) is the named fiduciary with respect to the administration of the Plan. The Bank of New York Mellon, N.A. (BNY Mellon) serves as trustee of the Plan and has the overall responsibility for the custody and safekeeping of the assets of the Plan that it holds. Payden & Rygel provides investment advisory services. October Three Consulting, LLC (October Three) provides actuarial services.

The Plan is a noncontributory, nonparticipant-directed defined benefit cash balance pension plan that provides for retirement and death benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility and Vesting - Each Partner, Chief or Senior Advisor to the Management Committee (Partner or Chief) who was active on the adoption date of October 25, 2014 became a participant in the Plan. Any lateral Partner or Chief and any progression Partner or Chief who was not a Partner or Chief on the adoption date is eligible once he or she completes two years of service. Participants are eligible for contributions if they are active on December 31 of the Plan year. Each participant is 100% vested in his or her account.

Benefits - A cash balance account exists for each participant. Participant accounts are credited with Cash Balance Credits and Interest Credits.

A Cash Balance Credit is credited each Plan year to the account of each participant who is eligible under Plan rules. A Cash Balance Credit is equal to the Formula Credit Amount, limited to the Maximum Credit Amount. A Formula Credit Amount is equal to the applicable dollar amount set forth in the Plan Matrix. Certain progression Partners and Chiefs, as defined within the Plan Document, participate on a phased-in schedule. Effective January 1, 2024, all eligible participants may express a preference of a Formula Credit amount for a flat \$2,500 or for a Group Matrix percentage ranging from 25% to 150%. Prior to the amendment, this preference was only available to participants that participated in the Plan as of December 31, 2014. All other participants expressed a Group Matrix percentage of 100%.

An Interest Credit is equal to the market rate of return on the investment in which the trust assets are invested. The Interest Credit amount is limited to the lesser of 5% or the cumulative rate of interest on 30-year treasury securities as published by the Secretary of Treasury of the United States for the month of November of the Plan year, which was 4.36% and 4.54%, for 2024 and 2023, respectively.

The participant account balance is available for distribution to the participant or the participant's beneficiaries, in either a lump sum or an annuity, upon the occurrence of any of the following events: attainment of age 59½, separation from service, death or termination of the Plan. At the time of distribution, the balance of the participant's account cannot be less than the accumulated Cash Balance Credits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statements of changes in net assets available for benefits and related notes to the financial statements (financial statements) follows:

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 6 for discussion of fair value measurement.)

**Purchases and sales of securities** are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefit payments are recorded when paid.

**Expenses** - The Plan's expenses are paid either by the Plan or the Firm, as provided by the Plan Document. Expenses that are paid directly by the Firm are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events** - The Plan administrator has evaluated subsequent events through September 18, 2025, the date that the financial statements were available to be issued.

NOTE 3 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, payable to the Plan's participants, and include benefits expected to be paid to present and retired Partners and Chiefs or their beneficiaries.

The actuarial present value of accumulated plan benefits is determined by an independent actuary, October Three, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The valuation dates are as of January 1, 2025 and 2024 as opposed to December 31, 2024 and 2023. However, no material adjustment would occur if the valuation date were as of December 31, 2024 and 2023.

NOTE 4 - FUNDING POLICY

The Firm contributes such amounts as are necessary on an actuarial basis to provide the Plan with sufficient assets to pay Plan benefits. For the years ended December 31, 2024 and 2023, the minimum funding requirements of ERISA, as actuarially determined, were met.

Although it has not expressed any intention to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 5 - PLAN TERMINATION

In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations. Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan sponsor and level of benefits guaranteed by the PBGC.

NOTE 6 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6 - FAIR VALUE MEASUREMENT (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds - Valued based on the actual observable value of the underlying money market funds and priced daily at its closing price.

NOTE 7 - TAX STATUS

On July 9, 2020, the Plan received a favorable determination letter from the Internal Revenue Service (IRS) stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and the related trust is exempt from taxation under Section 501(a). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified. The related trust is tax-exempt.

NOTE 7 - TAX STATUS (Continued)

U.S. GAAP requires Plan administration to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan administration has determined that there are no uncertain tax positions at December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. Should the Plan incur penalties and interest related to unrecognized tax benefits, such amounts would be recorded in administrative expenses. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits is reported, based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 9 - CERTIFIED INVESTMENTS (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by Plan administration and agreed to or derived from information certified as complete and accurate by BNY Mellon, the trustee of the Plan.

NOTE 10 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are invested in funds managed by BNY Mellon and Payden & Rygel. BNY Mellon is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Payden & Rygel provides investment advisory services to the Plan. Certain administrative functions are performed by employees or Partners of the Firm at no cost to the Plan.

For 2024, the maximum compensation limit under IRC section 401(a)(17) is \$345,000, and the maximum benefit payable under IRC section 415(b) is \$275,000.
