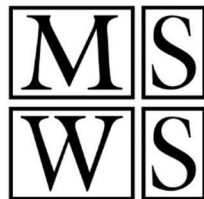

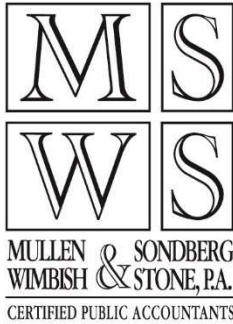

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 401(k) Profit-Sharing Plan for Employees of Compass, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the 401(k) Profit-Sharing Plan for Employees of Compass, Inc. (the Employer) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The 401(k) Profit-Sharing Plan for Employees of Compass, Inc. (the Plan) was established January 1, 2009 and amended thereafter (formerly SecureCare Services, LTD 401(k) Plan). The Plan is a defined contribution plan covering all employees of the Organization. Per Plan provisions, employees must be eighteen or older and have completed 90 days of service for Employer matching contributions. There are no service requirements for participant deferrals. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan includes an automatic contribution arrangement whereby all employees who became participants on or after November 1, 2024 shall be deemed to have directed the Employer to make salary reduction contributions on their behalf on 1% of compensation. Participants may also elect to opt-out of participation in the Plan. Participants may elect to defer any portion of their salary into the Plan. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. Each year, the Employer makes a non-discretionary matching contribution. The matching contribution was three percent of the eligible participants' salary for the year ended December 31, 2023 and the first ten months of 2024. Effective November 1, 2024, the matching contribution increased to five percent. Total contributions made by the Organization for the years ended December 31, 2024 and 2023 amounted to \$477,480 and \$304,254, respectively. Additionally, the Plan permits the Employer to make discretionary base contributions; however, no such contributions were made during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with (a) the participant's salary deferrals, (b) the Organization's match of salary deferrals, (c) an allocation of the Organization's contribution, (d) an allocation of Plan earnings, and (e) an allocation of forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan (Cont.)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contributions portion of their accounts is based on years of continuous vesting service. A participant is 100% vested after five years of credited service. Every year of vesting service with the Organization increases the participant's vesting percentage by 20% until fully vested. On termination of employment due to death or disability (approved by Social Security), a participant becomes fully vested in their account.

Notes Receivable from Participants

The Plan allows loans of up to 50% of vested account balance or \$50,000, whichever is less. The minimum loan amount is \$1,000. Interest rates are to be determined at the time of the loan and the loan is to be repaid within a 5 year period. These loans are secured by the vested portion of the participants account and bear interest ranging from 4.25% to 9.50% for the years ended December 31, 2024 and 2023.

Payment of Benefits

Upon severance of employment or after attainment of age 59 1/2, a participant may elect to receive either a lump sum distribution amount equal to the value of the participant's vested interest in his or her account, or annual installments that do not exceed the life expectancy of the participant or beneficiary. Eligible distributions may also be rolled over to another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Forfeited Accounts

For the years ended December 31, 2024 and 2023, employer contributions and Plan fees were reduced from forfeited non-vested accounts in the amount of \$5,442 and \$7,989, respectively. The amounts available to reduce future employer contributions and plan fees as of December 31, 2024 and 2023 were \$-0-.

Administrative Expenses

The administrative expenses related to the Plan's custodian are paid by the Plan. The Organization pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the guaranteed investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value provides a good approximation of fair value of the contracts held in the stable value fund because the value of the investment contracts are deemed to be no less than the accumulated balance, and that each investment purchase is made at fair value since these purchases are not distressed and are conducted between willing buyers and sellers in open market conditions with a variety of investment choices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. The Plan administrator has determined all notes receivable are fully collectible from the participants' vested account balances; consequently, no amounts have been recorded as an allowance.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. The employer-matching contributions and the employer discretionary contributions are recorded in the year in which the employer designated the contributions. All participant and employer contributions are participant-directed. Management of the Plan evaluates employer contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023, there were no contributions receivable and therefore, no allowance for credit loss has been established.

Payment of Benefits

Benefits are recorded when paid. Benefits paid, including deemed distributions of participant loans, to participants amounted to \$422,017 and \$243,703 for the years ended December 31, 2024 and 2023, respectively.

Note 3 - Data Obtained and Certified from the Custodian

Investment Data

Mutual of America Life Insurance Company is the Custodian of the Plan for the years ended December 31, 2024 and 2023. All data contained in the statements of net assets available for benefits, statements of changes in net assets available for benefits, and the Schedule H, Line 4i – Schedule of assets (held at end of year) for the year ended December 31, 2024 was summarized from information supplied and certified as complete and accurate by the Custodian of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, Line 4i – Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Investment Contract with Insurance Company Measured at Contract Value

On December 1, 2017, the Plan entered into a fully benefit-responsive investment contract with Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account. The amount is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Mutual of American Life Insurance Company. The contract value of the fully benefit-responsive investment contract with Mutual of America at December 31, 2024 and 2023 was \$1,642,889 and \$1,359,064, respectively.

The guaranteed investment contract is fully benefit-responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Mutual of America Life Insurance Company, which approximates fair value, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value or credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Under the terms of the contract, the guaranteed minimum rate is 1.00%.

The value shown, is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value of a withdrawal request.

Note 5 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Fair Value Measurements (Cont.)

ASC 820-10 "Fair Value Measurements" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics and other factors. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. However, the determination of what constitutes "observable" requires significant judgment by the Plan. The Plan considers observable data to be market data, which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary and provided by independent sources that are actively involved in the relevant market. The categorization of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to the Plan's perceived risk of that instrument.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Note 5 - Fair Value Measurements (Cont.)

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

Pooled separate accounts: Valued at the net asset value of the pooled separate accounts, as reported by the Custodian and calculated in a manner consistent with Generally Accepted Accounting Principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by variable annuity contracts. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy. The total fair value of the Plan's pooled separate accounts as of December 31, 2024 and 2023 was \$6,450,871 and \$4,758,700, respectively.

Note 6 - Tax Status

Effective December 1, 2017, the Plan adopted a standardized form of prototype plan. The prototype plan obtained its latest opinion letter on June 30, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letters have been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note 6 - Tax Status (Cont.)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 9 - Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the Custodian as defined in the Plan, and, therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$2,723 and \$2,608, respectively.

Note 10 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

Note 11 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. There have been no subsequent events through August 5, 2025, the date the Plan's financial statements were available to be issued that require recognition or disclosure.
