As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Voice Media Group Retirement Savings Plan (“the Plan”) provides only general information. The Plan was amended and restated provisions of the Plan became effective on December 15, 2022. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company, who are at least 21 years of age and have completed three (3) months of service. Participants are eligible for matching contributions after completing 3 months of service and attaining age 21 and nonelective contributions after completing one year of service and attaining age 21. A year of service consists of working a 12-consecutive month period and accreditation of at least 1,000 hours of service. After meeting eligibility requirements, the individual may participate beginning the first day of the month following eligibility, as defined in the Plan agreement.

Contributions

Eligible employees may withhold 1% to 100% of their compensation (Elective Deferrals), but not to exceed the dollar limitations established under the Internal Revenue Code, to deposit in the Plan Trust Fund, as defined in the Plan documents. The Plan calls for automatic enrollment with 4% of pay deferral for all employees as of the date the employee entered the Plan, unless the employee elects a different amount or elects not to participate.

Beginning January 1, 2022, the Company elected to make a discretionary matching contribution to the Plan. The matching contribution formula in effect during the year ended December 31, 2024 was 50% up to the first 6% of employee deferrals. Employer matching contributions to the Plan for the years ending December 31, 2024 and 2023 totaled \$542,658 and \$518,507, respectively. The Company may also make discretionary nonelective contributions to the Plan. There have been no discretionary nonelective contributions into the plan for the years ending December 31, 2024 and 2023.

Participant Accounts

Each participant account is credited with the participant's elected compensation deferral and an allocation of (a) the employer's contribution and (b) plan earnings. In addition, the participant's account is charged with an allocation of the Plan's administrative expenses. These allocations are based on participant's earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Investment Options

Upon election of compensation deferral, the participant directs the deferred amount to be invested based on percentages into investments options sponsored by Empower. The participants direct their contributions to a variety of mutual funds offered by Empower. These funds offer a range of cash, corporate debt and equity funds. The participants can change their allocations and transfer between funds by telephone, the Internet or by written request at any time.

Vesting

Participants are immediately vested in their elective deferrals. Participants become fully vested in the discretionary profit sharing and the account attributable to matching contributions after three years of employment.

Participant Loans

The Plan document allows participants to borrow money from the Plan by taking up to one loan. Participants are allowed to borrow up to 50% of their vested balance, not to exceed \$50,000. Loans are amortized over a maximum of five years, unless the purpose of the loan is for the purchase of the principal residence of the participant, in which case the maximum period may be 10 years. Repayment is made through payroll deductions with equal installments made each pay period. The loans are secured by the remaining balance in the participant's account and bear interest at the prime rate plus 1%.

Payment of Benefits

Generally, upon termination of service, a participant may receive their accrued benefit as a lump sum distribution or by making regular withdrawals annually (in approximately equal amounts) based on life expectancy tables or until the participant reaches the normal retirement age of 65 or may take early retirement at 55; however, the participant must cease employment to receive this benefit. If the vested account balance at the time of termination exceeds \$5,000, the individual may defer payment of benefits until April 1 of the calendar year following the calendar year the participant reaches age 72. Other withdrawals may be subject to a penalty tax.

Forfeitures

Forfeitures will occur if the participant leaves the Plan before they are fully vested in the discretionary profit sharing plan. These forfeitures may be used by the Plan for several purposes such as the payment of Plan expenses or to reduce any employer contributions. Forfeitures available at December 31, 2024 and 2023 were \$38,221 and \$52,724, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The process of preparing financial statements in conformity with U.S. generally accepted accounting principles ("U.S. GAAP") requires the use of estimates regarding certain types of assets, liabilities, revenues, and expenses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Investments Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Fair Value Measurements (continued)

The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means.
	If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation technique maximizes the use of relevant observable inputs and minimize the use of unobservable inputs.

Reclassifications

Certain accounts in the prior-year statements may have been reclassified for comparative purposes to conform to the presentation in the current-year financial statements.

Subsequent Events

Subsequent events have been evaluated through September 22, 2025, the date the financial statements were available to be issued.

NOTE 3 - RELATED PARTY TRANSACTIONS AND PARTIES IN INTEREST TRANSACTIONS

Plan investments include investments managed by Empower Trust Company, LLC, the trustee, and Empower Retirement, LLC, the record keeper, as defined by the Plan, and therefore those transactions are considered as party-in-interest transactions.

NOTE 4 - INVESTMENTS - INFORMATION CERTIFIED BY CUSTODIAN

Investments, income and net appreciation in fair value of investments included in the accompanying financial statements and supplemental schedule have been certified by Empower Trust Company, LLC, the Plan's trustee, to the Plan administrator as being complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 - TERMINATION OF PLAN AND RELATED TRUST

Although it has not expressed any interest to do so, the Plan Sponsor has the right under the Plan to terminate or partially terminate the Plan and related trust, subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination or partial termination of the Plan and related trust, or upon complete discontinuance of contributions to the related trust, the amount of each participant's or beneficiary's account as of the date of such termination or complete discontinuance of contributions shall be fully vested and non-forfeitable, and shall be paid to the participant, or beneficiary by the Trustee in accordance with the provisions of the Plan.

NOTE 6 – INVESTMENT FAIR VALUE MEASUREMENT

The following is a description of the valuation methods used for assets measured at fair value:

Mutual funds with registered investment company: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Self-directed brokerage account: Valued using pricing models maximizing the use of observable inputs for a group of similar securities and equities.

NOTE 7 - ADMINISTRATIVE EXPENSES

The Plan’s sponsor absorbs certain administrative expenses including a portion of the audit fees. Administrative expenses required to be paid by the Plan impact participant fund balance earnings. Administrative expenses paid by the Plan were \$93,740 and \$66,521 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 - INCOME TAX STATUS

The IRS has determined and informed the Plan by a letter dated November 14, 2022, that the Plan and related trusts are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 - INCOME TAX STATUS (continued)

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
