### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of the Peco Foods, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

**Notes to Financial Statements****December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the Peco Foods, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan of Peco Foods, Inc. and Affiliates (the “Employer”) and covers substantially all full-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – All employees, who have attained the age of 18 and have been employed for at least 90 days, are eligible to participate in the Plan. Entry dates are January 1, April 1, July 1, and October 1.
- c. **Contributions** – Each year, participants may contribute a minimum of 2% of pretax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (“IRC”). Participants may designate all or a portion of their contributions as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The automatic deferral percentage for new participants is six percent (6%) of compensation. A participant may elect not to participate or to defer a different percentage of their compensation. Employee deferrals will automatically increase by one percent (1%) each April 1, up to a maximum of ten percent (10%). The Employer may make discretionary matching contributions to the Plan. For the years ended December 31, 2024 and 2023, the Employer elected to make a discretionary matching contribution in an amount equal to 50% of participant deferrals up to 5% of eligible compensation. The Employer may also make additional discretionary contributions. The Employer did not make additional discretionary contributions during 2024 or 2023.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – A participant is always fully vested in their own contributions, plus earnings/losses thereon. All benefits attributable to a participant shall be fully vested if their employment is terminated as a result of death, disability, or reaching retirement age. If a participant terminates employment for any reason other than those mentioned above, they are entitled to the total value of their own contributions, plus any earnings/losses thereon, plus a vested percentage of the contributions, plus earnings/losses thereon, made by the Employer.

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct their account to any of the investment options offered under the Plan. Participants may change their investment selections at any time.
- g. **Forfeitures** – The portion of a participant’s account to which they are not entitled upon the termination of participation is deemed a forfeiture. Forfeitures may be used to pay Plan administrative expenses or may be used to offset the first Employer matching contribution made after the forfeiture is determined. For the years ended December 31, 2024 and 2023, approximately \$16,000 and \$27,000, respectively, in forfeitures were utilized to pay administrative expenses. For the years ended December 31, 2024 and 2023, approximately \$1,085,000 and \$940,200, respectively, in forfeitures were utilized to offset Employer matching contributions. Forfeitures available for future use totaled approximately \$8,400 and \$39,700 as of December 31, 2024 and 2023, respectively.
- h. **Notes receivable from participants** – Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000; or 50% of the participant’s account balance. Note terms range from one to five years with extended terms for the purchase of a primary residence. The notes are secured by the participant’s account with an interest rate at Prime, which is commensurate with local prevailing borrowing rates. Principal and interest are paid at least quarterly through payroll deductions.
- i. **Payment of benefits** – Upon termination of service with the Employer, a participant may choose to receive their distribution in either a lump sum payment, periodic installments, or in an annuity. If a terminated participant’s account balance is equal to or less than \$7,000, the account balance will be automatically distributed. In addition, in-service withdrawals are available to participants meeting certain hardship requirements or who have attained age 59½.
- j. **Corrective distributions** – The Plan failed the actual deferral percentage and actual contribution percentage tests for the years ended December 31, 2024 and 2023. Corrective distributions in the amount of \$83,953 and \$104,647 are recorded as a liability on the accompanying statement of net assets available for benefits and as a reduction of participant contributions on the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. These corrective distributions were refunded to the applicable participants in March 2025 and March 2024, respectively.

**Notes to Financial Statements****December 31, 2024 and 2023****1. Summary of Significant Plan Provisions (cont.)**

- k. **Termination of the Plan** – Although it has not expressed any intention to do so, the Employer reserves the right to reduce or discontinue contributions to the Plan or to terminate the Plan. In the event of termination of the Plan, each participant will have a 100% nonforfeitable interest in their individual account.

**2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value as disclosed in Note 3. See Note 5 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Administrative expenses paid by the Plan are allocated to participant’s accounts. Fees related to loans and distributions are charged directly to the participants’ account.

**3. Fully Benefit-Responsive Investment Contract**

The Plan has entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Principal Life Insurance Company (“PLIC”). PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. PLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

### Notes to Financial Statements

#### 3. Fully Benefit-Responsive Investment Contract (cont.)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by PLIC, represent contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of PLIC or otherwise. The crediting rate for the fund is based on all guaranteed rates in the GIC for which the guaranteed period has not expired on the date the crediting rate is being established. The crediting rate is guaranteed to not be less than zero. Every six months, PLIC establishes a new guaranteed rate. The guaranteed rate is determined based on several factors including expected cash flow and market rates.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include any Employer originated transfer or distribution out of the contract. Plan management does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. Any Employer originated transfer or distribution, including termination of the contract, will be subject to either 12 months advance notice or a 5% surrender charge.

#### 4. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Principal Trust Company ("PTC"), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing such information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits totaling \$120,936,631 and \$106,330,355 as of December 31, 2024 and 2023, respectively.
- b. Notes receivable from participants as shown on the accompanying statement of net assets available for benefits of \$8,430,108 and \$7,248,911 as of December 31, 2024 and 2023, respectively.

- e. All investment transactions that occurred during the years ended December 31, 2024 and 2023.
- f. All the information included in the supplemental schedule.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Pooled separate accounts:* These investments are valued based on the net asset value ("NAV") of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

*Mutual funds:* These investments are valued at quoted market prices on the last business day of the Plan year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Tax Status

The Plan is utilizing a prototype plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan Document is designed in accordance with the applicable sections of the IRC. As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Parties-in-Interest Transactions

PLIC is the third-party administrator of the Plan. The Plan is invested in a GIC and pooled separate accounts with PLIC. Principal Financial Group (“PFG”) owns the entity that is the trustee of these funds. PTC holds the Plan’s investment assets and executes investment transactions. The Plan pays PLIC for its services. PLIC, PFG, and PTC are affiliated through common ownership. Inasmuch as PTC serves as trustee and PLIC as third-party administrator, they are by definition parties-in-interest and, as a result, all investment transactions pertaining to the investments with PLIC, PFG, and PTC were with a party-in-interest. Merrill Lynch, Pierce, Fenner & Smith Incorporated (“Merrill Lynch”) serves as consultant to the Plan. The Plan pays Merrill Lynch for its services. Inasmuch as Merrill Lynch serves as consultant, it is by definition a party-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.
