### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Wepfer Marine Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 - Description of Plan

The following description of Wepfer Marine Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution 401(k) retirement plan available to all employees of Wepfer Marine, Inc., Wepfer Marine of Greenville, LLC, Wepfer Marine of Calvert City, LLC, Okie Moore Diving and Marine Salvage, LLC and Wepfer Marine of Caruthersville, LLC, (collectively, the "Company") upon date of hire, with the exception of employees who are solely classified as trip pilots, as defined by the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to defer any percentage of their annual eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants who have reached the age of fifty (50) before the end of the plan year are eligible to make catch-up contributions. The Company may make discretionary matching contributions to the Plan in amounts determined by management. The Company made matching contributions equal to fifty percent (50%) of the first \$6,000 of eligible compensation that a participant contributed to the Plan during 2024 and 2023. The Plan also allows the Company to make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made for 2024 or 2023.

#### Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options offered by John Hancock Life Insurance Company, which includes a selection of pooled separate accounts and guaranteed interest accounts.

#### Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Company's discretionary matching contributions, an allocation of the Company's discretionary profit sharing contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested, and charged with an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 - Description of Plan (continued)

#### Vesting

Participants are immediately vested in their deferral contributions, plus earnings or losses thereon. Participants vest in the Company's discretionary matching and profit sharing contributions, if any, and related earnings or losses based upon years of service, with 100% vesting occurring after six years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Payment of benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive account distributions either in the form of a lump sum payment or installments over a period of time as defined in the plan document. For terminations due to other reasons, a participant may request the value of the vested interest in his or her account as a lump sum distribution. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59½.

#### Forfeited accounts

If an employee terminates before his or her matching and profit sharing contribution accounts have become fully vested, such portions of the accounts are forfeited. Participant forfeitures are used first to pay plan expenses. Any remaining forfeitures may be used to reduce Company contributions.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

### Note 2 - Summary of significant accounting policies (continued)

#### Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the Company's matching contributions are recorded in the year in which employee contributions are withheld from compensation.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to recordkeeping and administration of participant accounts are charged to participant accounts and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

### Note 3 - Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the custodian for the Plan, has certified the following data included in the accompanying financial statements and the schedule of assets (held at end of year) is complete and accurate:

- Investments at fair value
- Net appreciation in fair value of investments
- Interest income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the schedule of assets (held at end of year).

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820 *Fair Value Measurement* are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units of the separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that security liquidations will be carried out in an orderly business manner.

*Guaranteed interest accounts:* Valued at fair value by John Hancock Life Insurance Company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The guaranteed interest accounts promise contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to maturity. Therefore, the guaranteed interest accounts are not considered benefit-responsive and are valued at estimated fair value.

The fair value of investments in the pooled separate accounts has been estimated using the NAV of the investments. The pooled separate accounts are redeemed on a daily basis and do not have any redemption restrictions, other than disclosed above. Additionally, there are no unfunded commitments.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments include interests in certain pooled separate accounts and guaranteed interest accounts managed by the custodian. John Hancock Life Insurance Company is the custodian for the Plan and provides the Plan with certain recordkeeping and administrative services. These services provided and the investments and related investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in the net appreciation of investments as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to parties-in-interest of \$33,335 and \$23,475 in 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan's operations.

### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions.

### Note 7 - Tax status

The IRS has determined that the volume submitter 401(k) profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the custodian of such in a letter dated June 30, 2020. The trustees have adopted the prototype plan and believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8 - Risks, uncertainties and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024, approximately 29% and 16% of the Plan's total investments were invested in the American Balanced Fund and John Hancock Money Market Fund, respectively.

As of December 31, 2023, approximately 32% of the Plan's total investments were invested in the American Balanced Fund.

### Note 9 - Subsequent events

Plan management has evaluated subsequent events through August 26, 2025, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure.
