Opinion

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Greene Light Holding Company Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, which was effective on January 1, 2021, is a leveraged employee stock ownership plan, which is designed to provide eligible employees the opportunity to participate in ownership of their employer. Greene Light Holding Company ("Greene Light" or the "Sponsor") is the Sponsor of the Plan. The Plan is intended to satisfy the requirements of an Employee Stock Ownership Plan, as defined under Section 4975(e)(7) of the Internal Revenue Code ("IRC"), and as a stock bonus plan under Section 401(a) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan purchased Sponsor common shares using proceeds from borrowings from the Sponsor (Note 5) and holds the stock in a trust established under the Plan. As the Plan makes each loan payment, an appropriate percentage of stock is allocated to eligible employee's accounts at fair value in accordance with applicable regulations under the IRC.

The borrowings are collateralized by the unallocated shares of stock and are guaranteed by the Sponsor. The lender has no rights against shares once they are allocated under the Plan. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to: (a) the accounts of participants with vested rights in allocated stock ("allocated") and (b) stock not yet allocated to participants ("unallocated").

Plan Administration

Greene Light's Board of Directors serves as fiduciary of the Plan and has the responsibility to appoint, monitor, and oversee the Plan Trustee. An independent third party, Mark Mills of The MGM Group, Inc, serves as Trustee and Custodian of the Plan's assets. The Trustee oversees the valuation process and the accounting of the Plan's transactions pertaining to the accounts of participants with vested rights in allocated and unallocated stock. Principal Life Insurance Company is the recordkeeper of the Plan.

Eligibility

Substantially all employees of the Sponsor and its participating subsidiaries are eligible to participate in the Plan upon attaining the age of 21 and completing one year of employment. An employee who is eligible becomes a participant on the first day of the plan year immediately preceding attainment of the above requirements.

Note 1: Description of Plan (Continued)

Contributions

The Sponsor is obligated to make contributions in cash to the Plan equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. The payment of debt releases a pro rata number of shares based on the interest and principal paid in the current year as a percentage of total required interest and principal payments during the entire term of the loan. The Sponsor remits contributions to the Plan annually.

Participants eligible to receive an allocation of the Sponsor's common stock and, if applicable, discretionary cash or stock contributions for any Plan year shall include only those participants who are eligible employees on the last day of the Plan year and have completed 1,000 hours of service during the Plan year.

The Sponsor is allowed to make additional discretionary contributions to the Plan in cash or Greene Light common stock. A discretionary cash contribution of \$33,215 was made during 2024.

Participant contributions are not permitted.

Participant Accounts

Each participant's employee stock ownership account is credited as of the last day of each plan year with an allocation of shares of the Plan's common stock released by the Trustee from the unallocated account, forfeitures, plan earnings or losses, and the Plan's discretionary cash contributions, if any. Allocations are based on a uniform percentage of allowable compensation. The benefit to which a participant is entitled is the participant's vested account balance.

Vesting

Vesting in the Greene Light common stock is based on the number of years of credited service. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during a calendar year. Participants vest at a rate of 20% each year beginning with the first year of credited service and become fully vested after five years of credited service. Participants were credited with one year of service for every ten continuous years of service prior to January 1, 2021.

If participants terminate due to normal retirement, death, or disability, as defined by the Plan, they become 100% vested in their entire balance as of their termination date.

Payment of Benefits

Plan benefits are available at normal retirement (age 65); disability retirement, death, or termination of employment. Benefits are paid in annual installments generally over a period not to exceed five years, a single lump sum of cash, or Sponsor common stock that must be immediately sold back to the Sponsor for cash.

Payment of Benefits (Continued)

Distributions of participant accounts will be made in substantially equal periodic payments over a period of five years in an annual amount equal to the value of the participant's account divided by the remaining number of annual installments to be paid; provided that, in the case of a participant with an accounting having a fair market value in excess of \$1,165,000, distribution of the participant's account will be made in annual installments over five years plus one additional year (but not more than five additional years) for each \$230,000 or fraction thereof by which such account balance exceeds \$1,165,000.

Administrative Expenses

Administrative expenses of the Plan are generally paid by the Sponsor.

Voting Rights

The Sponsor common stock held in the Plan will be voted by the Trustee. However, participants are entitled to direct the Trustee on how to vote the shares of Sponsor common stock allocated to their account with respect to approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all of the assets of a trade or business. If a participant does not notify the Trustee of how they would like their shares of Sponsor common stock to be voted with respect to any of the transactions described above, those shares will be voted at the discretion of the Trustee.

Plan Termination

The Sponsor reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participants or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Put Option

Under federal income tax regulations, the Sponsor common stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to demand that the Sponsor buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Sponsor can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants who are at least 55 years old and have participated in the Plan for at least 10 years (a "Qualified Participant") so they have the opportunity to allocate part of the value of their investment in the Sponsor's stock into other investments. During each of the first five years of eligible diversification, participants may elect to receive a cash distribution of up to 25% of the total number of shares in Greene Light stock that have been allocated to the participant during the qualified election period (reduced by the number of shares of Greene Light stock previously distributed in cash pursuant to a prior election). In the sixth year of eligible diversification, the percentage of shares that can be distributed increases to 50%. There were no diversifications during the year ended December 31, 2024.

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested. The forfeitures are allocated to active participants in the same way as Company contributions. Forfeitures of terminated nonvested account balances allocated to remaining participants totals \$41,532 for the year ended December 31, 2024. There were no unallocated forfeitures at December 31, 2024 or 2023.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The valuation of investments in the Sponsor's common stock is a significant estimate. Actual results may differ from these estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Company has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Company common stock: The fair value of Sponsor common stock held by the Plan is valued at fair value based on an independent appraisal. This appraisal was based on a combination of the market and income valuation techniques, consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, and market comparables. The Plan's management has concluded that a market participant would also recognize a discount for lack of marketability.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Note Payable - Related Party

The Plan has entered into a term loan agreement with the Sponsor. The proceeds of the loans were used to purchase Sponsor common stock. Unallocated shares are collateral for the loans. Payments on the note are due in annual principal and interest installments and will be repaid through 2050. The loan bears interest at a fixed rate of 1.86%. Interest expense was \$368,280 in 2024.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Plan investments are shares of Sponsor common stock. Greene Light is the plan sponsor and lender to the Plan, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not prohibited transactions as defined by Department of Labor's regulations.

Except as noted in Note 1 and Note 5, as of December 31, 2024 and 2023, the Plan had no amounts due to or from the Sponsor. There were no shares of Sponsor's common stock purchased or distributed in 2024.

The Plan held 1,000,000 shares of Sponsor common stock at December 31, 2024 and 2023.

Note 7: Tax-Exempt Status of the Plan

The Plan has received a determination letter from the Internal Revenue Service ("IRS") dated January 7, 2025, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Note 8: Risks and Uncertainties

The Plan investments consist primarily of the Sponsor's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in values of common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets (deficit) available for benefits.
