### 1 – DESCRIPTION OF THE PLAN

#### **General**

CP 401(k) Plan (the "Plan") is a defined contribution retirement plan that was established on January 1, 2001 for the benefit of employees of Connelly Partners, LLC (the "Company"). The Plan is funded by contributions from its participants and the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **Eligibility for Participation**

Employees are eligible to enter the Plan and begin making elective deferrals and receiving employer contributions after attaining the age of twenty-one. Effective April 1, 2023, part-time employees and interns are not eligible to participate in the Plan.

#### **Employee Elective Deferral Contributions**

Participants may elect to make salary deferral contributions as their contribution to the Plan and participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions, subject to the limitations outlined in the Internal Revenue Code. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document. Newly eligible employees are automatically enrolled in the Plan at a contribution rate of 3% with annual increases of 1% until a deferral rate of 10% is reached.

#### **Discretionary Employer Matching Contributions**

The Company may decide each Plan year to make a discretionary employer contribution matching a portion of each participant's salary deferral contributions. For the year ended December 31, 2023, the Company matched 25% of each participant's deferral contribution. There was no discretionary employer contribution for the year ended December 31, 2024.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company matching contributions portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest 20% after one year of service, 40% after two years of service, 60% after three years of service, 80% after four years of service, and are 100% vested after five years of service with respect to Company matching contributions.

#### **Participant Accounts**

Accounts are maintained for each participant. Accounts are increased for contributions, transfers, and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

#### **Investment Options**

The Plan was established with Fidelity Management Trust Company as its trustee. Upon enrollment into the Plan, a participant may direct employee and employer contributions in whole number percentages into a variety of investment options.

#### **Notes Receivable from Participants**

Participants may borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing lending interest rates as determined by the Plan Administrator. Principal and interest are repaid ratably through payroll deductions.

#### **In-service Withdrawals**

In-service withdrawals may only be made under the following circumstances:

- Hardship as defined in the Internal Revenue Code and the Plan document
- Upon attainment of age 59 ½

#### **Retirement Benefits**

The normal retirement age under the Plan is age 65. Certain participants may be eligible for early retirement subject to the provisions in the Plan document. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

#### **Payment of Benefits**

Upon termination of service from the Company, participants may elect to receive their account balance in the form of a single lump sum payment. Upon termination of service at the Company, a participant with an accumulated balance of \$1,000 or less would receive a distribution of the balance at the discretion of the Company. Effective April 1, 2023, a participant with an accumulated balance of the dollar amount specified in the Internal Revenue Code or less will receive a distribution of the balance at the discretion of the Company.

#### **Timing of Distributions**

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the trustee.

As of December 31, 2024 and 2023, there were no distributions payable to participants.

#### **Administrative Expenses**

Certain administrative expenses are paid by the Plan and certain administrative expenses are paid by the Company. Expenses paid by the Company are excluded from the financial statements.

#### **Forfeited Accounts**

Forfeitures may be used to pay administrative expenses, after which any remaining forfeitures may be applied to reduce future employer contributions. Forfeitures available for use at December 31, 2024 and 2023 totaled \$44,290 and \$38,564, respectively.

#### **Participant-Directed Contributions, Withdrawals and Transfers**

The election to allocate contributions between the investment options, and any decision to change such allocation, is made by each participant as permitted by the trustee. Withdrawals and transfers are recorded at the time such transactions take place.

### 2 – SUMMARY OF ACCOUNTING POLICIES

#### ***Basis of Accounting***

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investments***

Investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and may include amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains (losses) on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### ***Payment of Benefits***

Benefits are recorded when processed and approved for payment.

#### ***Risks and Uncertainties***

The Plan provides for various investment options in various mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

#### ***Subsequent Events***

The Plan Administrator evaluated events that occurred after December 31, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued September 24, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

### 3 – INFORMATION CERTIFIED BY TRUSTEE

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's trustee and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the trustee that such information is complete and accurate.

### 4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6 – PLAN TERMINATION

Although it has expressed no intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, all participants will become 100% vested in their aggregate account balance and will be entitled to a distribution of the balance.

### 7 – INCOME TAX STATUS

Fidelity Management and Research Company ("FMR") obtained an advisory letter from the Internal Revenue Service indicating its "Fidelity Basic Plan No. 17" is qualified under Internal Revenue Code Section 401. The Company has adopted FMR's Basic Plan No. 17.

Although the Company has amended the adopted Plan document, the Company and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 8 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments include shares of investment options managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan's assets and, therefore, these transactions qualify as party-in-interest. During the years ended December 31, 2024 and 2023, administrative services were provided to the Plan by Fidelity Management Trust Company.

The Organization provides certain administrative and accounting services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
