Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Los Angeles Tourism & Convention Board 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

1. Description of the Plan

The following description of the Los Angeles Tourism & Convention Board 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted by the Los Angeles Tourism & Convention Board (the Plan Sponsor or the Company). The Plan is a tax qualified defined contribution plan covering substantially all employees of the Company and the Los Angeles Sports & Entertainment Commission, an affiliate of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

Principal Trust Company (Principal) is the Trustee and provides recordkeeping functions to the Plan. Certain members of executive management are the Plan Administrators and are responsible for oversight of the Plan. The Plan is intended to be a qualified defined contribution plan that satisfies the requirements of section 401(k) of the Internal Revenue Code (the Code).

Eligibility

Employees of the Company, and the Los Angeles Sports & Entertainment Commission who are age 21 years or older are eligible to enter the Plan on the first day of the month following six months of service.

Contributions

Each year, participants may contribute up to 100% of pretax annual eligible compensation, as defined in the Plan, subject to certain annual Internal Revenue Code (IRC) limitations. The Plan also allows for Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for a safe harbor matching contribution (Safe Harbor Matching Contribution) in which the Company, in order to satisfy the "safe harbor" requirements of the Code, contributes a matching contribution based upon each participant's contributions. The Safe Harbor Matching Contribution is equal to 100% of the participant's contributions up to 6% of the participant's compensation. The Company contributed \$675,623 to the Plan during the year ended December 31, 2024.

In addition to the Safe Harbor Matching Contribution, the Plan provides additional discretionary employer matching contributions to participants, none of which were made during the 2024 plan year. The amount of the contribution, if any, is determined by the Company.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, the Safe Harbor Matching Contributions and the earnings thereon. Vesting of employer contributions other than Safe Harbor Matching Contributions, is based upon the following schedule:

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in equal installments over a period of time. For termination of service for other reasons, if the vested account balance exceeds \$5,000, consent is required to distribute the account. A participant may elect to have the vested account balance distributed as soon as administratively feasible or may elect to postpone the distribution until retirement.

If the vested account balance is less than \$5,000, the Plan will distribute the vested account balance without consent. If the amount of the distribution exceeds \$1,000 but is less than \$5,000, including any rollover contributions, and no affirmative election is made, the distribution will be directly rolled over to an individual retirement account (IRA). Participants with an account value of \$1,000 or less who do not elect a distribution will receive a lump-sum distribution of the participant's vested account balance as soon as practicable following termination.

The Plan also allows for in service withdrawals, provided certain criteria are met, as defined in the Plan document.

Forfeitures

Participants who terminate their employment prior to the completion of the minimum number of applicable years forfeit their unvested employer contributions. Forfeitures may be used to pay administrative expenses under the Plan or to reduce future employer contributions payable under the Plan. As of December 31, 2024 and 2023, forfeitures were de minimis.

Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts a maximum amount, equal to the lesser of 50% of the participant's vested account balance or \$50,000, reduced by any outstanding loan balance during the previous twelve-month period. Participant loans are to be repaid within five years, unless the loan is for a principal residence, in which case, the repayment period must be a reasonable period, as determined on the date the loan is made. Participants may have only two outstanding loans at any one time. Participant loans bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Sponsor at the time of the loan. Principal and interest are paid ratably through payroll deductions. An outstanding loan will become due and payable in full 60 days after a participant has a severance from employment and ceases to be a party-in-interest as defined in ERISA or after complete termination of the Plan. The Plan may suspend loan payments for a period not exceeding one year during which an approved unpaid leave of absence occurs other than a military leave of absence. The loan administrator shall provide the participant a written explanation of the effect of the suspension of payments upon their loan.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Any non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is de minimis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Plan's participants absorb certain transaction specific and administration expenses as permitted by the Plan. Administrative expenses paid by the Plan totaled \$32,045 for the year ended December 31, 2024. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts (CIT) - Collective investment trusts are valued at the net asset value (NAV) of units held. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee, and its affiliates. There were certain administrative fees paid by the Plan to the Trustee, and its affiliates for the year ended December 31, 2024. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan provides for various investment options. Such investment options are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. Tax Status

The Plan has adopted the non-standardized pre-approved profit sharing plan, issued by Principal Life Insurance Company, which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the pre-approved plan is in compliance with applicable sections of the IRC. The Plan has since been amended. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for federal or state income taxes is reflected in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.
