NOTE 1 - Description of the Plan

The following description of The Bowen Consulting Group, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established October 1st, 2019 to provide health and other benefits to eligible participants. The sponsoring employer, Bowen Consulting Group, Inc. has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, short-term disability benefits, life and accidental death and dismemberment, and supplemental accident benefits for eligible participants and their dependents. The Plan provides most of these benefits through contracts with third party insurance companies' contracts and on a self-funded basis. The Plan carries a stop-loss insurance policy, which covers both specific and aggregate claims in excess of the deductibles as specified in the contract.

Eligibility rules under the Plan require all employees hired as active employees to receive coverage the first of the month following one month of continuous employment on a fringe contract. Benefits terminate on the last day of the month in which a participant's employment terminates.

Eligible employees who waive medical benefits will receive an allocation to a separate retirement plan at a rate of \$3.75 and \$3.29 per hour worked for year 2024 and 2023, respectively. These retirement contributions are reported as contribution income and then deducted as an expense.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and received dates of December 31, and prior.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through September 23, 2025 the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Excess Loss Indemnity Policy

The Plan has entered into excess loss insurance arrangements in an effort to limit its exposure for self-insured benefits. The Plan maintained insurance policies with Fidelity Security Life Insurance Company during the year ended December 31, 2024 and 2023. The policy contains two excess loss provisions. The first of which applies to individual participant claims, whereby when the claims paid on behalf of an eligible participant or dependent exceeds \$100,000, during a policy year, the insurance carrier will reimburse the plan for 100% of the excess. The second provision involves aggregate plan claims, whereby when the total aggregate claims paid on behalf of all eligible participants or dependents exceed a specified amount based on the number of eligible participants and rate factors (“funding factor”), the insurance carrier will reimburse the Plan 100% of the excess up to a maximum aggregate amount of \$1,000,000, less the amount reimbursed for individuals under the specific individual policy noted above. The insurance company is responsible for funding claims incurred in excess of the funding factor.

The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative only arrangements. The claims processor pay claims directly to or on behalf of participants which are funded by the Plan up to the funding factor and thereafter by the excess loss carrier as noted above. Despite the Plan’s utilization of their-party claims processors, ultimate responsibility of payments to providers and participants is retained by the Plan.

NOTE 4 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. receives commissions and reimbursement of administrative fees from the Plan’s insurance carriers of approximately \$49,442 and \$35,783 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 5 - Income Taxes

The Trust established under the Plan to hold the Plan’s assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended December 31, 2024 and 2023, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
