We have performed audits of the accompanying financial statements of Contegix 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the Contegix 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan. The Plan sponsor is Stratus Midco, Inc. (the “Plan Sponsor”). Eligible employees include employees of the Plan Sponsor and Ascend Integrated Technology Solutions, Inc. (collectively, the “Company”) who have completed 90 days of service and are age 21 or older, excluding leased, part-time, temporary, seasonal employees, and interns. The Plan is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is responsible for oversight and administration of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Effective January 1, 2023, the Plan was amended to include a safe harbor matching contribution.

Participant Contributions – Each year, participants may contribute up to 100% of their annual compensation, as defined by the Plan, not to exceed certain dollar limits established by the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed certain dollar limits established by the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions – The Plan is a safe harbor plan and provides for the Company to match 100% of elective deferrals that do not exceed 3% of each participant’s eligible compensation contributed to the Plan, plus 50% of elective deferrals which are over 3% but do not exceed 5% of each participant’s eligible compensation contributed to the Plan.

Participant Accounts – Each participant’s account is credited with the participant’s deferral contributions, rollover contributions, and allocations of (a) safe harbor matching contributions, and (b) Plan earnings. Participants’ accounts are charged with an allocation of administrative expenses that are paid by the Plan and any losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The participant’s account is debited with any distributions or withdrawals made to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately 100% vested in their salary deferral, rollover contributions, and Company safe harbor matching contributions, plus actual earnings thereon.

Investment Options – Participants direct Principal Trust Company (“Principal”), the “qualified institution,” as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to (i) the lesser of \$50,000 less any outstanding loan balance during the one-year period ending on the day prior to a new loan or (ii) 50% of their vested account balance. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. The loans are secured by the balance in the participant’s account and bear interest at rates from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Note 1—Description of the Plan (continued)

Benefits Paid to Participants – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a life annuity. Upon termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or a life annuity option. Withdrawals from the Plan may also be made upon circumstances of financial hardship, or upon attaining the age 59½ years, in accordance with provisions specified in the Plan.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation in fair value of investments.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for its fully benefit-responsive investment contract, which is at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investments are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 2—Summary of significant accounting policies (continued)

Fair Value Measurement – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used on December 31, 2024 and 2023.

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and these investments are classified within Level 1 of the valuation hierarchy.

Pooled Separate Accounts (“PSA”) – PSAs invest mainly in domestic stocks, fixed securities, and commercial real estate. The majority of the underlying securities have observable, publicly quoted pricing inputs. PSAs are valued using NAV which is not publicly quoted but is made available to investors through the qualified institution. NAV is the basis for current transactions, and the PSA can be redeemed at NAV of a measurement date. Therefore, PSAs have a readily determinable fair value and are classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 2—Summary of significant accounting policies (continued)

Fixed Income Guaranteed Option – Principal fixed income guaranteed option (“PFIGO”) is a single group annuity contract with a fixed rate of interest. PFIGO is a fully benefit-responsive annuity contract issued by Principal Life Insurance Company. Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semiannual basis. Average yield earned by the Plan is calculated by dividing the annualized earnings of all fully benefit-responsive investment contracts by the fair value of all fully benefit-responsive investment contracts. The average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The declared crediting rate for the PFIGO for the Plan years ended December 31, 2024 and 2023 was 4.70% and 1.55%, respectively.

The investment is valued at contract value, which is the amount participants would receive if they were to withdraw or transfer funds prior to maturity. This does not include a 5% surrender charge, which would be imposed if the Plan decided to terminate this investment contract. Certain events limit the ability of the Plan to transact at contract value with the issuer such as the termination of a Plan’s interest or termination of the Plan; however, the Plan Sponsor does not believe any of these events are probable.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments, at fair value, fully benefit-responsive investment, at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest on fully benefit-responsive investment, dividends, interest from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Parties-in-interest

Certain Plan investments are managed by affiliates of the qualified institution. Transactions involving these investments qualify as party-in-interest transactions for which statutory exemption exists under DOL’s Rules and Regulations. Fees incurred by the Plan for investment management services are paid directly by the Plan and, therefore, also qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan and deducted from participant accounts for administrative expenses amounted to \$36,551 for the year ended December 31, 2024 and are included in administrative expenses on the accompanying statement of changes in net asset available for benefits. Notes receivable from participants also qualify as party-in-interest transactions.

Note 6—Tax status

The Plan Agreement is based on a principal prototype plan which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated the prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of this letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt. The Plan Sponsor believes the Plan has no income subject to unrelated business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

Note 8—Subsequent events

The Plan has evaluated subsequent events for potential recognition and disclosure through September 5, 2025, the date the financial statements were available to be issued.

In October 2024, the Plan Sponsor was acquired by Valiantys America, Inc. Effective January 1, 2025, the Plan was amended to change the name of the Plan Sponsor to Valiantys America, Inc. and the Plan name to Valiantys America, Inc. 401(k) Plan.
