Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Other Matter**

#### *Supplemental Schedules Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024, and delinquent participant contributions for the year then ended (referred to as the "supplemental schedules"), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from

and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of the W.W. Grainger, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established by W.W. Grainger, Inc. (the Company) for the benefit of its employees and the employees of certain subsidiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Eligibility and Contributions**

An employee is eligible for participation in the Plan on the first day of employment with the Company or a participating subsidiary (collectively, the Employer).

The Plan allows eligible participants to defer up to 75% of their eligible compensation, as defined in the Plan. The Plan has a Roth feature whereby participants may elect to make after-tax contributions to the Plan. Participants age 50 and older can make additional catch-up contributions. The Plan has a 3% automatic enrollment provision and annual escalation. Contributions for participants with a deferral election below 6% are generally increased 1% annually to a maximum of 6%. Both the automatic enrollment and annual escalation are subject to the participant's ability to opt out. Participants may also rollover qualified distributions from a previous employer into the Plan.

The Company makes a safe harbor non-elective contribution equal to 6% of participants' eligible compensation, as defined in the Plan, into their accounts each pay period. Both participant contributions and Company contributions are subject to certain limitations under the Internal Revenue Code (the IRC).

## Notes to Financial Statements (continued)

### **1. Description of the Plan (continued)**

#### **Investment of Contributions**

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options daily. The Company's contributions are invested in the same manner as that of the participant's elective contributions. Participants can invest up to 20% of their account balances in the Grainger Stock Fund using money from Company contributions only. Participants cannot direct employee contributions into the Grainger Stock Fund. The Grainger Stock Fund may also hold cash or other short-term securities, although these are expected to be a small percentage of the fund.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their elective pre-tax, Roth after-tax and the Company's safe harbor contributions plus actual earnings thereon.

Vesting in the Company's profit-sharing contributions, which were effective for plan years ending prior to January 1, 2021, is based on years of continuous service. A participant is fully vested after five years of credited service. In addition, a participant's account becomes fully vested upon the occurrence of certain specified events, including attainment of age 60, death, permanent disability, or entry into the United States military service.

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

#### Payment of Benefits

Upon retirement, participants may elect to receive their account balance in a single lump-sum distribution, in substantially equal periodic installments over a reasonable period of time not to exceed their life expectancy or the joint life expectancy of the participant and spouse or another designated beneficiary, or in a combination of lump-sum and installment payments. Participants may elect to receive payment of the portion of their withdrawal attributable to amounts invested in the Grainger Stock Fund in the form of whole shares of the Company's common stock and cash in lieu of any fractional shares.

Any retiring or terminating participants whose vested account balance is greater than \$1,000 may elect to begin distribution of their vested amount at any time or may defer distribution, but no later than the time required by law. If a participant's vested account balance is \$1,000 or less, a single lump-sum distribution will be made as soon as practicable following retirement or termination of service.

The Plan allows for in-service withdrawals. In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS).

The Grainger Stock Fund under the Plan is intended to constitute an employee stock ownership plan and provide for pass-through dividend treatment for participants who elect such treatment.

#### Participant Loans

Participants may borrow from their account balance up to a maximum amount equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the prior 12 months, or 50% of their vested account balance. Participants may have only one loan outstanding at a time. The loan repayment term may be for a period not to exceed five years, or if the purpose of the loan is to acquire a principal residence, the loan repayment term may be for a period not to exceed ten years. Loans bear interest at a rate commensurate with prevailing rates as determined by the Plan. Interest rates on all outstanding loans at December 31, 2024, ranged from 4.25% to 10.50%, which were the prevailing rates at the time of the loan. Principal and interest are paid ratably through payroll deductions.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions may be reinstated. The forfeiture account amounts are utilized to pay reasonable administrative expenses of the Plan, to restore eligible accounts, and to offset Company contributions. Unallocated forfeiture balances as of December 31, 2024 and 2023, were \$21,146 and \$72,668, respectively. For the 2024 plan year, forfeited non-vested accounts totaling \$3,300,000 were utilized to offset Company contributions to eligible participants.

##### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company and consist primarily of trustee fees for investments held outside the W.W. Grainger, Inc. Defined Contribution Master Trust (Master Trust), as provided by the Plan's provisions. Administrative expenses related to the Master Trust are allocated to the Plan and are reflected in the net investment gain from the Master Trust. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Expenses that are paid directly by the Company are excluded from these financial statements.

##### **Plan Termination**

Although the Company has expressed no intent to do so, it may terminate the Plan at any time, in whole or in part, subject to the provisions of ERISA. In the event of the Plan's termination, participants become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

##### **Other**

The Plan is intended to comply with the requirements of Section 404(c) of ERISA. Under ERISA Section 404(c), plan fiduciaries may be relieved of fiduciary liability for losses that result from the participants' independent investment decisions related to the Plan's investment funds.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual method of accounting in conformity with United States generally accepted accounting principles (U.S. GAAP) as applied to defined contribution plans. A summary of the significant policies applied in the preparation of the accompanying financial statements follows.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments, including those investments held in the Master Trust, are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Payment of Benefits**

Plan withdrawals are recorded when paid.

### 2. Summary of Significant Accounting Policies

#### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

### 3. Investments

The following investment information was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company (Vanguard), the trustee of the Plan. The fair value of the investments held in the Master Trust was not certified.

#### 4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active

#### 4. Fair Value Measurements (continued)

- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest-level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan and Master Trust:

*Registered investment companies* – Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

*Common stock* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Common/collective trust funds* – Valued at the NAV provided by the administrator of the funds.

**5. Investment in Master Trust**

Certain of the Plan’s investments are held in a Master Trust that was established for the investment of assets of the Plan and another Company-sponsored retirement plan. The Plan has specific interests in certain investments of the Master Trust based on account balances of the participants and their investment options. The Master Trust assets are allocated among the participating plans by assigning to each plan those transactions (primarily contributions, benefit payments, and plan-specific expenses) that can be specifically identified and by allocating among all plans, in proportion to the fair value of the assets assigned to each plan, income and expenses resulting from the collective investment of the assets of the Master Trust. At December 31, 2024 and 2023, the Plan’s interest in the net assets of the Master Trust was approximately 99.99%.

#### 6. Risks and Uncertainties

The Plan and the Master Trust provide for various investments that, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### Notes to Financial Statements (continued)

#### **7. Related-Party and Party-in-Interest Transactions**

The Company and Vanguard, provider of trustee and record-keeping services, are parties-in-interest as defined by ERISA. Certain plan investments are shares of the Company's common stock, shares of registered investment companies, and units of common/collective trust funds managed by Vanguard. As such, these investments qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. During 2024, the Plan received \$1,201,993 in common stock dividends from the Company.

Certain administrative expenses of the Plan are paid by the Company. Members of the Committee of the Plan are employees of the Company.

#### **8. Tax Status**

The Plan has received a determination letter from the IRS dated June 23, 2017, stating that the Plan is qualified under Section 401(a) of the IRC, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan, as amended and restated, is qualified and the related trust and Master Trust are tax-exempt. To the extent that operational issues arise from time to time, the plan administrator has indicated that it has taken and/or will take all necessary actions, if any, to maintain the Plan's compliance with the Code.

The Plan has also received a determination letter from the Commonwealth of Puerto Rico's Department of Treasury (Treasury) dated August 12, 2025, stating that the Plan is qualified under Section 165(a) of the Income Tax Act, and, therefore, the related trust is exempt from taxation. The Plan is required to operate in conformity with the Treasury to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Puerto Rico Code and, therefore, believes the Plan is qualified and the related trust and Master Trust are tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
