### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Novolex TE 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of the Novolex TE 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan with a cash or deferred arrangement, sponsored by Novolex Holdings, LLC (the Company, plan sponsor), covering substantially all hourly employees at the Northern Kentucky, New Jersey, Tennessee and Arizona manufacturing plants of the plan sponsor, governed by collective bargaining agreements.

Employees of the Northern Kentucky, Tennessee, New Jersey and Arizona manufacturing plants are eligible to become participants once they have reached 18 years of age and completed 90 days of service. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan. Employees can enroll in the Plan on the first day of the month following the date the eligibility requirements are met, as defined by the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Contributions

Each year, participants may defer a portion of their pretax annual compensation, as defined, subject to certain statutory limitations. Participants may also elect to make Roth 401(k) contributions, of which are subject to federal income taxes in the year of deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or contribution plans. Additionally, the Internal Revenue Code (IRC) allows for participants over the age of 50 to make additional contributions (catch-up contributions) in excess of these limits. Participants aged 60-63 are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or contribution plans. Participants direct the investment contributions of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants subject to certain collective bargaining agreements, as defined in the plan document, are automatically enrolled in the Plan the first of the month following 90 days of service upon meeting eligibility requirements. Participants are auto-enrolled with an effective deferral rate of 5%, which is allocated to the Plan's qualified default investment alternative, the American Funds Target Date Retirement Funds, based on the participants retirement age of 65.

Basic contributions are matched by the plan sponsor at various rates according to each collective bargaining agreement. Plan participants should refer to their respective collective bargaining agreement for specific details on these matching contributions made by the plan sponsor. Participants are generally eligible to receive matching contributions on the first day of the month or next following date requirements are met, unless a different entry date is required by a collective bargaining agreement. For the year ended December 31, 2024, the plan sponsor made a matching contributions equal to 100% of the first 3% and 50% on the next 2% of compensation contributed by participant, for all eligible participants.

Non-Elective Contribution 1 – The plan sponsor is permitted to make an additional nonelective contribution equal to a discretionary percentage of eligible compensation (determined each year by the plan sponsor and as stated in the collective bargaining agreement). If a nonelective contribution is made by the plan sponsor, it is in the same ratio that the participants' salary bears to the total salary of all participants in the Plan. Participants are generally eligible to receive nonelective contributions on the first day of the plan year or first day of 7th month of plan year on or next following date eligibility requirements are met, unless a different entry date is required by a collective bargaining agreement. To receive the nonelective contribution, participants must be employed on the last day of the plan year. The plan sponsor did not make a nonelective contribution to the Plan during the years ended December 31, 2024 and 2023.

Non-Elective Contribution 2 – This contribution type was introduced pursuant to a plan amendment dated October 1, 2024. The plan sponsor may make this contribution at its discretion. If made, it is allocated as an equal dollar amount to all eligible participants, with no service requirement. For the year ended December 31, 2024, the plan sponsor made a Non-Elective Contribution 2 totaling \$98,260.

### **Participant Accounts**

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's pretax or Roth contributions, the plan sponsor's matching contribution, the plan sponsor's nonelective contributions, plan earnings or losses, and administrative expenses which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested at all times in their pretax and Roth contributions and earnings or losses thereon. Matching contributions are subject to a graded vesting schedule under which participants become 25% vested after one year of service, with an additional 25% vesting each subsequent year, resulting in 100% vesting after four years of service. Non-Elective Contribution 1 is subject to a three-year cliff vesting schedule, under which participants become 100% vested after completing three years of service. Non-Elective Contribution 2 is 100% vested immediately.

Participants with transfers of contributions, and in-service withdrawals from the Novolex AE 401(k) and Novolex Holdings, LLC 401(k) Plan (affiliated plans), and predecessor plans have varying vesting schedules, and withdrawal restrictions as defined in the plan document.

### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance incurred by the participant during the 12-month period ending on the day before the date on which the loan was made or 50% of the value of the vested interest in the participant's plan account. No participant may have more than one loan outstanding at one time. The loans are secured by an equivalent lien on the participant's nonforfeitable interest in the Plan at the time of the loan. The loan interest rate, determined daily, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through weekly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

### **Payment of Benefits**

Upon termination of service, a participant may receive a lump-sum payment or partial cash payments. Active participants may withdraw all of their pretax and Roth contribution, employer contributions, employer nonelective contributions and related earnings, under hardship conditions as defined in the plan agreement, subject to certain restrictions and tax penalties. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the plan sponsor.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$128,441 and \$26,415, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$302 and plan administrative expenses were reduced by \$6,247, from forfeited nonvested accounts, in accordance with plan provisions.

### **Recent Accounting Standards**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## **2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, State Street Bank and Trust Company and Transamerica Life Insurance Company, the Trustee and Custodian of the Plan (Trustee and Custodian) and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### **Subsequent Events**

Subsequent events were evaluated through September 25, 2025, the date the financial statements were available to be issued.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 4. Concentrations

The Plan holds certain investments that represent 10% or more of the plan's net assets available for benefits. As of December 31, 2024, and 2023, the Plan held two such investments totaling \$4,520,243 and \$4,009,337, respectively.

### 5. Fully Benefit-Responsive Investment Contracts

The Transamerica Guaranteed Investment Option (Option) is a stable value product that guarantees principal and interest and is a fully benefit-responsive investment. The Option is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Guarantees are provided to participating retirement plans through a group annuity contract issued by Transamerica Life Insurance Company. The Option seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis and there is no set maturity. Interest shall accrue on the Contract Balance at the initial rate of interest declared by Transamerica Life Insurance Corporation (TLIC) prior to the Contract Date until such time as a new rate of interest shall be declared by TLIC. Each such declared rate of interest is referred to as a "Declared Rate" and the date upon which any Declared Rate shall become effective is referred to as a "Reset Date." The Declared Rate shall not be reduced for a period of at least 12 months following the most recent Reset Date, but the Declared Rate may be increased at any time. In the event of a reduction in the Declared Rate, TLIC shall notify the Plan of such reduced Declared Rate at least 45 days prior to the Reset Date. No prior notice is required for TLIC to increase the Declared Rate. In no event may the Declared Rate be less than the Minimum Guaranteed Interest Rate.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The annual return (Declared rate) for the Transamerica Guaranteed Investment Option in 2024 and 2023 is 3.55% each.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the Minimum Guaranteed Interest Rate of 0%. The contract cannot be terminated before the scheduled maturity date.

### **6. Information Certified by Trustee**

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, State Street Bank and Trust Company and Transamerica Life Insurance Company, the Trustee and Custodian of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### **7. Related-Party and Party in Interest Transactions**

Certain plan investments are managed by State Street Bank and Trust Company and Transamerica Life Insurance Company, the Trustee and Custodian of the Plan, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **9. Tax Status**

The Plan adopted a pre-approved plan offered by Transamerica Retirement Solutions Corporation. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
