Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Novolex Holdings, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Novolex Holdings, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Novolex Holdings, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Novolex Holdings, LLC (the Company, plan sponsor), except union employees, nonresident aliens with no U.S. source income, leased employees, employees of controlled employer group that does not affirmatively adopt this plan and independent contractors, who are at least 18 years of age and have completed three months of qualifying service. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan. Participants should refer to the plan agreement for a more complete description of the Plan's eligibility requirements. Employees are eligible to become participants on the first day of the month following the date the eligibility requirements are met, as defined by the plan agreement. The Plan implemented a Safe Harbor plan design, as permitted by the Internal Revenue Service (IRS), which exempts the Plan from certain compliance requirements, primarily associated with non-discrimination testing requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Transfers

From time to time, employees may no longer meet the eligibility requirements of the Plan and become eligible to participate in another qualified plan sponsored by the Company or vice versa. These employees have their account balances transferred between the Plan and another qualified plan sponsored by the Company.

During 2024, \$876,175 of transfers came into the Plan from another plan sponsored by the Company.

Contributions

Each year, participants may contribute from 1% to 90% pretax annual compensation, as defined, subject to certain statutory limitations. Participants may also elect to make Roth 401(k) contributions which are subject to federal income taxes in the year of deferral. Additionally, the Internal Revenue Code (IRC) allows for participants over the age of 50 to make additional contributions (catch-up contributions) in excess of these limits. Participants aged 60-63 are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes an auto enrollment provision whereby all newly eligible employees, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Newly hired employees are automatically enrolled at a 5% deferral rate which is allocated to the Plan's qualified default investment alternative, the American Funds Target Date Retirement Funds, based on the participant's retirement age of 65. Effective January 1, 2025, automatically enrolled participants will have their deferral rate increased by 1% on the anniversary of their enrollment date until it reaches 15%. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

The Plan provides for a safe harbor matching contribution to each eligible participant's account in an amount equal to 100% of the first 3%, plus 50% of the next 2% of eligible compensation, as defined, that a participant contributes to the Plan for the plan year.

In addition, the Plan provides for two types of discretionary non-elective contributions, as defined under the Plan:

1. Non-Elective Contribution 1 – This contribution may be made annually at the discretion of the plan sponsor and is allocated to eligible participants in proportion to each eligible participant's compensation relative to the total compensation of all eligible participants. Participants eligible for this contribution must have completed one year of credited service and be actively employed on the last day of the plan year, or have terminated during the year due to death, disability or retirement. No Non-Elective Contribution 1 was made for the years ended December 31, 2024 and 2023.
2. Non-Elective Contribution 2 – This contribution type was introduced pursuant to a plan amendment dated October 1, 2024. The plan sponsor may make this contribution at its discretion. If made, it is allocated as an equal dollar amount to all eligible participants, with no service requirement. For the year ended December 31, 2024, the plan sponsor made a Non-Elective Contribution 2 totaling \$715,895.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's pre-tax and Roth 401K contributions, the plan sponsor's safe harbor matching contribution, an allocation of the plan sponsor's discretionary nonelective contributions, if any, plan earnings and losses, and an allocation of administrative expenses, which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions, including actual earnings thereon. Vesting in the Plan sponsor's Discretionary Non-Elective Contribution 1 is based on years of continuous service. Participants are 20% vested after one year of credited service and continue to vest in increments of 20% until becoming 100% vested after five years of credited service. Non-Elective Contribution 2 is 100% vested immediately.

Participants with transfers of contributions and in-service withdrawals from the Novolex TE 401(k) and Novolex AE 401k Plan (affiliated plans) and predecessor plans have varying vesting schedules and withdrawal restrictions as defined in the plan document.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance incurred by the participant during the 12-month period ending on the day before the date on which the loan was made or 50% of the value of the vested interest in the participant's plan account. No participant may have more than one loan outstanding at one time. The loans are secured by an equivalent lien on the participant's nonforfeitable interest in the Plan at the time of the loan. The loan interest rate, determined daily, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum payment or an installment payment over the life expectancy of the participant or may elect a deferral option. Participants may withdraw all or a portion of their pre-tax, after-tax, employer contributions, discretionary nonelective contributions and related earnings, in accordance with hardship provision of the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the plan sponsor.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,216 and \$26,203, respectively. These accounts can be used to offset administrative expenses or reduce employer contributions. During 2024, employer contributions were reduced by \$24,872 and plan administrative expenses were reduced by \$3,637, from forfeited nonvested accounts, in accordance with plan provisions.

Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions along with some voluntary provision effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, State Street Bank and Trust Company and Transamerica Life Insurance Company, the Trustee and Custodian of the Plan (Trustee and Custodian) and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through September 25, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Concentrations

The Plan holds certain investments that represent 10% or more of the Plan's net assets available for benefits. As of December 31, 2024 and 2023, the Plan held one such investments totaling \$46,184,533 and \$38,523,086, respectively.

5. Fully Benefit-Responsive Investment Contracts

The Transamerica Guaranteed Investment Option (Option) is a stable value product that guarantees principal and interest and is a fully benefit-responsive investment. The Option is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Guarantees are provided to participating retirement plans through a group annuity contract issued by Transamerica Life Insurance Company. The Option seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis and there is no set maturity. Interest shall accrue on the Contract Balance at the initial rate of interest declared by Transamerica Life Insurance Corporation (TLIC) prior to the Contract Date until such time as a new rate of interest shall be declared by TLIC. Each such declared rate of interest is referred to as a "Declared Rate" and the date upon which any Declared Rate shall become effective is referred to as a "Reset Date." The Declared Rate shall not be reduced for a period of at least 12 months following the most recent Reset Date, but the Declared Rate may be increased at any time. In the event of a reduction in the Declared Rate, TLIC shall notify the Plan of such reduced Declared Rate at least 45 days prior to the Reset Date. No prior notice is required for TLIC to increase the Declared Rate. In no event may the Declared Rate be less than the Minimum Guaranteed Interest Rate.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The annual return (Declared Rate) for the Transamerica Guaranteed Investment Option in 2024 and 2023 is 3.55% each year.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the Minimum Guaranteed Interest Rate of 0%. The contract cannot be terminated before the scheduled maturity date.

6. Information Certified by Trustee

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, State Street Bank and Trust Company and Transamerica Life Insurance Company, the Trustee and Custodian of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain plan investments are managed by State Street Bank and Trust Company and Transamerica Life Insurance Company, the Trustee and Custodian of the Plan, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan adopted a pre-approved plan offered by Transamerica Retirement Solutions Corporation. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
