INDEPENDENT AUDITORS' REPORT

TO THE PLAN'S 401(k) COMMITTEE OF STATS CHIPPAC, INC. 401(k) PLAN AND TRUST

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of STATS CHIPPAC, INC. 401(k) PLAN AND TRUST (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the STATS ChipPAC, Inc. 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan which was established on January 1, 1999, and restated on April 20, 2022, to provide retirement benefits for eligible employees of STATS ChipPAC, Inc. and an affiliated company, STATS ChipPAC Test Services, Inc. (collectively, the “Company”). Employees are eligible to participate in the Plan on the first day of the month following the date of their employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”).

The Plan provides for a plan administrator who is responsible for keeping accurate and complete records with regard to the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law.

Participant Contributions – Participants may elect to contribute on a pre-tax basis, post-tax basis (“ROTH”), or after-tax basis, either a percentage or set dollar amount of annual eligible compensation, as defined by the Plan agreement. Participants may elect to contribute up to 60% of their annual eligible compensation, subject to annual limits specified by the IRC. For the year ended December 31, 2024, the annual limitation was \$23,000. Participants who reached at least 50 years of age by the end of the calendar year and who are making contributions to the Plan are permitted to make additional catch-up contributions limited to \$7,500 for the year ended December 31, 2024. Participants are also allowed to roll over contributions from other qualified retirement plans, subject to approval by the plan administrator. Participant contributions are vested and nonforfeitable at all times.

The Plan provides an auto-enrollment provision whereby all newly hired employees who have not yet enrolled in the Plan are automatically enrolled at a contribution rate of 6% of eligible compensation 35 days after their date of hire unless they have expressly elected not to make any salary contribution. All automatically enrolled employees may subsequently elect to stop or change the automatic contribution percentage.

Employer Contributions – The Company may make discretionary matching contributions to the Plan, subject to limitations imposed by applicable provisions of the IRC. For the year ended December 31, 2024, the Company elected to make matching contributions to each active participant’s account in an amount equal to 100% of each eligible participant’s contribution up to a maximum of 4% of the participant’s eligible compensation, limited to a maximum annual employer contribution of \$10,000 per participant.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Participant Accounts – The Plan maintains an account for each participant that is credited or charged with the participant’s contributions, rollover contributions, the Company’s discretionary employer matching contributions and investment earnings or losses and expenses. Allocations are based on participant compensation or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that may be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings or losses thereon. Participants vest in the Company’s discretionary contributions plus actual earnings or losses thereon based on their years of service according to the following schedule:

Less than 1	0%
1	50%
2	100%

Eligible employees who were participants in the Plan prior to August 1, 1999, became immediately 100% vested in employer contributions to their accounts as of that date as a result of a change in ownership of the Company.

Participants who terminated employment prior to January 1, 2005, vest in employer contributions based on their years of service according to the following schedule:

Investment Options – Upon enrollment in the Plan, a participant may direct the investment of his or her account balance into various funds available through the Plan.

Notes Receivable from Participants – Participants may borrow from their vested account balances provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant’s vested account balance or \$50,000. The maximum loan term may not exceed five years, except for loans used to finance the purchase of a primary residence, for which the maximum term may not exceed ten years. Loans are subject to interest charged at rates which remain fixed throughout the term of the loan. Interest rates are determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money in similar circumstances. Principal and interest are paid ratably through payroll deductions and loans are due immediately upon termination of employment.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits – Normal retirement is 59 ½ years of age; however, participants are eligible to receive distributions from the Plan upon reaching normal or early retirement age, termination of service, death or disability as a lump-sum distribution or installment distributions up to the value of the participant's vested interest in his or her account. Hardship distributions and in-service distributions upon attainment of age 59 ½ as defined in the Plan, are also permitted. Benefit payments to the participant generally must begin by the later of the year after the participant attains age 73 or the year in which the participant terminates employment. Vested account balances of less than \$1,000 are automatically cashed out as a single lump-sum distribution.

Forfeited Accounts – The unvested portion of a terminated employee's account is forfeited subject to the possibility of reinstatement if the participant is re-hired under certain circumstances. Forfeitures may be used to pay Plan administrative expenses or reduce future employer contributions to the Plan. Forfeited non-vested accounts amounted to \$500 and \$47 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures of \$18,333 were used to reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions – Contributions from participants and matching contributions from the employer are recorded in the Plan year which coincides with the payroll pay date.

Payments of Benefits – Benefits are recorded when paid.

Expenses – Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain investment management services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are required to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the Plan’s valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts consist of mutual funds, which are valued as described above; common stock and exchange-traded funds valued at the closing price reported on the active market on which the individual securities are traded; and U.S. government securities valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Collective Trust Fund: Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require advance notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with the fair value measurement guidance, investments measured using the net asset value practical expedient are not required to be classified within the fair value hierarchy in the following tables.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (“Fidelity”), the trustee, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the Statements of Net Assets Available for Benefits and in Note 3 as of December 31, 2024 and 2023, the supplemental Schedule H, line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan is a defined contribution plan designed to qualify as a tax-exempt plan under the IRC. The Plan adopted the Fidelity Pre-Approved Defined Contribution Plan that has received an opinion letter June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Pre-Approved Defined Contribution Plan and related trust are designed in accordance with the applicable requirements of the IRC. The Plan has not received a separate determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of various funds managed by Fidelity. Fidelity is the trustee and custodian, as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for recordkeeping and administrative services are netted against net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid \$5,086 to Fidelity and its affiliates for administrative services and investment management services provided for the year ended December 31, 2024 which is reported in the accompanying Statement of Changes in Net Assets Available for Benefits.

Fidelity and affiliates provide administrative services to the Plan pursuant to a service agreement between the Company, Fidelity and affiliates. Fidelity and affiliates receive revenue from certain mutual fund service providers for services Fidelity and affiliates provide to the funds. This revenue is used to offset certain amounts owed to Fidelity and affiliates for its administrative services to the Plan. If the revenue received by Fidelity and affiliates from such mutual fund service providers exceeds the amount owed under the service agreement, Fidelity remits the excess to the Plan. Such amounts may be applied to pay Plan recordkeeping and administration fees. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to Fidelity and affiliates for administration expenses not covered by revenue sharing.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination from among the funds offered through the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 9 – SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through September 24, 2025, which is the date of the Plan's financial statements were available to be issued.
