## **Report of Independent Auditors**

To the Participants and Trustees of  
Roofers Local No. 96 Annuity Fund

### ***Opinion***

We have audited the financial statements of Roofers Local No. 96 Annuity Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Roofers Local No. 96 Annuity Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1. Description of the Plan

Roofers Local No. 96 Annuity Fund (the Plan) was established in 1982 as a result of a collective bargaining agreement between United Union of Roofers, Waterproofers, and Allied Workers Local Union No. 96 (the Local) and Twin City Roofing Contractors Association to provide termination or retirement benefits for eligible participants. The Plan is a multiemployer defined contribution retirement plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a joint board of trustees consisting of an equal number of union and employer representatives. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

An individual becomes eligible to participate in the Plan on the date one hour of work is completed for a contributing employer who has entered into a collective bargaining or other agreement with the Local, requiring contributions to the Plan on the participant's behalf, and those contributions have been received. Voluntary contributions from participants are not allowed under the Plan. Although participants are immediately vested in contributions plus actual earnings thereon, a participant, or the beneficiary of a deceased participant, may forfeit their account if there have been no contributions made on their behalf for a period of 60 months, the individual has had no contact with the Plan for a period of 60 months, and the Trustees, after exhausting reasonable search efforts, are unable to locate the participant or beneficiary. Forfeitures are available to reduce the expenses of the Plan. In the event the participant or beneficiary is later located, the value of the account as of the date of the forfeiture will be restored to the credit of the individual, and will be charged as an expense. There were no forfeitures for the years ended December 31, 2024 and 2023.

Participants direct the investment of contributions into various investment options offered by the Plan. In the absence of participant direction, contributions are invested in a qualified default investment alternative until changed by the participant. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investments selected by participants may cause their balances to be lower than the amounts contributed to the Plan on their behalf.

Participants' accounts are credited with employer contributions made on their behalf, as well as an allocation of Plan earnings or losses, based on participant earnings, account balances or specific participant transactions, as defined. An administrative fee is deducted from each participant's account. Fees charged per participant consist of the following: monthly plan administration fees of \$2.60 and 1.09 basis points, quarterly recordkeeping fees of \$18.75 and quarterly custodial fees, which are ratably allocated to all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## **Note 1. Description of the Plan (continued)**

Distribution of a participant's account commences upon receiving written application for benefits and after any of the following events:

- A participant retires on or after age 62 or has begun receiving retirement benefits from the National Roofing Industry Pension Fund;
- A participant dies prior to becoming eligible for benefits;
- A participant becomes totally and permanently disabled; or
- A participant has not worked in covered employment for at least 12 consecutive months.

Net assets available for benefits include approximately \$382,000 and \$390,000 of an unallocated reserve at December 31, 2024 and 2023, respectively, which may be used to pay administrative costs incurred by the Plan.

Participants should refer to the summary plan description for more complete information.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Investments** - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex dividend date.

**Contributions Receivable** - Employer contributions due and not paid at year end are recorded as contributions receivable. Employer contribution deficiencies established through payroll compliance audits are recognized upon settlement with the employer. An allowance for doubtful accounts is considered unnecessary and is not provided.

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 within a jurisdiction primarily located in Minnesota and select counties in Wisconsin.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Revenue Sharing** - Revenue sharing income represents the portion of investment management fees that the investment manager has agreed to reimburse to help offset the cost of administrative services provided. Revenue sharing is allocated to those participants' accounts that generate the income.

**Payment of Benefits** - Benefits paid to participants are recorded upon distribution. No amounts were allocated to participants who elected to withdraw from the Plan but were not paid at both December 31, 2024 and 2023.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through August 14, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants and their beneficiaries except that provision may be used for payment of necessary expenses resulting from termination of the Plan.

In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

## **Note 4. Tax Status**

The Plan's latest determination letter is dated November 4, 2015, in which the Internal Revenue Service (IRS) stated that the Plan and related trust were designed in accordance with Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

#### **Note 4. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

##### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Measurements Using Net Asset Value as a Practical Expedient

The stable value fund is valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

## **Note 5. Fair Value Measurements (continued)**

### Measurements Using Net Asset Value as a Practical Expedient (continued)

The stable value fund is a direct filing entity (DFE) and files a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis, but are limited to the contract value of the stable value fund and not the fair value.

### Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

## **Note 6. Concentration of Plan Investments**

At December 31, 2024 and 2023, the Plan had a significant portion of its assets invested in two mutual funds: Vanguard Institutional Target Retirement 2030 Fund and Vanguard Institutional Target Retirement 2040 Fund. These investments represented approximately 58% of the Plan's net assets available for benefits at both December 31, 2024 and 2023.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant directed fund elections. Additionally, the investments within each participant directed fund election are future diversified into varied financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

## **Note 7. Funding Policy**

Employer contributions to the Plan are made under various collective bargaining agreements. The hourly contribution rate for the majority of journeyworkers ranged from \$3.64 to \$4.49 during the years ended December 31, 2024 and 2023.

## **Note 8. Major Employers**

Contributions from two employers accounted for approximately 28% and 24% of total contributions during the years ended December 31, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would retain the risk of meeting fixed administrative expenses until the appropriate adjustments were made.

**Note 9. Related Organizations**

The Plan has three related entities which include a labor union, a welfare plan and an apprentice and training fund, all of which are tax-exempt.

Contributions for the Plan and related organizations are received and deposited into the related welfare plan's operating account. Amounts owed are routinely transferred from the account to the respective organizations' cash accounts. No amounts were due from the welfare plan for contributions received at either December 31, 2024 or 2023.
