### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Keysight Technologies, Inc. Retiree Health Programs, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Keysight Technologies, Inc. Retiree Health Programs as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Keysight Technologies, Inc. ### Note 1 – Description of the Health Plan

The following description of the Keysight Technologies, Inc. Retiree Health Programs (the Health Plan formerly referred to as the Keysight Technologies, Inc. Health Plan for Retirees), provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General** – Prior to January 1, 2023, the Health Plan was established in 2014 by Keysight Technologies, Inc. (the Company or Keysight), to provide comprehensive health care benefits to eligible retirees, totally disabled former employees and their eligible dependents, and eligible dependents of deceased eligible employees. The Health Plan is designed to comply with the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, the Company executed a wrap Plan document to combine various retiree medical programs, with the Health Plan as the surviving plan. As a result, and effective January 1, 2023, the Keysight Technologies, Inc. Health Plan for Retirees (Health Plan for Retirees), the Keysight Technologies, Inc. Reimbursement Arrangement Plan (KRA), and the Keysight Technologies, Inc. Retiree Medical Account Plan (RMA) were combined into the Health Plan. Respective plan benefits continue and are referred to as Health Plan for Retirees, KRA and RMA throughout the following disclosures.

The Health Plan's assets are made up of interest-bearing cash held in a custodial trust account with Bank of New York Mellon, N.A. (Mellon), reported on the Form 5500 of this Plan (which is used for the Health Plan for Retirees), and an interest in the 401(h) Account held by the Keysight Technologies, Inc. Retirement Plan (the Retirement Plan) reported on the Form 5500 of the Retirement Plan. The 401(h) Account has an interest in the Keysight Technologies, Inc. Master Trust (the Master Trust). The assets of the 401(h) Account are included as assets of the Health Plan in these financial statements, but are used to fund the benefit obligations of the Health Plan for Retirees, the KRA and the RMA.

**Administration** – The Company has appointed the Benefits Committee (the Committee) to manage the operation and administration of the Health Plan. The Company has contracted with Mellon to act as the custodian and trustee, and a third-party administrator, Fidelity Workplace Services, LLC (Fidelity), to process and maintain the records of participant data.

For the Health Plan for Retirees, the Company has also contracted with UnitedHealthcare (UHC) and Kaiser to administer the processing and payment of claims from the Health Plan's assets.

The Company has also contracted with Willis Towers Watson and its wholly owned subsidiary Extend Health, Inc. (Extend Health) to administer the processing and payment of claims for health insurance premium reimbursements from the KRA and the RMA.

All eligible expenses incurred for administering the Health Plan are paid by the 401(h) Account.

Premiums for the Health Plan for Retirees are collected from participants and deposited by Fidelity into a trust account with Mellon for the benefit of the Health Plan for Retirees. The trust account is at all times subject to the condition that the assets are held for the exclusive purpose of providing benefits to the participants in the Health Plan for Retirees and their beneficiaries.

**Funding policy** – The Health Plan is funded by participants' contributions held in a custodial trust and also assets held in the 401(h) Account. There were no contributions made by the Company to the 401(h) Account during the year ended December 31, 2024, and there were no minimum contributions by the Company required at December 31, 2024 and 2023.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation** – The Health Plan's investments, including its interest in the net assets of the 401(h) Account, which has an interest in the Master Trust, are stated at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

**Income recognition** – The Health Plan's interest in the investment gain, including net realized and unrealized gains/losses, of the Master Trust, is reported as one amount under "Beneficial interest in investment gain of the Master Trust" on the statement of changes in net assets available for benefits. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Cash and investments denominated in foreign currencies included in the Master Trust are translated into U.S. dollars at current exchange rates. Dividend and interest income and realized and unrealized gains and losses from such cash and investments are translated using historical exchange rates at the settlement date. Exchange gains and losses on dividend and interest income, realized and unrealized exchange gains and losses on foreign denominated cash and investments are included in beneficial interest in investment gain the Master Trust.

**Interest-bearing cash** – The Health Plan maintains its cash in an interest-bearing cash account with Mellon. The recorded carrying amount of interest-bearing cash approximates its fair value. The Company has determined that its investment in this interest bearing cash account of approximately \$56,000 and \$54,000 as of December 31, 2024 and 2023, respectively, is included in the Statement of Net Assets for Benefits and is classified as Level 1 in the fair value measurements hierarchy. The Company made this determination after considering that inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Company has the ability to access.

**401(h) account** – A separate account (the 401(h) Account) has been established and maintained in the Retirement Plan to fund certain postretirement obligations for eligible retirees and their eligible dependents for the Health Plan for Retirees, KRA and RMA, in accordance with Section 401(h) of the Code. In accordance with Section 401(h) of the Code, the investments in the 401(h) Account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries under the Health Plan for Retirees, the KRA and RMA. Benefits provided under the Health Plan are primarily funded with investments of the 401(h) Account and participants' contributions.

**Payment of benefits** – Benefit payments to participants are recorded upon distribution.

**Due to plan administrator** – As of December 31, 2024, the Company paid on behalf of the Health Plan, benefit payments and insurance premiums of approximately \$227,000 and \$48,000, respectively. As of December 31, 2023, the Company paid on behalf of the Health Plan, benefit payments and insurance premiums of approximately \$270,000 and \$56,000, respectively. The benefit payments and insurance premiums have been recorded as due to the Health Plan administrator on the statements of net assets available for benefits at December 31, 2024 and 2023.

**Subsequent events** – The Health Plan has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued.

**Reclassification** – Certain amounts from the prior year summary of the net assets held in the Master Trust have been reclassified in order to conform to the current year presentation.

### Note 3 – Plan Benefits

The Health Plan for Retirees is comprised of two separate programs: The Pre-Medicare Medical Plan (self-funded) and the Alternative Health Care Options (HMOs) offered by the Company. Furthermore, effective August 1, 2015, the Health Plan for Retirees was closed to new entrants who did not meet the eligibility requirements at some time on or after August 1, 2014, and before August 1, 2015.

*Self-insured health care benefits* – The Pre-Medicare Medical Plan provides for reimbursement of certain medical and prescription drug expenses incurred by eligible retirees, totally disabled former employees and their eligible dependents, and eligible dependents of deceased Electronic Measurement Group (EMG) employees or deceased EMG members who died prior to January 1, 2009, if such individuals are not eligible for and/or enrolled in Medicare Part A and/or Part B.

*Other benefits* – The Alternative Health Care Options are fully insured health maintenance organizations (HMOs) with Kaiser. The Health Plan pays monthly premiums to the HMOs and the HMOs provide services to the participants who have elected this option. Payment of all benefits is made by the related insurance companies. Participants are also required to pay monthly contributions to the Health Plan in order to receive these benefits. The terms of coverage under HMOs are determined in accordance with the provisions of each HMO. An individual must be eligible to otherwise participate under the terms of the Pre-Medicare Medical Plan in order to participate in an HMO offered by the Company.

*Participant contributions* – In addition to deductibles and copayments, participants pay monthly premium amounts based on their respective benefit elections, for the Health Plan for Retirees. The costs of the postretirement benefits are shared by the Company and participants.

For KRA and RMA benefits, participants are eligible if they're not eligible under the Agilent Technologies, Inc. Retiree Medical Account Plan (the Agilent RMA), or the Agilent Technologies, Inc. Reimbursement Arrangement Plan (the ARA). The RMA and KRA also have eligibility provisions by various groups and participants should refer to the applicable plan documents for further details for eligibility into the various benefits.

The KRA benefits provide for reimbursement up to a specified monthly amount of eligible health insurance premium costs incurred by participants and their eligible spouse or domestic partner.

The reimbursement of eligible health insurance premium costs incurred by participants and their eligible spouse or domestic partner is limited to a monthly amount based on the participants' years of full-time equivalent service. Any monthly amount not entirely used by a participant in a particular month carries over to the next month within the same calendar year. Unused amounts at the end of the same calendar year will not carry over from year-to-year.

The RMA benefits provide for reimbursement up to a specified amount of eligible health insurance premium costs incurred by participants and their eligible spouse.

The reimbursement of eligible health insurance premium costs incurred by participants and their eligible spouse is limited to a specified amount. Any amount not entirely used by a participant is carried forward from year to year until it is exhausted or otherwise terminated in accordance with the RMA provisions.

**Claims incurred but not paid** – Health Plan obligations at December 31, 2024 and 2023, for claims incurred by participants but not paid at that date, are estimated by the Health Plan's actuary in accordance with accepted actuarial principles. The actuarial computations are based on historical payments and claim statistics. Estimated amounts reported are subject to change over time and these changes could have a material impact on the Health Plan's financial statements.

**Postretirement benefits** – The postretirement benefit obligation is based on actuarial assumptions that are subject to change over time and could have a material impact on the Health Plan's financial statements. As a result of the Health Plan only reimbursing certain medical and prescription drug expenses incurred by the participants up to predetermined levels. The effects of health care cost trends are included in calculating this obligation.

The postretirement benefit obligation represents the actuarial present value of those estimated future fixed monthly subsidy benefits that are attributed to employees' service rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid on behalf of: (1) currently retired employees and their eligible dependents prior to their turning age 65 and (2) active employees and their eligible dependents after retirement from service with the Company and certain related entities and prior to their turning age 65. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the 401(h) Account.

The actuary determines the actuarial present value of the postretirement benefit obligations by discounting pre-65 fixed monthly subsidy amounts for the time value of money, and the probability of payment between the valuation date and the expected date of payment.

#### **Note 6 – Master Trust**

The Master Trust was established on August 1, 2014, to hold substantially all of the Retirement Plan's assets (including those of the 401(h) Account) and the assets of the Keysight Technologies, Inc. Deferred Profit-Sharing Plan.

The Master Trust was established to achieve certain economies in the management of investments and to maximize the return on investments of participating plans. Each participating plan has a proportional interest in the Master Trust, as more fully described below. Assets of the Master Trust are invested by investment managers in accordance with guidelines established by the Committee.

Within the Master Trust, investments are segregated into investment pools based on the ownership and investment objectives of each participating plan. Three types of investment pools have been established in the Master Trust based on the principal types of investments held: an Equity pool, a Fixed Income pool, and a TIP pool. Each participating plan in the Master Trust has a proportional interest in each one of these pools. Within each of these pools, the net assets allocable to each plan are separately accounted for by Mellon. The net investment income (loss) of each investment pool is allocated monthly by Mellon between each of the participating plans based on their relative ownership of the net assets of that pool at the beginning of the month.

The 401(h) Account's allocated interest in the net assets of the Master Trust at December 31, 2024 and 2023, was approximately \$167,642,000 (17%) and \$166,880,000 (16%), respectively.

#### **Note 7 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

**Level 1** –Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Health Plan has the ability to access.

**Level 2** –Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** –Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Collective trusts* – Units held in collective trusts (CTs) are valued using the net asset value (NAV) practical expedient of the CT as reported by the CT managers. The NAV is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CT is calculated based on a compilation of primarily observable market information. There are no redemption restrictions on the Health Plan's investments in CTs.

The Master Trust has a significant investment in the Ninety One Emerging Markets Equity Fund that is not a direct filing entity. The Fund's investment objective is to achieve long term capital growth through primarily investment in equity securities issued by companies or equity-related securities of companies established and/ or listed on an exchange in emerging markets, or companies which are established and/or listed on exchanges outside emerging markets but which carry out a significant portion of their economic activity in emerging markets.

*Pooled separate accounts* – Units held in pooled separate accounts (PSAs) are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

The Master Trust has a significant investment in the PRISA Core RE fund that is not a direct filing entity. The PSA seeks to provide capital appreciation and income by investing primarily in domestic real estate securities.

*Partnership/joint venture* – Units held in the Wellington Trust Company, NA CIF II Multi Sector Credit II Portfolio (the fund) are valued using the NAV practical expedient of the fund as reported by the portfolio managers. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding.

*Preferred stocks, corporate debt instruments, U.S. government securities, and other investments (municipal bonds and interest-bearing cash)* – Valued using the market approach based on quoted exchange rates or at the last settlement price at the end of each day on the board of trade or exchange upon which they are traded. When active market quotes are not available, the Company uses industry standard valuation models. Where applicable, these models project future cash flows and discount the future amounts to a present value using market-based observable inputs including interest rate curves, credit risk, foreign exchange rates, and forward and spot prices for currencies.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Health Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 8 – Financial Instruments with Off-Balance Sheet Risk

In the normal course of operations, assets in the Master Trust are invested in financial instruments that may give rise to off-balance sheet risk. These instruments involve, in varying degrees, elements of credit and market risk in excess of the amounts recognized on the statements of net assets available for benefits. The notional value provides a measure of the Master Trust's involvement in such instruments but is not indicative of potential loss. The intent is to use these financial instruments to reduce, rather than increase, market risk. There were no significant off-balance sheet risks as of December 31, 2024 and 2023.

#### Note 9 – Tax Status

The custodial trust funding the Health Plan has not received an exemption letter from the Internal Revenue Service (IRS) stating that it is tax-exempt under Section 501(a) of the Code. The Health Plan administrator believes the Health Plan and the custodial trust are operating in conformity with the Code and ERISA. Income tax obligations, if any, are paid by the Company.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Health Plan's tax positions and does not believe the Health Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Health Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 10 – Risks and Uncertainties

The Master Trust provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 11 – Party-In-Interest Transactions

Certain Plan investments held in the Master Trust are managed by the custodian of the Health Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Health Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### Note 12 – Reconciliation to Form 5500

The differences between the financial statements of the Health Plan and the Form 5500 are a result of the 401(h) account net assets and change in net asset activity included in the financial statements but not in the Form 5500.
