### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Cactus Wellhead, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report;

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### 1. Description of the Plan

The following description of the Cactus Wellhead, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement and summary plan description for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a qualified defined contribution plan, sponsored and established by Cactus Wellhead, LLC (the “Employer” or “Plan Administrator”), effective August 15, 2011, for the benefit of its eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### *Eligibility*

Employees are eligible to become a participant in the Plan on the first day of the month following attainment of age 18 provided that such employees are not a) non-resident aliens, b) bona fide residents of or employees performing services in Puerto Rico or c) temporary employees whose regularly scheduled service is less than 1,000 hours of service in the relevant eligibility computation period, as all such employees are ineligible from participating in the Plan. Effective August 15, 2025, the Plan was retrospectively amended to allow non-resident aliens to contribute to the Plan.

#### *Trustee and Administration of the Plan*

For the period from January 1, 2023 through October 20, 2023, Prudential Bank & Trust, FSB and Prudential Retirement Insurance and Annuity Company (collectively “Prudential”) served as the Plan’s investment trustees, and Prudential Retirement Insurance and Annuity Company served as the recordkeeper. Effective October 21, 2023, Empower Trust Company, LLC (“Empower”) was appointed as the Plan’s investment trustee and recordkeeper.

The Retirement Plan Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### *Transfer from Other Qualified Plan*

Effective March 2024, the Plan merged in outstanding loans of \$285,896 which relate to a prior year Plan merger.

#### *Contributions*

The plan agreement permits eligible participants, through a salary deferral election, to defer up to 85% of their compensation as contributions to the Plan. A participant may elect to have all or a portion of his or her elective deferrals to be either pre-tax or after-tax (as Roth elective deferrals) when contributed to the Plan. The Employer makes matching contributions equal to 100% of the first 3% and 50% of the next 4% of eligible compensation deferred by the participant, as defined by the plan agreement. The Employer may also make additional discretionary non-elective employer contributions at its discretion, as described in the plan agreement. The Employer made no discretionary non-elective employer contributions for the year ended December 31, 2024.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Contributions are subject to certain Internal Revenue Service (“IRS”) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 10%.

### ***Participant Accounts***

Participant accounts are credited with a) participant salary deferral contributions, b) rollover contributions, c) employer matching contributions, d) discretionary non-elective employer contributions, if any, e) earnings/losses, and f) allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may change their investment options daily.

### ***Vesting***

Participants are 100% vested in their individual deferral, after-tax, and rollover contributions and the allocated earnings thereon.

Participants vest in employer matching and discretionary non-elective contributions based upon years of continuous service. A participant vests 20% after each year and is 100% vested after five years of credited service. This vesting schedule is applied prospectively.

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

### ***Payment of Benefits***

Benefits are generally paid upon normal retirement, death, disability or termination of employment. Upon normal retirement, disability or death, a participant is entitled to receive 100% of his or her account balance. Under the plan agreement, normal retirement is defined as age 65. Upon termination, a participant is entitled to receive the vested portion of his or her account balance. Benefits are paid in lump-sums, substantially equal installments, or partial withdrawals as defined in the plan agreement. In certain circumstances, in-service withdrawals are allowed subject to a 10% penalty tax for participants under age 59½. For participants who have reached age 59½, there is no penalty tax on in-service withdrawals. Financial hardship withdrawals are permitted, as defined in the plan agreement.

### ***Notes Receivable from Participants***

Participants are allowed to borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance less their highest outstanding note amount during the prior twelve months. The notes are secured by the balance in the participants' vested accounts and must be paid within one to five years. Repayments can be for longer periods up to 15 years if the note is used for the purchase of the participant's primary residence. Principal and interest are paid ratably through payroll deductions. Notes receivable bear an interest rate at the prime rate plus 2% or at local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code ("IRC").

Also, each participant may not have more than two loans outstanding at any time.

### *Forfeitures*

Forfeitures, if any, will be used to reduce employer matching contributions and/or discretionary non-elective employer contributions, or to pay plan expenses. At December 31, 2024 and 2023, forfeited unallocated accounts totaled \$80,904 and \$39,168, respectively. During the year ended December 31, 2024, the Plan used \$516 of forfeitures to reduce employer contributions. No forfeitures were used to pay for plan expenses during the year ended December 31, 2024.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by its investment advisers. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The guaranteed income fund is a traditional guaranteed investment contract backed by the general account of the issuer. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan deposited a lump sum with the issuer and received a guaranteed interest rate for a specified time. Interest was accrued on either a simple interest or fully compounded basis and paid either periodically or at the end of the contract term. The issuer guarantees that all qualified participant withdrawals will occur at contract value (principal plus accrued interest). The contract value approximates fair value. See Note 4.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan agreement.

### *Administrative Expenses*

The Plan's expenses are paid either by the Plan or the Employer, as provided by the plan agreement. Expenses that are paid directly by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other participant-directed expenses are charged directly to the participant's account and are included in expenses of the Plan. Investment related expenses are included in net appreciation or depreciation.

### **3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustees, which are qualified institutions.

### **4. Guaranteed Income Fund**

The Plan's investment in the Guaranteed Income Fund ("GIF") is an evergreen group annuity contract issued by Prudential, which is a fully benefit-responsive investment. Contract value represents net contributions plus interest at the contract rate, less funds used to purchase annuities and pay administrative expenses by Prudential. The issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The GIF's interest rates are adjusted to market semiannually.

The minimum crediting rate under the GIF contract is 2.08% for the year 2024. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guarantee is based on Prudential's ability to meet its financial obligations from its general assets. Prudential's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events that might limit the ability of the Plan to transact at contract value with the contract issuer include the following:

- Plan termination of the contract;
- Plan termination or merger;
- Company layoffs;
- Company mergers; and
- Bankruptcy of the Employer.

In the case of these events, Prudential reserves the right to settle within 90 days or over time as specified in the group annuity contract. The Plan has made no such plans for the near future. No events are considered probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The contract includes a pool transfer limitation (the deferral provision). Prudential has the contractual right to defer a transfer or distribution. If total distributions and transfers from the contract's pool exceed 10% of the pool's balance as of January 1 in any one calendar year, the distribution or transfer may be deferred by Prudential. During a deferral provision, any amount deferred will continue to receive credited interest. Retirement, termination, death or disability distributions, hardship withdrawals, and distributions required by IRC section 401(a)(9) payable from the guaranteed income fund will be paid and not deferred. The deferral provision was not invoked in 2024.

### 5. Fair Value Measurements

The Plan measures fair value in accordance with Accounting Standards Codification ("ASC") 820 which defines fair value as the price that would be received in the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. ASC 820 requires disclosure of the extent to which fair value is used to measure financial and non-financial assets and liabilities, the inputs utilized in calculating valuation measurements, and the effect of the measurement of significant unobservable inputs on earnings, or changes in net assets, as of the measurement date.

ASC 820 establishes a three-level valuation hierarchy based upon the transparency of inputs utilized in the measurement and valuation of financial assets or liabilities as of the measurement date:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds:** The fair values of mutual funds are determined based on quoted market prices ("fair value") on the last business day of the plan year as reported by the trustees.
- **Pooled Separate Account:** These investments consist of insurance company separate accounts whose investors include only qualified retirement plans and certain governmental retirement plans. The value of each pooled separate account is determined at the close of each business day based on the fair value of the underlying assets, which can consist of a single mutual fund or multiple securities. The value of the account is expressed as the NAV. The unit value is the dollar value of one unit and is

determined at the close of each business day by dividing the fair value of the entire account by the total number of units in the account. Contributions to the account increase the number of units. Withdrawals from the account decrease the number of units. The increase or decrease in number of units is determined by dividing the amount of the contribution or withdrawal by the unit value for the day the transaction is made. As these assets are measured at net asset value, they are therefore excluded from the fair value hierarchy and included in other.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

## 6. Plan Termination

Although the Employer has not expressed any intent to do so, it may terminate the Plan at any time, subject to the provisions of ERISA. In the event of a plan termination or partial plan termination, affected participants will become 100% vested in their accounts.

### 7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Empower. Participant loan and distribution processing fees are paid to Empower by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 8. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Empower. Empower received an opinion letter from the IRS, dated September 16, 2022, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and participant account balances.

### 10. Delinquent Participant Contributions

For the year ended December 31, 2023, the Plan Administrator determined that certain participant contributions totaling \$2,334 had not been remitted to the Plan in a timely manner under DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures were taken. The aggregate amount of 2023 delinquent remittances, including the related lost earnings, were funded during 2024.

### 11. Subsequent Events

The Plan Administrator has evaluated all events and transactions through September 26, 2025, the date the financial statements were available to be issued.
