Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lighting Retrofit International, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

(1) Description of Plan

The following brief description of the Lighting Retrofit International, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Lighting Retrofit International, LLC and its affiliates (the Company), except for employees covered by a collective bargaining agreement, leased employees, nonresident aliens, and persons engaged as independent contractors or as specific project workers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Directors are responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees must complete 6 months of employment to gain eligibility. Employees may enter the Plan on the first day in which the employee becomes a member subsequent to satisfying the eligibility requirements.

Contributions

Participants may contribute up to the maximum amount allowed by law as pre-tax or Roth elective deferrals, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company contributes a safe harbor match, for each non-highly compensated employee, based on 100% of the participants' elective deferral up to 3% of the participant's eligible compensation and 50% of the participant's elective deferral on the next 2% of the participant's eligible compensation. Effective September 1, 2024, the Company elected to suspend the remaining safe harbor matching contributions for the 2024 plan year. Effective January 1, 2025, the Company reinstated the safe harbor matching contribution for 2025 plan year. The Company may also make discretionary matching, profit sharing and qualified non-elective employer contributions to the Plan. There were no discretionary matching, profit sharing or qualified non-elective employer contributions for 2024.

(1) Description of Plan, Continued

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as allocations of plan earnings and losses. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participating earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, safe harbor matching employer contributions, qualified non-elective contributions, and qualified matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions is based upon years of credited service. A participant is 20% vested after two years of credited service with the remaining 80% vested ratably over the next four years of credited service.

Participants automatically become fully vested when they reach normal retirement age while employed, meet the age and service requirement(s) for early retirement, or terminate employment due to total disability or death.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts may be used to pay administrative expenses or to reduce future employer contributions. During 2024, no forfeitures were used to pay administrative expenses or reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, and the combined maximum loans outstanding may not exceed the lesser of 50% of the participant's vested account balance or \$50,000. Loan terms range from 1 to 5 years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime interest rate plus one percent, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

Benefits

Benefits are payable upon retirement at age 65, death, disability or termination of employment. Hardship withdrawals, qualified reservist withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Benefits are payable in lump sum and installment payments.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

(3) Investment Information Certified by a Qualified Institution

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year), including investments in fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Principal), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology on adjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract with Principal through its investment in the Principal Fixed Income Guaranteed Option totaling \$514,766 and \$14,218 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is 4.75% at December 31, 2024. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(7) Tax Status

The Plan is based on a volume submitter plan document sponsored by MandMarblestone PC. The Internal Revenue Service (IRS) determined and informed MandMarblestone PC by a letter dated June 30, 2020 that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting policies generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies, common collective trust funds and an investment contract managed by Principal. Principal is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

(9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that, such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(10) Prohibited Transactions

During 2024, 2023, and 2022, the Company failed to remit to the Plan's trustee certain employee contributions totaling approximately \$2,715, \$652, and \$9,930, respectively, within the period prescribed by DOL regulations. These delinquent contributions are considered prohibited transactions as defined by ERISA. The Company corrected the 2024, 2023, and 2022 delinquent contributions during 2024, with the exception of the June 2024 delinquent contribution, which will be corrected in 2025.
