**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Carrier Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Carrier Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering certain employees of Carrier Global Corporation (“Company,” “Employer,” or “Sponsor”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan was established April 3, 2020 as a result of the spin-off of the Company from United Technologies Corporation (“UTC”). Special rules apply to employees who were eligible participants of the United Technologies Corporation Employee Savings Plan or the United Technologies Corporation Represented Employee Savings Plan (“UTC Plans”) immediately before the spin-off and who were eligible Company employees on April 3, 2020. Employees are generally eligible to participate in the Plan as soon as administratively feasible after completing an hour of service.

During 2024, the Sponsor completed five divestiture transactions in alignment with an ongoing portfolio transformation covering approximately 1,900 Plan participants. Upon the applicable divestiture, affected participants became immediately vested in their Company matching and retirement contributions.

***Contributions***

Each year participants may make pre-tax, Roth, and/or after-tax contributions of their eligible compensation, subject to applicable limits established by law. Under certain circumstances, an eligible participant may make a rollover contribution to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an automatic enrollment and deferral feature, except for certain collectively bargained employees. Accordingly, the Employer will automatically withhold certain percentages. The automatic contribution rate increases annually, unless the participant chooses a different election percentage.

The Company makes a matching contribution of 60% of participant contributions up to 6% of eligible compensation or as defined in an applicable collective bargaining agreement. The Company also makes a retirement contribution for eligible employees, ranging from 3% to 8% of a participant’s eligible compensation, contingent upon the assigned division and union affiliation. The retirement contribution is made irrespective of whether the Company recognizes a profit and whether the participant makes an elective or after-tax contribution. Company matching contributions were approximately \$35,000,000 and Company retirement contributions were approximately \$56,900,000 for the year ended December 31, 2024.

***Participant Accounts***

Participant accounts are credited with the participant contributions (elective deferral, after-tax, catch-up, Roth, and rollover) and allocations of the Company’s contributions and Plan earnings or losses and charged with the participant’s benefit payments and an allocation of administrative expenses. Allocations are based on the earnings and losses of the participant’s investments or participant account balances, as defined. Income is allocated daily based on the number of shares in the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### NOTES TO FINANCIAL STATEMENTS - CONTINUED

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts from \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, excluding Company retirement contributions, whichever is less. Loan terms range from one to 60 months. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate at the time of the loan, generally 1% above prime. Principal and interest are paid ratably through payroll deductions. Only one loan per participant may be outstanding at a time.

#### ***Vesting***

Participants' contributions are fully vested upon contribution. Company matching and retirement contributions are generally fully vested upon the completion of two years of service, the participant obtaining a normal retirement age, early retirement, disability date, the participant's death, the participant being laid off, or joining the military, whichever comes first.

#### ***Forfeitures***

Forfeitures are used to pay administrative expenses first, then may be used to reduce future Company contributions, if applicable. The Company utilized forfeitures of approximately \$1,826,334 to pay administrative expenses during the year ended December 31, 2024. As of December 31, 2024 and 2023, the Plan had unallocated forfeitures of approximately \$334,075 and \$252,825, respectively.

#### ***Payment of Benefits***

Upon separation of employment due to termination of employment, death, disability or retirement, participants may, at their election, withdraw their benefits as a lump sum or partial payment or maintain their vested balance in the Plan. Terminated participants who are at least 55 years of age and who have five years of service may also choose annual, monthly, or quarterly installments for two to 20 years. Participants who invest in the lifetime income strategy investment option and who are at least age 60 and have terminated employment may elect a lifetime income benefit which is calculated as an age 65 single or joint life income benefit. Participants who have attained the age of 73 receive distributions in accordance with the Internal Revenue Service ("IRS") minimum required distribution rules.

If the value of a separated participant's vested balance is less than \$1,000, vested portions will be distributed to the participant in a lump sum payment. Participants are permitted withdrawals from their Plan accounts for financial hardships and upon reaching age 59½.

#### ***Plan Termination***

While the Plan Sponsor has not expressed any intent to discontinue the Plan, the Plan Sponsor reserves the right to amend or terminate the Plan at any time. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements are presented in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") and were prepared using the accrual basis of accounting.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan agreement.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Reasonable expenses of the Plan, including trustee, attorneys, advisors, actuaries, fiduciaries and service providers are to be paid by the Plan. Certain Plan administrative expenses are paid in whole or in part by the Company. Expenses fully paid by the Company are excluded from the financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### **NOTE 3 - CERTIFIED INFORMATION**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank & Trust Company and AllianceBernstein Trust Company have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

*Collective Trust Funds and Pooled Separate Account* - Valued at the net asset value (“NAV”) of units held, based upon the fair value of the underlying investments less liabilities. The NAV is used as a practical expedient to estimate fair value. There are no unfunded commitments or redemption restrictions for the collective trusts, with the exception of the AllianceBernstein AB Balanced 60/40 Collective Trust, in the amount of approximately \$101,900,000 and \$77,600,000 as of December 31, 2024 and 2023, respectively, which requires a 180 day notice prior to total withdrawal. The investment objective of the AllianceBernstein AB Balanced 60/40 Collective Trust is long-term growth of capital by investing in underlying collective trusts which represent a variety of asset classes and investment styles. The Voya Stable Value Fund pooled separate account has a 30 day notice requirement prior to terminating the contract.

**NOTE 5 - INCOME TAX STATUS**

The Plan obtained a determination letter on December 21, 2021, in which the Internal Revenue Service ("IRS") states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since receiving the letter; however, management believes the plan is being operated in accordance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
