Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Corporate Mailings, Inc. 401(k) Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to, or derived from, the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- The information in the accompanying financial statements related to assets held by, and certified to by, a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The Corporate Mailings, Inc. 401(k) Profit Sharing Plan (Plan) is administered by Corporate Mailings, Inc. (Company, Plan Sponsor). The Plan was established on March 1, 1977. The following summary provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan containing a cash or deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code. The Plan is subject to, and complies with, the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan when they are 21 years of age and have completed six months of service. Employees who are covered by a collective bargaining agreement are excluded from participation. An employee becomes a participant in the Plan when they have satisfied the age and service requirements.

Employee Contributions

Eligible employees may elect to reduce their compensation by a specific percentage or dollar amount as salary deferrals up to the applicable limit by law. Employees may elect to make either pretax 401(k) deferrals or Roth 401(k) deferrals. If an employee is at least 50 years of age, they are eligible to make catch-up contributions in accordance with, and subject to, certain statutory limitations.

Employees are permitted to roll over, into the Plan, distributions they have received from other retirement plans and certain IRAs at the Plan Administrator's discretion. Participants are 100% vested in their rollovers and may withdraw amounts from their rollover account at any time.

Employer Contributions

The Company may make a discretionary matching contribution equal to a percentage of the participants' salary deferrals. The Company will determine the amount of this discretionary percentage annually. Total matching contributions for the Plan years ended December 31, 2024 and 2023 were \$154,912 and \$141,416, respectively.

The Company may also make a discretionary profit-sharing contribution to the Plan. In order for any employee to receive the profit-sharing contribution, they must be employed on the last day of the year and have completed one year of service. The profit-sharing contribution will be allocated among eligible participants based on their employee compensation compared to the total compensation of all eligible participants. There was no discretionary profit sharing contribution made during the Plan years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participants direct the investment of their contributions and discretionary contributions into various investment options offered by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting

Participants are immediately vested in their own elective deferrals plus earnings thereon. Vesting in the matching and profit sharing contributions is based on years of continuous service, subject to the vesting schedule. Participants become 100% vested in matching and profit-sharing contributions upon reaching normal retirement age, death, or disability. A year of service is earned when the participant works at least 1,000 hours of service.

Normal Retirement Age

A participant reaches normal retirement age upon the attainment of age 60 or completion of five years of Plan participation, if later.

Payment of Benefits

On termination of service, death, disability, or reaching normal retirement, a participant receives a lump-sum amount equal to the value of the participant's vested interest in their account; partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions. If a participant's vested balance is greater than \$5,000, receipt of distribution can be postponed until the time it is required by law to receive minimum required distributions. The mandatory distribution date is defined as the later of April 1 following the calendar year of attaining age 72 or April 1 following the termination of employment.

Participants may request in-service withdrawals under the following conditions:

- Attainment of age 59½
- Minimum required distributions for those who have reached age 72
- Hardship withdrawals

These withdrawals are subject to all conditions set forth in the Plan.

Forfeited Accounts

Upon a participant's termination of employment, except upon reaching normal retirement age, death, or disability, the nonvested portion of their account shall be forfeited. Forfeitures may first be used to pay administrative expenses and then may be used to reduce any employer contributions. During the years ended December 31, 2024 and 2023, \$15,663 and \$-0- of forfeitures were used to offset the employer-match contributions and administrative expenses, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$562 and \$15,249, respectively, and were maintained in a money market account.

Pricing Credits

The Plan receives pricing credits from the Plan's recordkeeper, which are calculated on a quarterly basis and are to be used to pay eligible Plan administrative expenses. During the year ended December 31, 2024, the Plan received \$18,511 in credits and utilized \$11,229 against Plan expenses. During the year ended December 31 2023, the Plan received \$19,543 in credits and utilized \$4,703 against Plan expenses. At December 31, 2024 and 2023, total pricing credits available in the expense account were \$23,365 and \$15,645, respectively, and were maintained in a money market account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the vested balance of their account, whichever is less, reduced by the highest outstanding principal balance of loans outstanding in the Plan over the past twelve months. No more than one loan can be taken out at a time. Loans bear a rate of interest, as determined by the Plan Administrator, based on the prevailing interest rates charged by persons in the business of lending money for notes, which would be made under similar circumstances. Participants pay a one-time loan application fee upon receipt of the loan.

Generally, loans must be repaid through payroll deductions over a maximum period of five years; however, if the loan is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term. Loans are secured by the balances in the participants' accounts.

Investments

Upon enrollment in the Plan, participants may direct their contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding deduction in the statement of changes in net assets. The Plan distributed the 2024 Plan year excess contributions to the applicable participants prior to March 15, 2025. There were no excess contributions payable during the 2023 Plan year.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Payments of Benefits

Benefits are recorded when paid.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expense. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated its subsequent events and transactions occurring after December 31, 2024 through September 25, 2025, the date that the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from information certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value, that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Common Trust Fund: Valued at daily net asset value (NAV) of units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by T. Rowe Price Trust Company, the recordkeeper for the Plan, and Reliance Trust Company, the custodian for the Plan; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from Plan participants qualify as party-in-interest transactions.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 7 INCOME TAX STATUS

The Plan Sponsor adopted a non-standardized prototype plan, which received an IRS opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended and restated, however, the Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
