### **Opinion**

We have audited the accompanying financial statements of BancTenn Corp. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



# Notes to Financial Statements

## NOTE 1. DESCRIPTION OF PLAN

The following brief description of the BancTenn Corp. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

BancTenn Corp. (the "Company" and the "employer") established the Plan effective as of January 1, 2004. The Plan operates as a leveraged employee stock ownership plan ("ESOP"), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended ("the Code"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by an ESOP Plan Committee appointed by the Company's Board of Directors, which consists of four individuals. The Plan Trustees consist of two individuals appointed by the Company's Board of Directors.

The Plan purchased 78,408 shares of Company common shares using the proceeds of loans totaling \$2,930,040 from the Company, along with 13,909 shares of Company common shares using available cash and holds the stock in a trust established under the Plan. The shares were purchased at prices ranging from \$32.15 to \$67.75 per share, for an aggregate purchase price of \$3,621,119. The loans are generally to be repaid over a period of ten years by fully deductible company contributions to the trust fund. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible participants' accounts in accordance with applicable regulations under the Code.

Outstanding borrowings are collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- (a) the accounts of employees with vested rights in allocated stock ("Allocated") and
- (b) stock not yet allocated to employees ("Unallocated").

At December 31, 2024 and 2023 no loans were outstanding and there were no unallocated shares.

### Eligibility

Employees of the Company and its participating subsidiary are generally eligible to participate in the Plan after one year of service provided they worked at least 1,000 hours during such plan year. Participants who do not have at least 1,000 hours of service during such plan year are generally not eligible for an allocation of company contributions for such year.

### Contributions

The Company is obligated to make contributions in cash, shares of Company stock, or a combination of both as determined by the Company's Board of Directors to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on any of its term loans. Employee contributions are not permitted.

In accordance with ASC 326, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer contribution receivable, if any, has never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

### Payment of Benefits

Distributions on account of death, disability, or retirement are made in a lump sum in the Plan year following the event for accounts of \$10,000 or less. For accounts exceeding \$10,000, payments are made in substantially equal annual installments over five years. For other types of termination of service, payments begin as soon as administratively feasible after the close of the plan year in which the participant's employment terminates. For accounts of \$10,000 or less, lump sum payments will be made. As of December 31, 2024, vested balances of terminated employees totaled \$2,086,825.

## **NOTE 1. DESCRIPTION OF PLAN (CONTINUED)**

### **Payment of Benefits (Continued)**

Distributions may be made in the form of cash or in the form of Company common shares plus cash for any fractional share. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. During 2024, the Company repurchased from participants 8,740.41 shares at a price determined from an independent appraisal.

### **Voting Rights**

The Trustees receive instructions from the ESOP Plan Committee, and all Company stock held by the Trust is voted by the Trustees in accordance with instructions from the ESOP Plan Committee. Notwithstanding the foregoing, the participant shall be entitled to direct the voting of any shares of Company stock allocated to the participant's Company stock account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of the Company.

### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustees from the unallocated account and forfeitures of terminated participants' non vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

### **Vesting**

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest 20 percent per year of service and are 100 percent vested after five years of service. A year of credited service is earned for each year in which at least 1,000 hours of service have been performed for the employer.

### **Put Option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants that is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

### **Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during December 31, 2024, totaled \$3,619. Forfeited non-vested accounts to be allocated to the participant accounts in future years were not material for the years ended December 31, 2024 and 2023, respectively.

## **NOTE 1. DESCRIPTION OF PLAN (CONTINUED)**

### **Administration**

The Plan's assets are held by the Trustees of the Plan. Certain administrative functions are performed by officers or employees of the Company or its subsidiary. No such officer or employee receives compensation from the Plan. Under the terms of the Plan, administrative expenses may be paid by the Company. If not paid by the Company, administrative expenses shall be paid by the Plan.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### **Allocations**

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

### **Investment Valuation and Income Recognition**

The shares of Company common stock are reported at fair value. See Note 8 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Management performed an evaluation of subsequent events through September 17, 2025, the date these financial statements were available to be issued.

## **NOTE 3. TAX STATUS OF THE PLAN**

The Plan has received a determination letter on August 24, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no tax audits in progress.

#### NOTE 4. PLAN TERMINATION PROVISIONS

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the ESOP Plan Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code.

#### NOTE 6. RISKS AND UNCERTAINTIES

The Plan's investments consist primarily of Company common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### NOTE 7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company stock and at times has indebtedness guaranteed by the Company. The Plan also has a money market account with Bank of Tennessee (the "Bank"). The Company is the plan sponsor, and the Bank is a wholly owned subsidiary of the Company and therefore, these transactions qualify as related party and party-in-interest transactions. In addition, Menke & Associates provided recordkeeping services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for recordkeeping services are included in administrative expenses.

#### NOTE 8. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTE 8. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*BancTenn Corp. common stock:* The fair value of the sponsor Company common stock held by the Plan is determined based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves the selection of an appraiser under contract for a one-year term. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. The valuation report is reviewed and approved by the ESOP Plan Committee.

*Interest-bearing cash:* Carrying amount approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
