Independent Auditors' Report

To the Plan Administrator and Participants of
Greeneville Oil & Petroleum, Inc. 401 (k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Greeneville Oil & Petroleum, Inc. 401 (k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Basis for Opinion

Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Greenville Oil & Petroleum, Inc. 401 (k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a contributory, defined contribution plan that covers employees of Greenville Oil & Petroleum, Inc., (the “Company”). The Plan covers all employees of the Company who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions - Each year, participants may contribute up to the maximum allowable limits set by the Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary contribution. The Company did not make a discretionary contribution for the years ended 2024 and 2023. Contributions are subject to certain limitations. The Plan allows participants to make rollover contributions from other qualified defined benefit or contribution plans. Contributions are subject to certain limitations.

The Company makes safe harbor matching contributions equal to 100% of the employee’s salary deferral that do not exceed 3% of the employee’s compensation plus 50% of the employee’s salary deferrals between 3% and 5% of the employee’s compensation. These safe harbor matching contributions are invested in the options in accordance with the investment election percentages selected by the participant.

Participant Accounts - Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related Company discretionary contributions, as well as an allocation of Plan earnings. Allocations of income and administrative expenses are based on the participant’s account balance in proportion to the total fund balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account balance.

Vesting - Participants are always vested in the amount of participant contributions and Company safe harbor matching contributions and earnings thereon. Vesting in Company contributions and related earnings is based on years of service with the Company, in accordance with the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at rates of 4.25% to 9.50%, which are commensurate with prime plus one percent. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits - On retirement, death, disability, or termination of service, a participant (or participant’s beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant’s vested account balance. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Forfeited Accounts - Forfeited Accounts can be used to reduce Company contributions or to offset administrative expenses of the Plan. Forfeitures of \$4,938 and \$- were used to reduce employer contributions for the years ending December 31, 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$1,081 and \$5,899, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the modified cash basis, which is a comprehensive basis of accounting other than that which is generally accepted in the United States of America. Under this basis, investment assets are reported at fair value, net realized and unrealized appreciation in fair value of investments is recognized, contributions are recognized when received rather than when due, and benefits and expenses are recognized when paid rather than as incurred.

Management Estimates - The preparation of financial statements in conformity with modified cash basis requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Date of Management's Review - Management has evaluated subsequent events subsequent to the statement of net assets available for benefits for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through September 17, 2025, which is the date these financial statements were available to be issued.

NOTE 3 - TRUSTEE CERTIFICATION

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as to complete and accurate by the trustees.

Investments are currently held by Empower in a combination of mutual funds. Upon enrollment in the Plan, a participant may direct employee contributions in any of the available investment options. These funds are credited with the actual earnings of the underlying investments and charged for Plan withdrawals and expenses. All investment earnings are from mutual funds.

The Plan participates in a benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The average yield and crediting interest rates were approximately 1.4 and 1.2 percent for the reporting years.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents, (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants is probable.

NOTE 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Empower manages Plan investments including shares of money market and pooled separate accounts. Also, Empower is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Other parties in interest include any person providing services to the Plan including the investment advisor, Osaic Advisory Services LLC, Contract Administrator, Erisa Services Inc., and the auditor of the Plan, ClearPoint CPAs PC.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

NOTE 7 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

NOTE 7 - FAIR VALUE MEASUREMENTS (Continued)

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the period presented.

Level 1 Fair Value Measurements - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

NOTE 8 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 1, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax exempt.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 740, Income Taxes.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.
