Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about McFarlane Incentive Savings and Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of Schedule of Assets Held for Investment Purposes, as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The accounting records of the Plan are maintained on the accrual basis and presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Cash Equivalents - The Plan considers all investments with original maturities of three months or less to be cash equivalents.

Investment Valuation – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan’s valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Interest and Dividend Income - Interest and dividend income are recorded when earned during the fiscal year.

Purchases and Sales of Securities - Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on sales of securities is based on cost. Cost is the fair value at the beginning of the Plan year or historical cost if the security was purchased during the Plan year.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in the net appreciation/depreciation of fair value of investments.

**NOTE 2 - PLAN DESCRIPTION**

The brief Plan description is provided for general information purposes only; for more complete information, the participants should refer to the Plan agreement.

The Plan is a defined contribution employee benefit plan, with employee elective contributions and employer matching and employer discretionary contributions, covering substantially all full-time employees of McFarlane Manufacturing Company, Inc. The plan was adopted on January 1, 1976 and restated effective September 1, 2015. It is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – McFarlane Manufacturing Company, Inc. employees are eligible to participate in the Plan immediately. Employees who have completed one hour and 1,000 hours during a consecutive twelve months period ending on December 31 are eligible for employer matching and discretionary contributions, respectively.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service based on the following schedule:

The vesting percentage times the employee's account balance is his or her benefit if they terminate employment.

Contributions - Participants may contribute up to the maximum percentage allowable by Internal Revenue Code Sections 401(k), 402(g), 404 and 415. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The sponsor contributed 50% and 25% of the first 6% of base compensation that a participant contributed to the Plan as matching contributions for the periods ended December 31, 2024 and 2023, respectively. Additional amounts may be contributed at the option of the Company's board of directors. All employee and employer contributions are participant directed.

Participant Accounts – Separate accounts for each participant are maintained by the Plan administrator. Deferrals and matching contributions, as elected by each participant, are credited to their account. Participants direct their deferrals to allowable investments offered by the Plan. Investment earnings are allocated to participant accounts on a daily basis based on the participants' account balance at the time of receiving the income. The net appreciation or depreciation in the fair value of investments is allocated to participants based on each account's investment balance at fair value at the beginning and at the end of the day. Participants are allowed to transfer the balances of the investments within their account between the allowable investments.

Participant Notes Receivable - Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Fund. Loan terms range from 1-30 years. The Plan Committee will establish the loan terms for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Interest rates range from 4.25% to 9.50%. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive the value of his or her account in a lump-sum distribution, receive a partial distribution or leave the balance in the plan to withdraw at a future date. Separated participants with deferred vested benefits at December 31, 2024 and 2023 were \$2,261,643 and \$2,540,372 respectively.

Forfeited Accounts – Forfeitures of employer matching and profit sharing contributions are added to the employer matching and/or employer nonselective contributions and then allocated to the remaining participant accounts and do not reduce the employer's liability for future matching or profit sharing. At December 31, 2024 and 2023, forfeited non vested accounts totaled \$13,454 and \$4,993 respectively.

Investment Options – Participants direct employee and matching contributions into a variety of mutual fund options.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs rather than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds and common trust accounts are based on quoted prices of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

The fair value of these investments are determined by pricing data provided by outside valuation service providers who generally use the mean bid/ask prices but may also use alternative observable pricing inputs including discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

*Level 3 Fair Value Measurements*

The fair value of these investments are determined by inputs to the valuation methodology that are not observable and are significant to the fair value measurement.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1, 2, or 3.

**Collective Trust Funds** - Collective trust funds are valued at NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell its investments for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Certain investments that were measured at NAV have not been classified in the fair value hierarchy table presented below. The fair value amounts presented in the table are intended to permit the reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for plan benefits.

**NOTE 5 – COLLECTIVE TRUST FUND**

The Plan offers various Wilmington Trust Funds, which are collective trust funds. This Stable Value Strategy Option (SVS) is not a traditional investment contract, and it does not have a stated minimum or maximum interest rate. The fund is commingled with the general assets of Transamerica Life Insurance Company (TLIC). Prior to January 1<sup>st</sup> and July 1<sup>st</sup>, with a minimum of 45 days' notice, the effective annual rate of interest is established for the corresponding six-month period. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. The SVS seeks to protect against any loss of principal while providing returns greater than money market funds and one-year U.S. Treasury bills. The SVS is considered fully benefit-responsive.

When the market is volatile and withdrawal requests exceed certain thresholds, Transamerica will declare a 12-month calendar-year hold period on all SVS withdrawals, regardless of the age of the contract. During this "delay period", withdrawals resulting from total or partial discontinuances and requests to remove and transfer SVS assets to another choice will be delayed for all contract holders invested in SVS until the end of the delay period. The delay period will be administered on a non-discriminatory basis and will begin for all contract holders invested in SVS on a date specified by Transamerica and will end for all contract holders on a subsequent date specified by Transamerica, but no later than 12 months after the start date of the delay period.

**NOTE 6 – ADMINISTRATIVE EXPENSES**

The Company pays all administrative expenses and participant fees not absorbed by the Plan or charged directly to participant accounts.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTION**

Certain Plan investments are managed by State Street Bank and Trust (SSBT). SSBT has appointed Transamerica Retirement Solutions (TRANSAMERICA) as its agent to provide certain necessary duties and functions on its behalf. As such, SSBT is the custodian and TRANSAMERICA is the agent of SSBT, therefore, these transactions qualify as party-in-interest transactions. Fees paid totaled \$25,059 and \$16,628 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

**NOTE 10 – AMOUNTS OWED TO PARTICIPANTS WITHDRAWING FROM THE PLAN**

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

**NOTE 11 - TAX STATUS**

The Plan has received a determination letter, dated June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
