### 1. Description of Plan

The following brief description of the Sign-Zone, LLC Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

#### **General**

The Company has a retirement plan which was established on February 1, 1995 and has been amended and restated on March 1, 2022. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code ("IRC"). The Plan sponsor, administrator, and employer is Sign-Zone, LLC (the "Company" or "Administrator"). The Plan allows other employers to adopt its provisions. The Custodian of the Plan is Minnesota Life Insurance Company (the "Custodian").

#### **Eligibility**

Employees are eligible to participate in the Plan beginning the first day of the month following the completion of 30 days of service and attaining the age of 18. However, potential participants will not be able to participate in the Plan if their employment is governed by a union contract.

#### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Additionally, participants may elect Roth 401(k) contributions of up to 100% of after-tax compensation. Upon eligibility, each employee will be enrolled into the Plan by the Administrator, automatically deferring 6% of their pretax annual compensation, with no automatic increase in deferral percentage. Employees may elect not to defer compensation in the Plan at any time or may change their percentage deferral on the first day of each month. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan has a qualified automatic contribution arrangement consisting of a safe harbor employer matching contribution equal to 100% of salary deferrals that do not exceed 1% of employee compensation plus 50% of employee salary deferrals between 1% and 6% of employee compensation.

The Company may also make a matching contribution and a profit sharing contribution at its discretion for eligible participants. The Company did not contribute a discretionary matching contribution or a profit sharing contribution during the year ending December 31, 2024.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Excluding loans for the purchase of a primary residence, loan terms range from one to five years. The Plan Administrator may permit a longer repayment term if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate which is commensurate with local prevailing rates as determined by the Plan Administrator at the loan origination. At December 31, 2024, the notes bear interest between 3.07% and 11.00% and mature at various dates through 2050. Notes receivable from participants are valued at their unpaid principal balance plus accrued interest.

#### **Participant Accounts**

Each participant's account is credited with the participant's elective deferrals, rollover contributions, the Company's safe harbor matching contribution, and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their accounts, and the contribution thereto, in various investment fund options offered by the Plan. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

### 1. Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The Company's matching contributions and profit sharing contributions are subject to a graded vesting schedule and are fully vested after five years of service. Qualified safe harbor contributions are subject to a two-year cliff vesting schedule.

#### Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan by the Company. Forfeited amounts that were used to pay Plan expenses and offset employer matching contributions during 2024 totaled approximately \$47,000. At December 31, 2024 and 2023, there was approximately \$14,000 and \$35,000, respectively, of forfeited nonvested account balances in the Plan.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

#### Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates, and the differences could be significant.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation or depreciation in fair value of investments.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Administrative Expenses

Plan administration expenses that have not been paid by the Company are paid first from the forfeitures account and secondly by the participants of the Plan on a pro-rata basis, based on account balances or the number of participants.

Other fees charged for participant loan activity and for transactions in the self-directed accounts are paid by the participant or charged directly to the participant's account. These fees are included in the net appreciation or depreciation in fair value of investments.

### 2. Summary of Significant Accounting Policies (Continued)

#### Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of financial assets and financial liabilities and for fair value measurements of nonfinancial items that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board ("FASB") fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 inputs are unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. The Plan uses valuation techniques in a consistent manner from year to year.

#### Securing Strong Retirement Act

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Most of the provisions of SECURE 2.0 became effective in 2024 and beyond. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect; however, no decision has been made as of December 31, 2024.

#### Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through September 24, 2025, the date which the financial statements were available to be issued.

### 3. Certification of Information from Plan Custodian

At the direction of the Plan Administrator, the Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurements

Pooled separate accounts are measured at fair value using the net asset value practical expedient as determined by the Custodian based on the fair value of the underlying investments of each pooled separate account, which is generally obtained by using quoted prices for similar assets in active markets, and include dividends and capital gains declared. The valuation of the underlying investments of each pooled separate account depends on the types of investments held by the pooled separate account and may be based on inputs based on other than quoted market prices.

### 5. Party-In-Interest Transactions

Certain Plan investments are pooled separate accounts managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the Custodian of the Plan; therefore, these are allowable party-in-interest transactions. Fees paid by the Plan for investment management services amounted to approximately \$56,000 for the year ended December 31, 2024.

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will continue to occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### **7. Tax Status**

The Plan adopted a defined contribution non-standardized pre-approved profit sharing plan. The Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that it is in compliance with IRS requirements. The Plan was amended since the receipt of the opinion letter. However, the Plan's Administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Due to the tax exempt status of the Plan, the Plan does not have any significant tax uncertainties that would require recognition or disclosure. The Plan is no longer subject to income tax examinations for the years before 2021.

### **8. Plan Termination**

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions and the Plan assets will be distributed according to the provisions of the Plan documents.
