### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Action Partnership of Ramsey and Washington Counties Tax Sheltered Investment Program 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the financial statements of the Plan referred to in the first paragraph. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules of assets (held at end of year) and delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

**Note 1: Description of Plan**

The following description of the Community Action Partnership of Ramsey and Washington Counties Tax Sheltered Investment Program 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Community Action Partnership of Ramsey and Washington Counties (the Employer and Plan administrator). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Employees are eligible to participate in the Plan for salary deferrals as soon as administratively feasible. Employees are eligible to participate in the Plan for Employer nonelective contributions after completing two years of service (1,000 hours each year). Carpenters' Union Employees are excluded from employer nonelective contributions. On April 1, 2023, the adoption agreement was amended and restated to include eligibility conditions to participate in employer matching contributions. Employees are eligible to receive employer matching contributions after completing 90 days of service, provided they are not carpenters' union employees.

**Contributions**

Eligible participants are permitted to elect to have up to 100% of their eligible compensation contributed as pre-tax contributions, Roth contributions, or a combination thereof, to the Plan. The Plan has an automatic enrollment provision whereby employees who become eligible and have not completed a salary deferral election will be deemed to have elected a 3% deferral election percentage unless an election to the contrary is made.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, otherwise known as rollover contributions. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain regulatory limitations.

Employer nonelective contributions were 3% of participant's eligible compensation through March 30, 2023. On April 1, 2023, the Plan was amended and restated to allow for employer nonelective contributions to be made solely with respect to any participant who is subject to a collective bargaining agreement between the Employer and certain unions, as defined by the Plan. Such participants who deferred any amount of compensation during the applicable period are eligible to receive a fixed contribution equal to 3% of compensation. Those not making salary deferrals to the Plan are eligible to receive a fixed contribution equal to 1% of compensation.

Additionally, as of April 1, 2023, employer matching contributions are allowed under the Plan for participants not subject to a collective bargaining agreement. The Employer matches 100% of employee contributions, up to 3% of eligible compensation.

Other employer contributions of \$73,834 consist of a qualified non-elective contribution incurred by the employer during the year ended December 31, 2023, and this plan error was fixed in 2024. See Note 13 for additional information.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the employer's contributions, investment earnings (and losses), changes in market values, and certain plan expenses. Allocations are based on participant earnings or account balances, as defined. Investment earnings and losses and changes in market value are allocated daily based on the shares in the participant's account. Plan expenses are allocated either directly to a participant's account for certain transactions affecting only the participant or proportionally to all participants for certain administrative expenses of the plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Vesting**

Participants are immediately vested in all of their contributions, employer matching, and nonelective employer contributions plus actual earnings thereon.

**Plan Loans**

Participants may borrow amounts from TIAA, the Plan insurance company. Plan loans may be requested by a participant, using their account as collateral for the Plan loan. A Plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, Plan loans are not reported on the statements of net assets available for benefits.

A participant may apply for a Plan loan to be made from his or her vested account balance in the Plan, not to exceed the lesser of (i) \$50,000 or (ii) 45% of the participant's vested account balance in the Plan. Loans may be further limited by the funding vehicles.

At December 31, 2024 and 2023, there was \$3,912 and \$3,715, respectively, held within participant accounts in the TIAA Traditional Fixed Account on the statements of net assets available for benefits, which served as collateral against outstanding Plan loan balances.

**Benefit Payments**

Upon termination of service, death, disability, or retirement (age 65), the participant may receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 65 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. In July 2024, the force out limit was increased to \$7,000.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Employer. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, investment related expenses are included in net appreciation of fair value of investments.

**Benefit Payments**

Benefits are recorded when paid.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 22, 2025, the date the financial statements were available to be issued.

**Note 3: Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association of America and College Retirement Equities Fund on behalf of TIAA, and Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, collectively the trustees of the plan.

**Note 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Account:* Valued at the NAV which is based on the market value of its underlying investments (i.e. common stock, mutual funds, short term securities). While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted and is determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Sub-Accounts of Variable Annuities:* Valued at NAV of shares, which are valued by TIAA and CREF at accumulation unit value based on the estimated value of the underlying investments, held by the Plan at year-end. The NAV is a readily determinable fair value and is the basis for current transactions.

*Non-benefit-Responsive Fixed Account:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations as reported by TIAA. Significant unobservable inputs include the risk adjusted discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates.

**Note 5: Individual Annuity Contracts with Insurance Company**

Each participant maintains an individual annuity contract with TIAA and/or CREF. As part of the contracts, TIAA may maintain a portion of the contributions in a "guaranteed account," which is called the Traditional Fixed Account. This account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA. The guaranteed minimum rate of interest is based on a formula established by TIAA and is between 1% and 3%. Any additional interest is not guaranteed.

The Traditional Fixed Account does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

Certain Traditional Fixed Account individual annuity contracts are considered to be non-benefit responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

These contracts are subject to a 10-year withdrawal period. Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

**Note 5: Individual Annuity Contracts with Insurance Company (Continued)**

Certain Traditional Fixed Account individual annuity contracts meet the fully benefit-responsive criteria and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Upon termination of the investment contract, the lump sum liquidation value of the guaranteed account portion of the participant's accumulation value shall be equal to the product of (a) the participant's guaranteed account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date, and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**Note 6: Group Annuity Contract with Principal Life Insurance Company**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$622,823 and \$638,566 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed semi-annually for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to its scheduled maturity date.

The contract meets the fully benefit-responsive contract criteria and is therefore reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (include complete or partial Plan terminations or mergers with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation of the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would remain 100% vested in their account balances.

**Note 9: Plan Tax Status**

The Employer adopted a prototype 403(b) plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated the Plan as then designed was in accordance with the applicable section of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10: Related Party and Party-in-interest Transactions**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$75,747 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**Note 11: Audit Scope Limitation**

Prior to 2009, the Plan's third-party administrator, TIAA and CREF, tracked contributions, investment earnings, distributions, and other activity on a "contract" basis. Each participant was set up as having a separate "contract" and Plan level activity was not captured. This method of administration was utilized prior to January 1, 2009 as the regulations governing 403(b) Plans did not require Plan level reporting. As a result of this administration and lack of historical Plan level financial reporting, the Plan administrator is unable to obtain Plan level information prior to January 1, 2009.

**Note 12: Nonexempt Transactions**

The Employer failed to remit employee deferral contributions for certain payroll periods within the time frame prescribed by the Department of Labor in 2023 and 2021. This was deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The Employer is working to self-correct the error outside of the Voluntary Fiduciary Correction Program (VFCP).

**Note 13: Plan Errors**

During plan years beginning in 2020, certain employees received compensation that was incorrectly excluded from the calculation of employee and employer contributions. This constitutes an operational failure within the Plan. The Employer has corrected the error in accordance with the IRS Self-Correction Program as outlined by the Employee Plans Compliance Resolution System and has made corrective contributions to the Plan. The Employer corrective contribution receivable of \$73,899 as of December 31, 2023, represents amounts due to participants, including lost earnings, for corrections relating to Plan years 2020 through 2023. These corrections were made from the Employer's assets, not the assets of the Plan, and are reflected as other employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 14: Concentrations**

As of December 31, 2024 and 2023, there were two investment funds that accounted for approximately 24 and 23 percent, respectively, of total Plan investments.

**Note 15: SECURE Act 2.0**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

During the year ended December 31, 2024, the plan implemented the following optional and required provisions set forth by the SECURE 2.0 Act on an operational basis:

- Increase in Cash-Out Limit – Effective July 25, 2024, the Plan increased the threshold for involuntary cashouts from \$5,000 to \$7,000 in accordance with Section 304.
- Domestic Abuse Distributions – Effective July 25, 2024, the Plan allowed distributions for victims of domestic abuse in accordance with Section 314.
- Allowing Terminal Illness Distributions without a 10% penalty tax – Effective July 25, 2024, the Plan allowed terminally ill individuals to qualify for an exception to the 10% early distribution penalty tax in accordance with Section 326.
- Required Minimum Distribution for Surviving Spouse – Effective July 25, 2024, the Plan allowed surviving spouses to elect to be treated as the participant for required minimum distributions purposes in accordance with Section 327.
- 403(b) Hardship Expansion – Effective July 25, 2024, the Plan expanded sources available for a Hardship Distribution to include contributions made pursuant to a salary reduction agreement, qualified nonelective contributions, qualified matchings contributions, and earnings on any of these contributions in accordance with Section 602.

**Note 15: SECURE Act 2.0 (Continued)**

Subsequent to the year ending December 31, 2024, the plan will implement the following optional provision set forth by the SECURE 2.0 Act on an operational basis:

- Age 60 – 63 Catch-up Contribution Increase – Effective January 1, 2025, the Plan will implement higher catch-up limits for participants aged 60 to 63 as permitted under Section 109.

Formal amendments reflecting these provisions have not been executed as of the date the financial statements were available to be issued. However, the plan sponsor intends to make all necessary amendments by the applicable deadline of December 31, 2026, in accordance with IRS Notice 2024-2.

**Note 16: Subsequent Event**

In February 2025, the Plan Administrator signed a form to terminate the Plan's Interest in the "Principal Fixed Income Guaranteed Option" group annuity contract with 12-months advice notice. The value of the Plan's Interest will be transferred to the Participant-Level Default Investment Option named in Plan Sponsor's agreement with Principal Life Insurance Company, if no other election is made. The liquidation of Plan's Interest will be on January 1, 2026, or the next open market date. The Plan will not incur a surrender charge as 12-month advice notice was given, per the terms of the contract.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Action Partnership of Ramsey and Washington Counties Tax Sheltered Investment Program 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the financial statements of the Plan referred to in the first paragraph. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules of assets (held at end of year) and delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

**Note 1: Description of Plan**

The following description of the Community Action Partnership of Ramsey and Washington Counties Tax Sheltered Investment Program 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Community Action Partnership of Ramsey and Washington Counties (the Employer and Plan administrator). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Employees are eligible to participate in the Plan for salary deferrals as soon as administratively feasible. Employees are eligible to participate in the Plan for Employer nonelective contributions after completing two years of service (1,000 hours each year). Carpenters' Union Employees are excluded from employer nonelective contributions. On April 1, 2023, the adoption agreement was amended and restated to include eligibility conditions to participate in employer matching contributions. Employees are eligible to receive employer matching contributions after completing 90 days of service, provided they are not carpenters' union employees.

**Contributions**

Eligible participants are permitted to elect to have up to 100% of their eligible compensation contributed as pre-tax contributions, Roth contributions, or a combination thereof, to the Plan. The Plan has an automatic enrollment provision whereby employees who become eligible and have not completed a salary deferral election will be deemed to have elected a 3% deferral election percentage unless an election to the contrary is made.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, otherwise known as rollover contributions. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain regulatory limitations.

Employer nonelective contributions were 3% of participant's eligible compensation through March 30, 2023. On April 1, 2023, the Plan was amended and restated to allow for employer nonelective contributions to be made solely with respect to any participant who is subject to a collective bargaining agreement between the Employer and certain unions, as defined by the Plan. Such participants who deferred any amount of compensation during the applicable period are eligible to receive a fixed contribution equal to 3% of compensation. Those not making salary deferrals to the Plan are eligible to receive a fixed contribution equal to 1% of compensation.

Additionally, as of April 1, 2023, employer matching contributions are allowed under the Plan for participants not subject to a collective bargaining agreement. The Employer matches 100% of employee contributions, up to 3% of eligible compensation.

Other employer contributions of \$73,834 consist of a qualified non-elective contribution incurred by the employer during the year ended December 31, 2023, and this plan error was fixed in 2024. See Note 13 for additional information.

**Note 1: Description of Plan (Continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the employer's contributions, investment earnings (and losses), changes in market values, and certain plan expenses. Allocations are based on participant earnings or account balances, as defined. Investment earnings and losses and changes in market value are allocated daily based on the shares in the participant's account. Plan expenses are allocated either directly to a participant's account for certain transactions affecting only the participant or proportionally to all participants for certain administrative expenses of the plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Vesting**

Participants are immediately vested in all of their contributions, employer matching, and nonelective employer contributions plus actual earnings thereon.

**Plan Loans**

Participants may borrow amounts from TIAA, the Plan insurance company. Plan loans may be requested by a participant, using their account as collateral for the Plan loan. A Plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, Plan loans are not reported on the statements of net assets available for benefits.

A participant may apply for a Plan loan to be made from his or her vested account balance in the Plan, not to exceed the lesser of (i) \$50,000 or (ii) 45% of the participant's vested account balance in the Plan. Loans may be further limited by the funding vehicles.

At December 31, 2024 and 2023, there was \$3,912 and \$3,715, respectively, held within participant accounts in the TIAA Traditional Fixed Account on the statements of net assets available for benefits, which served as collateral against outstanding Plan loan balances.

**Benefit Payments**

Upon termination of service, death, disability, or retirement (age 65), the participant may receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 65 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. In July 2024, the force out limit was increased to \$7,000.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Employer. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, investment related expenses are included in net appreciation of fair value of investments.

**Benefit Payments**

Benefits are recorded when paid.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 22, 2025, the date the financial statements were available to be issued.

**Note 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Account:* Valued at the NAV which is based on the market value of its underlying investments (i.e. common stock, mutual funds, short term securities). While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted and is determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Sub-Accounts of Variable Annuities:* Valued at NAV of shares, which are valued by TIAA and CREF at accumulation unit value based on the estimated value of the underlying investments, held by the Plan at year-end. The NAV is a readily determinable fair value and is the basis for current transactions.

*Non-benefit-Responsive Fixed Account:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations as reported by TIAA. Significant unobservable inputs include the risk adjusted discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates.

**Note 5: Individual Annuity Contracts with Insurance Company**

Each participant maintains an individual annuity contract with TIAA and/or CREF. As part of the contracts, TIAA may maintain a portion of the contributions in a "guaranteed account," which is called the Traditional Fixed Account. This account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA. The guaranteed minimum rate of interest is based on a formula established by TIAA and is between 1% and 3%. Any additional interest is not guaranteed.

The Traditional Fixed Account does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

Certain Traditional Fixed Account individual annuity contracts are considered to be non-benefit responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

These contracts are subject to a 10-year withdrawal period. Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

Certain Traditional Fixed Account individual annuity contracts meet the fully benefit-responsive criteria and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Upon termination of the investment contract, the lump sum liquidation value of the guaranteed account portion of the participant's accumulation value shall be equal to the product of (a) the participant's guaranteed account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date, and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**Note 6: Group Annuity Contract with Principal Life Insurance Company**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$622,823 and \$638,566 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed semi-annually for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to its scheduled maturity date.

The contract meets the fully benefit-responsive contract criteria and is therefore reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (include complete or partial Plan terminations or mergers with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation of the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would remain 100% vested in their account balances.

**Note 9: Plan Tax Status**

The Employer adopted a prototype 403(b) plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated the Plan as then designed was in accordance with the applicable section of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10: Related Party and Party-in-interest Transactions**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$75,747 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**Note 11: Audit Scope Limitation**

Prior to 2009, the Plan's third-party administrator, TIAA and CREF, tracked contributions, investment earnings, distributions, and other activity on a "contract" basis. Each participant was set up as having a separate "contract" and Plan level activity was not captured. This method of administration was utilized prior to January 1, 2009 as the regulations governing 403(b) Plans did not require Plan level reporting. As a result of this administration and lack of historical Plan level financial reporting, the Plan administrator is unable to obtain Plan level information prior to January 1, 2009.

**Note 12: Nonexempt Transactions**

The Employer failed to remit employee deferral contributions for certain payroll periods within the time frame prescribed by the Department of Labor in 2023 and 2021. This was deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The Employer is working to self-correct the error outside of the Voluntary Fiduciary Correction Program (VFCP).

**Note 13: Plan Errors**

During plan years beginning in 2020, certain employees received compensation that was incorrectly excluded from the calculation of employee and employer contributions. This constitutes an operational failure within the Plan. The Employer has corrected the error in accordance with the IRS Self-Correction Program as outlined by the Employee Plans Compliance Resolution System and has made corrective contributions to the Plan. The Employer corrective contribution receivable of \$73,899 as of December 31, 2023, represents amounts due to participants, including lost earnings, for corrections relating to Plan years 2020 through 2023. These corrections were made from the Employer's assets, not the assets of the Plan, and are reflected as other employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 14: Concentrations**

As of December 31, 2024 and 2023, there were two investment funds that accounted for approximately 24 and 23 percent, respectively, of total Plan investments.

**Note 15: SECURE Act 2.0**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

During the year ended December 31, 2024, the plan implemented the following optional and required provisions set forth by the SECURE 2.0 Act on an operational basis:

- Increase in Cash-Out Limit – Effective July 25, 2024, the Plan increased the threshold for involuntary cashouts from \$5,000 to \$7,000 in accordance with Section 304.
- Domestic Abuse Distributions – Effective July 25, 2024, the Plan allowed distributions for victims of domestic abuse in accordance with Section 314.
- Allowing Terminal Illness Distributions without a 10% penalty tax – Effective July 25, 2024, the Plan allowed terminally ill individuals to qualify for an exception to the 10% early distribution penalty tax in accordance with Section 326.
- Required Minimum Distribution for Surviving Spouse – Effective July 25, 2024, the Plan allowed surviving spouses to elect to be treated as the participant for required minimum distributions purposes in accordance with Section 327.
- 403(b) Hardship Expansion – Effective July 25, 2024, the Plan expanded sources available for a Hardship Distribution to include contributions made pursuant to a salary reduction agreement, qualified nonelective contributions, qualified matchings contributions, and earnings on any of these contributions in accordance with Section 602.

**Note 15: SECURE Act 2.0 (Continued)**

Subsequent to the year ending December 31, 2024, the plan will implement the following optional provision set forth by the SECURE 2.0 Act on an operational basis:

- Age 60 – 63 Catch-up Contribution Increase – Effective January 1, 2025, the Plan will implement higher catch-up limits for participants aged 60 to 63 as permitted under Section 109.

Formal amendments reflecting these provisions have not been executed as of the date the financial statements were available to be issued. However, the plan sponsor intends to make all necessary amendments by the applicable deadline of December 31, 2026, in accordance with IRS Notice 2024-2.

**Note 16: Subsequent Event**

In February 2025, the Plan Administrator signed a form to terminate the Plan's Interest in the "Principal Fixed Income Guaranteed Option" group annuity contract with 12-months advice notice. The value of the Plan's Interest will be transferred to the Participant-Level Default Investment Option named in Plan Sponsor's agreement with Principal Life Insurance Company, if no other election is made. The liquidation of Plan's Interest will be on January 1, 2026, or the next open market date. The Plan will not incur a surrender charge as 12-month advice notice was given, per the terms of the contract.
