INDEPENDENT AUDITORS' REPORT

To the Participants of
Strata Products Worldwide 401(k) Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Strata Products Worldwide 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. DESCRIPTION OF PLAN

The following description of the Strata Products Worldwide 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees, who are age 18 or older and have met certain eligibility criteria, of Strata Products Worldwide, LLC (the "Sponsor"), Strata Safety Products, LLC, Strata Products (USA), LLC, and Strata Mine Services, LLC (collectively the "Employer"). The Plan became effective on October 1, 1992, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and Internal Revenue Code ("IRC").

Contributions

Each employee eligible to participate ("participant") may contribute wages on a pre-tax or after-tax basis as defined by the Plan, subject to the IRC limitations which are adjusted annually by the Internal Revenue Service ("IRS"). Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

For active participants in the Plan who have completed one year of service, the Employer makes safe harbor matching contributions equal to 100% of the first 3% plus 50% of the amount that exceeds 3% but does not exceed 6% of salary deferrals. The Employer may also make discretionary matching and profit-sharing contributions. There were no discretionary matching or profit-sharing contributions made during the year ended December 31, 2024.

Investment options

The Plan's assets are held by Reliance Trust Company (the "Custodian"), the custodian for the Plan. Under an arrangement with the Custodian and upon enrollment in the Plan, participants direct all contributions in any whole percentage increments to any of the available funds. Participants may change their allocation among the various investment options at any time.

Participant accounts

Each participant's account is credited with (a) the participant's contributions, (b) the Employer's contributions on behalf of the participant, and (c) the earnings and losses of the participant's investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in the entire balance of their accounts.

Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. Each participant is permitted to have a maximum of two loans outstanding at any time. The maximum term of repayment for a loan, other than that used to purchase a primary residence, is five years. The maximum term of repayment for a loan used to purchase a primary residence may be longer than five years. The interest rate ranged from 4.25% to 9.50% on loans outstanding at December 31, 2024 and 2023.

Administrative expenses

Administrative expenses charged to the Plan include transaction fees relating to certain participant-initiated transactions, and advisory fees based on total Plan assets.

Payment of benefits

Upon termination of employment, attainment of normal retirement age, or for reasons of death or disability, participants may request a lump sum distribution of their vested account. Participants still employed with the Employer may withdraw all or a portion of their account balance upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. Terminated employees whose vested account balance is less than \$7,000 will have their account balances automatically rolled over into an individual retirement account, outside of Plan assets.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the unrealized and realized gains and losses on investments purchased and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Use of estimates in financial statement preparation

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation/depreciation in fair value of investments.

Subsequent events

The Sponsor has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedules.

4. RELATED PARTY TRANSACTIONS

The Sponsor pays certain administrative costs on behalf of the Plan. The Sponsor also provides recordkeeping and administrative services to the Plan at no cost.

The Plan offers, as investment options, certain funds and trusts managed by the Third-Party Recordkeeper. Accordingly, transactions in these investments qualify as party-in-interest transactions as defined by ERISA.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (the "FASB") *Accounting Standards Codification* (the "ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the year ended December 31, 2024.

- Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trust: Valued at the NAV of units of the common trust. The NAV, as provided by the trustee of the collective trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) can normally occur daily, at fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. PLAN TERMINATION

Although it has expressed no intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. TAX STATUS

The Plan uses a volume submitter plan document sponsored by DST Retirement Solutions LLC who was informed by the IRS by a letter dated June 30, 2020, that the volume submitter plan is designed in accordance with the applicable sections of the IRC. Though the Plan has not received a determination from the IRS, the Sponsor believes that the Plan, as amended, is designed and being operated in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

10. PLAN AMENDMENTS

Effective January 1, 2024, the Sponsor increased the threshold for forced distributions of terminated participants from \$5,000 to \$7,000 as permitted under Secures Act 2.0.

Effective April 9, 2024, the Plan document was restated to permit Roth after-tax elective deferrals.

11. SUBSEQUENT EVENT

Effective January 1, 2025, the Plan document was restated to amend the definition of eligible compensation to exclude certain non-cash fringe benefits.
