Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Springs Living 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Springs Living 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Springs Living 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Springs Living 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Plan Description

The following description of The Springs Living 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering non-union employees of The Springs Living (the Company) who are age 18 or older and have completed three months of service. Effective April 1, 2024, the Plan reduced the service requirement to two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective January 1, 2022. The Board of Trustees oversees the governance of the Plan.

Contributions

Participants may elect annually to contribute on a pre-tax or after tax (Roth) basis up to 100 percent of their annual compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may make additional "catch-up" contributions. Participants may also contribute amounts representing rollover distributions from other qualified sources. The Company may make a discretionary match contribution equal to a percentage of the amounts contributed by participants and this percentage can be no more than 6 percent of participants' eligible compensation. The percentage is determined annually by the Company. For the years ended December 31, 2024 and 2023, the Company elected to make a discretionary matching contribution of 50 percent of participant contributions, limited to 3 percent of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution (if any), and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts between several investment alternatives available within the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100 percent vested in employer contributions and earnings thereon after completing five years of vesting service (defined as one calendar year in which a participant has at least 1,000 hours of service) according to the following schedule:

Payment of Benefits

Upon retirement, death, disability or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts in a lump sum, substantially equal installments or a partial withdrawal of at least \$1,000. Participants may withdraw rollover contributions at any time. Participants aged 65 or older may receive in-service distributions from their vested account. The Plan also allows hardship withdrawals in the event of an immediate and heavy financial need from the participant's vested account, as described in the plan document.

Forfeited Accounts

The non-vested account of a participant shall be forfeited if a participant is terminated. These accounts are used to reduce the Plan's future employer contributions or pay Plan expenses. During the years ended December 31, 2024 and 2023, \$51,076 and \$24,013, respectively, was forfeited from participant accounts. \$139,595 and \$7,853 of forfeitures were used to offset employer contributions and pay Plan expenses for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, unused, forfeited accounts were \$6,239 and \$94,758, respectively.

Participant Loans

Loans to participants are not permitted.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurement. The Plan's guaranteed interest account is carried at contract value which represents deposits, plus interest, less withdrawals (See Note 4).

Investment transactions are accounted for on the trade date (date the investment securities are purchased or sold). Both the average cost and specific identification methods are used in determining the cost of investment securities sold. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Certain administrative expenses are paid directly by the Company and are therefore excluded from these financial statements. Certain participant transaction fees and quarterly participant fees are paid from participant accounts. Investment related expenses are included in the net change in fair value of investments.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Prepared and Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the financial statements and supplemental schedule was certified as being complete and accurate by Standard Insurance Company, the custodian of the Plan, as of and for the years ended December 31:

4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive, investment contract with Standard Insurance Company (The Standard), included in the statements of net assets available for benefits as a guaranteed interest account. The Standard maintains the contributions in a pooled account (Stable Value Asset), which is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. All assets in the guaranteed interest account are credited with interest using a declared quarterly rate determined by The Standard and stated in advance of the coming quarter. There is no specific portfolio of assets in which the stable value fund invests.

4. Investment Contract with Insurance Company, continued

The crediting interest rate is backed by the income received from assets held in The Standard's general account. The crediting interest rate was 2.43 and 1.92 percent for the Plan years ended December 31, 2024 and 2023, respectively. The rate will never be below 1 percent and has no maximum interest rate for the Stable Value Asset. Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with The Standard. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable. Based on these factors, The Standard has certified that the fair value of the insurance contracts is equal to the current contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become 100 percent vested in their accounts.

6. Tax Status

The Plan has adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA. Standard Retirement Services, Inc, the sponsor of the prototype plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, that the adoption agreement and basic Plan document satisfy IRC Section 401. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Related Party Transactions

Certain Plan investments are managed by the custodian of the Plan and therefore these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid to Stancorp Financial Group, an affiliate of the custodian, totaled \$83,533 and \$82,566, respectively, a portion of which was investment related expenses and included in net change in fair value of investments. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate pooled account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to ASU 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments are held by the Plan within a group annuity contract and have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

9. Fair Value Measurements, continued

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan Administrator believes the Plan's valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

10. Subsequent Events
