## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The Alliance for Senior Care Communities, LLC Health Insurance Trust (the Trust) administers a multiple employer welfare arrangement (the Plan). Through a group insurance arrangement, the Trust provides certain medical insurance benefits to eligible employees of the following participating employers: Jewish Home of Rochester, Summit at Brighton, Rochester Friendly Home, dba: The Friendly Home, Cloverwood Senior Living, Inc., Church Home of the Protestant Episcopal Church in the City of Rochester, and St. Ann's Home. The Trust itself is not subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), however, each participating employer sponsors a health and welfare plan that is subject to ERISA. Collectively, the participating employer sponsors have elected to meet their obligations under ERISA via the group insurance arrangement provided by the Trust. Participants should refer to the Plan documents of each participating employer for a complete description of the Plans' provisions.

#### **General Terms**

The Trust was established on September 23, 2009. Contributions began to be made to the Trust in December 2015. The group insurance arrangement, offered through the Trust, became effective on January 1, 2016.

#### **Benefits**

The Trust provides medical benefits to employees of the participating employers who meet certain eligibility criteria as defined in the respective Plan documents based on occurrence.

Participation in the Plan may cease for the following reasons: a participant's employment ends and the participant does not elect the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), Family and Medical Leave Act (FMLA), or Uniformed Services Employment and Reemployment Rights Act (USERRA) coverage; the group contract terminates; a participant or his or her dependent is no longer an eligible employee or meets the dependent classification; a participant fails to make the required contribution to the respective participating employer; a participant terminates coverage; a participant retires or a participant dies.

Benefits under this Trust are processed by a third-party insurer. The Trust pays for actual costs incurred by participants and has a stop loss arrangement, whereby costs exceeding certain thresholds are reimbursed by the insurer.

#### **Contributions**

Benefits under the Trust are funded by the participating employers according to terms specified in the Trust Membership Agreement. Amounts funded by the participating employers are billed monthly, based on pre-determined rates, and held in the Trust's general assets.

Under the terms of the health and welfare plan sponsored by each participating employer, eligible employees contribute specified amounts to the participating employers based on elected coverage levels, as determined annually by the participating employers.

## 1. DESCRIPTION OF PLAN (Continued)

### **Rebates**

The Trust receives rebates of prescription costs incurred from the insurer. These rebates are recognized as income on the statements of changes in net assets available for benefits. Rebates received by the Trust are used to aid the Trust in meeting its obligations under the Plan.

### **Administrative Expenses**

All administrative expenses, including claims maintenance fees, are paid by the Trust.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Trust's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **Allowance for Credit Losses**

The Trust records receivables for rebates, premiums and other receivables (stop loss amounts) due to the Trust at year-end and remitted to the Trust subsequent to the Trust's year-end. The Trust considers an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. The Trust has not experienced any historical credit losses relative to rebates, premiums and other receivables (stop loss amounts), current and future economic conditions are not expected to change relative to historical financial information and the full amount outstanding at December 31, 2024 and 2023 was received subsequent to year-end, therefore management has determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

### **Cash**

Cash consists of bank demand deposit and money market accounts that, at times, may exceed federally insured limits. The Trust has not experienced any losses in these accounts and believes it is not exposed to any significant credit risk with respect to cash.

### **Rebate, Premium and Other Receivables and Other Income**

Under the Trust's contract with the insurer, the Trust pays for actual eligible costs incurred by participants. Costs, paid by the Trust, exceeding \$250,000 per individual participant for the years ended December 31, 2024 and 2023 are refunded by the insurer and recorded as other income in the statements of changes in net assets available for benefits.

Certain prescription rebates require manufacturer's input data and are not finalized by the insurer until the fall following year-end. Such additional rebates are reflected in the financial statements in the year they become known or can be reasonably estimated.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Rebate, Premium and Other Receivables and Other Income (Continued)**

Premiums are billed monthly to the participating employers in advance of the coverage period, based on established rates. Rates are determined annually, considering factors such as historical Trust operations, economic trends and projected enrollment at the participating employers, amongst others. While rates are developed in a manner projected to fully fund Trust operations for the upcoming year, actual operational activity may result in additional amounts due from or excess contributions made by the participating employers. Additional amounts due from the participating employers are recorded as other receivables.

### **Deposits with Insurance Company**

Restricted deposits with the insurer can be applied against possible future losses. Such deposits are determined on an annual basis with the difference between the required annual deposits refunded by or paid to the insurance company after the end of the Trust year. Deposits with the insurer are funded by the participating employers and accordingly, refunds of such deposits are recorded as liabilities in the statements of net assets available for benefits.

### **Refund of Excess Contributions**

Refund of excess contributions represent excess contributions due to the participating employers, which have been approved for payment by the Board of Trustees but not paid at year-end.

### **Premiums Received in Advance**

Premiums received in advance are contributed by the participating employers in advance of the coverage period.

### **Benefit Payments**

Benefit payments are recorded as expense when paid by the insurer and reported to the Trust.

### **Health Claims Payable**

Health claims payable represent claim expenses incurred and reported to the Trust prior to but not paid at year end.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Trust to use estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and incurred but not reported claims. Due to the uncertainties inherent in this process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Trust obligations at December 31, 2024 and 2023 for health claims incurred by active participants but not reported at that date were estimated by the Trust's actuary in accordance with generally accepted actuarial principles. For measurement purposes, an annual medical trend rate of 7.50% in both years, and an annual prescription drug trend rate of 11.00% and 10.50%, respectively, were used in calculating the claims incurred by not reported (IBNR) reserve at December 31, 2024 and 2023.

### 3. PARTY-IN-INTEREST TRANSACTIONS

Gallagher Consulting Services, Inc. provides healthcare consulting and actuarial services and Excellus Health Plan, Inc. (Excellus) provides claims processing services to the Trust. Transactions between Gallagher, Excellus, the participating employers described in Note 1 and the Trust qualify as party-in-interest transactions.

### 4. TAX STATUS

The Trust is reported in the Alliance for Senior Care Communities, LLC (ASCC, LLC) tax return, which is treated as a Limited Liability Company for Federal and New York State income tax purposes. Under an election, the profit or loss of ASCC, LLC is reported in the tax returns of its members.

### 5. PLAN TERMINATION

Although they have not expressed any intent to do so, the participating employers have the right under the Trust agreement to discontinue their contributions at any time and to amend, suspend, or terminate the Plan and related Trust.

Upon termination of the Plan, the Trust shall provide for payment of all expenses incurred up to the date of termination and expenses incurred in connection with the termination. Assets remaining after the satisfaction of all benefit liabilities may be rebated to the participating employers to the extent permitted by law.

### 6. RECONCILIATION TO FORM 5500

While the Trust is not subject to the provisions of ERISA because each participating employer sponsors a health and welfare plan that is subject to the provisions of ERISA, the Trust files a single Form 5500, on behalf of the participating employers, as a group insurance arrangement.
