### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Gen4 Dental Partners 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Gen4 Dental Partners 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Fidelity Management Trust Company (Fidelity), as of December 31, 2024 and for the period from May 1, 2024 to December 31, 2024, and Voya Retirement Insurance and Annuity Company (Voya), as of December 31, 2024 and for the period from January 1, 2024 to April 30, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Gen4 Dental Partners 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a profit-sharing plan established on August 1, 2021, that covers all employees of Gen4 Dental Partners OPCO, LLC (the Company or Plan Sponsor) and adopting employers. Employees are eligible to participate in the Plan once they have attained the age of eighteen and the completion of thirty days of service. The Plan entry date is the first day of each month following meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The company functions as the Plan administrator.

*Amendments*

During 2024, the following amendments were made to the plan:

- The plan has included the following adopting employers, Gen4 Payroll California, Gen4 Dental Clinical Tennessee, LLC, Gen4 Dental Clinical Ohio, LLC, Gen4 Dental Clinical New Mexico, LLC, Gen4 Dental Clinical Nevada, LLC Gen4 Dental Clinical Indiana, LLC, Gen4 Dental Clinical Virginia, LLC, and Gen4 Dental Clinical Pennsylvania LLC, as participating employers.

*Contributions*

Participants may make voluntary salary reductions (participant contributions) up to 90% of their Salary. For 2024 this deferral limit was \$23,000. Participants may also rollover amounts from other qualified plans. Participants over the age of 50 are eligible for catch-up contributions. The Plan includes automatic enrollment for newly eligible participants and will start deferring at 6% of eligible compensation and will automatically increase 1% each plan year to a maximum of 10%.

The Company, at its discretion, may make rigid discretionary matching contributions based on a percentage of participant contributions. During 2024, the Company matched 100% up to 3% of participants' eligible Plan compensation. During 2024, the Company made discretionary matching of approximately \$1,444,000.

*Contributions, Continued*

The Company may also make discretionary non-elective profit-sharing contributions to the Plan, an amount determined by resolution of the owner or other governing authority of the Company. Participants must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year in order to share in the profit sharing contributions. During 2024, the Plan Company did not make any discretionary non-elective profit-sharing contributions.

In some circumstances, the Company may need to make special contributions on the participants' behalf called Qualified Nonelective Contributions. If made, participants are always 100% vested in these contribution accounts. During 2024, the Company did not make discretionary non-elective contributions.

*Participant Accounts*

Each participant's account is credited with the participant's contributions, rollover contributions, qualified nonelective contributions, discretionary matching contributions, discretionary non-elective profit-sharing contributions, and earnings thereon for each participant. Employer discretionary contributions and discretionary non-elective profit-sharing contributions are referred to as Company contributions. The benefit to which a participant is entitled is the total benefit, which can be provided from the vested portion of these individual accounts

*Vesting*

Participants are 100% vested in their salary deferral contributions, qualified nonelective contributions, rollover contributions as well as earnings thereon. Discretionary matching and profit-sharing contributions made by the Plan Sponsor vest as follows

*Notes Receivable from Participants*

Participants may borrow from their accounts upon written application to and approval by the Plan Administrator. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the participant's vested account balance. Loans must be repaid within 5 years and bear a reasonable rate of interest.

**NOTE 1 - DESCRIPTION OF THE PLAN, CONTINUED**

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may request a distribution of their vested account balance from the Plan Administrator. Furthermore, upon approval of the Plan Administrator, participants may be entitled to take hardship distributions. Participants may elect to withdraw all, or a portion of their account while still employed, upon attainment of age 59 ½. Vested account balances less than \$5,000 for terminated participants, will be distributed as soon as administratively feasible after termination. Benefits are recorded when paid.

*Forfeited Accounts*

Forfeited accounts will be used to either pay Plan expenses or to reduce Company contributions. Forfeitures as of December 31, 2024 and 2023 were approximately \$56,000 and \$78,000, respectively. During 2024, approximately \$14,000 was used to pay Plan expenses, and approximately \$375,000 was used to reduce Company contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

*Basis of Accounting*

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully-benefit responsive investment contract, which is valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. See Note 5 for discussion of contract value measurements.

*Investment Valuation and Income Recognition, Continued*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Fair Value Measurements*

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

*Investment Contracts*

Investments held by a defined contribution plan are required to be reported at fair value, except fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The investment contract held by the Plan is fully benefit-responsive. Therefore, the investment is recorded at contract value as of December 31, 2024, and 2023. See Note 5 for a description of the investment contract.

*Administrative Costs*

All expenses of maintaining the Plan are paid out of the Plan assets or by the Plan Sponsor. Investment-related expenses are included in net appreciation in fair value of investments. Any fee or expense that the Employer pays, directly or indirectly, is not an Employer contribution to the Plan, provided the fee or the expense relates to the ordinary and necessary administration of the plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

*Market Risk*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Subsequent Event*

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate Fidelity Management Trust Company (Fidelity), and Voya Retirement Insurance and Annuity Company (Voya), qualified institutions. Effective May 1, 2024, the Plan changed its qualified institution from Voya Retirement Insurance & Annuity Company to Fidelity Management Trust Company.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3                    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Cash and equivalents:* Cash consists of cash on deposit with banks. Cash equivalents represent money market funds or short-term investments with original maturities of three months or less from the date of purchase, except for those amounts that are held in the investment portfolio which are invested for long-term purposes. Cash and cash equivalent are valued at fair value, which approximates cost basis.

*Collective trusts funds:* Valued at NAV based on the market value of the underlying investment assets divided by the number of units outstanding at the end of the Plan year. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a fully benefit-responsive investment contract with VOYA and is reported at contract value in the statements of net assets available for benefits. The contract value represents principal contributions made by participants, plus interest accrued at a crediting rate established under the contract, less participant withdrawals and administrative expenses. The fixed contract does not have a maturity date. The fixed contract's provisions do not provide for a distribution at book value at some specified future date. A contract holder can request a lump sum distribution with a market value adjustment, or an installment payout, at book value, over a period of years. The fixed contract continues in force until all assets have been distributed, or no further payments are due.

VOYA determines its effective annual interest rate. Interest is credited, based upon the daily balance at a rate that is the daily equivalent of the effective annual rate of interest. There is no stated minimum or maximum interest rate.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the preapproved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Voya and Fidelity held the Plan’s assets and performed the record-keeping. Fidelity and Nova 401(k) Associates provides third-party administration. Investment advising is performed by BCG 401(k) Advisors. Global Retirement Partners is the Plans registered investment advisor. Therefore, any investment or administrative fees paid during the year to these parties qualify as party-in-interest transactions.

**NOTE 9 – SECURE 2.0**

The SECURE 2.0 Act of 2022 introduces several changes to qualified retirement plans, with various implementation dates ranging from 2023 to future years. Key provisions include enhanced catch-up contribution limits for participants ages 60-63 (effective 2025), requirements for higher income participants to direct catch-up contributions to Roth accounts (effective 2026), increases to required minimum distribution ages (phasing up to age 75), and the option to increase the automatic rollover threshold for force-out distributions from \$5,000 to \$7,000.

The Plan Administrator is currently evaluating these changes to determine which optional provisions may benefit plan participants. Any required amendments will be implemented by their respective deadlines, and participants will be notified of adopted changes that affect their accounts or options under the Plan.
