NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. THE PLAN

The following description of the Mirror Lake Inn 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established to provide benefits to eligible employees of The Cottage Corporation, Mirror Lake Inn, Inc., Mirror Lake Inn, LLC, and Mirror Lake Inn Builders, Inc. (collectively, the "Company"). The Plan is administered by management of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

As defined in the Plan document, all full-time employees of the Company who are age 21 or older and have completed one year of service, defined as 1,000 hours, are eligible to participate in the Plan.

Once an employee has completed one year of service, he or she is eligible for the Company's match and discretionary contributions. Employees may begin contributing to the Plan on January 1 or July 1 of the year after the employee meets all eligibility requirements. Eligible employees may begin to receive matching contributions and discretionary contributions, if any, on the first day of the payroll period coinciding with or next following the date on which an employee meets the eligibility requirements, or as soon as administratively feasible thereafter.

Contributions

Participants may contribute pre-tax and post-tax salary deferrals to the Plan, subject to certain IRS limitations. Participants are automatically enrolled at 5% deferral of compensation. The deferral percentage automatically increases 1% on annual basis (up to a 10% maximum). Participants may elect to contribute more, but only up to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Participants aged 50 and over are also permitted to make additional "catch-up" contributions. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans.

The Company provides safe harbor matching contributions automatically to participant accounts of each eligible employee in an amount equal to 100% of deferrals up to 3% of compensation and 50% of deferrals on the next 2% of compensation.

The Company may also make a discretionary matching, qualified matching, and profit-sharing contributions to eligible employees. There were no discretionary contributions declared for the year ended December 31, 2024 and 2023.

1. THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contribution, Plan investment earnings and losses, and administrative expenses. Allocations are based on participant earnings and account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may elect to have their contributions and Company contributions invested in a variety of mutual funds and money market funds.

Vesting

Participants are immediately vested in their participant contributions, employer safe harbor contributions, and employer qualified matching contributions, plus actual earnings and losses thereon. Vesting in employer discretionary matching and profit sharing contributions is based on years of continuous service. A year of service is achieved by plan participants if they have 1,000 hours of service. If a participant terminates employment and is less than 100% vested, they will forfeit the non-vested portion of their account. A participant is 100% vested after six years of credited service, with incremental vesting as follows:

1 year or less	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,678 and \$14,242, respectively. These accounts will be used to reduce future administrative expenses. During the year ended December 31, 2024 and 2023, administrative expenses were reduced by \$1,875 and \$1,106, respectively, from forfeited nonvested accounts.

Payment of Benefits

On termination of service due to death, disability, retirement or termination, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

Hardship Withdrawals

Prior to age 59 ½, a participant may withdraw his or her participant contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from Plan assets. Substantially all administrative expenses associated with the Plan are paid by Plan participants as a reduction of investment income allocated to participant accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Risk and Uncertainties

The Plan provides investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Payment of benefits to participants are recorded when paid.

Investment Valuation and Income Recognition

Investments in mutual funds and money market funds are stated at fair value based upon quoted market prices at the Plan's year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Changes in the fair value of investments, including realized/unrealized gains and losses on assets sold during the year or held at year-end, are reflected in the statements of changes in assets available for benefits as net appreciation or depreciation in the fair value of investments. Purchases and sales of securities are reflected on a trade day basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures* provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023. The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

Money market and mutual funds - Value based on quoted price in active markets

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used in the prior year.

See Note 4 for a description of where the Plan's assets fall within the fair value hierarchy.

3. CERTIFIED INVESTMENT INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, NBT Bank, the Plan's custodian, has certified that the following data included in the financial statements and accompanying supplemental schedule is complete and accurate as of December 31, 2024 and 2023, and for the years then ended.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participant accounts, and earnings thereon, would become fully vested in the Company's contributions.

6. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 9, 2025, which is the date the financial statements were available to be issued.
