Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Caledonia Haulers, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following brief description of Caledonia Haulers, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of Caledonia Haulers, Inc. (the Plan Administrator and Plan Sponsor) and its wholly owned subsidiary, Caledonia Haulers, LLC, who are at least 18 years of age and have been employed for at least 60 days. Upon meeting the eligibility requirements, an employee shall commence actual participation in the Plan as of the first day of the month following the date on which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor has established a Plan Committee, which is responsible for oversight of the Plan.

The Plan Sponsor has appointed Empower Annuity Insurance Company of America and Empower Trust Company, LLC, as custodians of the Plan (the Custodians). The Custodians are responsible for maintaining custody of the Plan's assets, processing participant contributions and distributions, and executing transactions to appropriate investment options.

Contributions: Participants may contribute up to 100% of eligible compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and Roth deferrals. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Each year, the Plan Sponsor may elect to make a matching contribution and a profit-sharing contribution to the Plan. Participants who are eligible to contribute to the Plan, have at least 1,000 hours of service during the plan year, and are employed on the last day of the plan year (except in the year of termination due to death, permanent disability or attainment of normal retirement age) are eligible to receive matching and profit-sharing contributions. For the year ended December 31, 2024, the Plan Sponsor matched 50% of each eligible participant's deferrals up to \$3,000, for a maximum matching contribution of \$1,500 for each eligible participant. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant accounts and investment options: Individual accounts are maintained for each participant of the Plan. Each participant's account is credited or charged with the participant's contributions, the Plan Sponsor's matching contribution, if any, and allocations of the Plan Sponsor's profit-sharing contribution, if any, Plan investment results and administrative expenses that are paid by the Plan. Allocations are based on participant contributions, eligible participant compensation, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may elect to have all or part of their account balances and future contributions transferred from one investment option to another in any combination.

Vesting: Participants are immediately vested in their voluntary contributions, including actual investment earnings or losses thereon. A participant is fully vested in Plan Sponsor contributions, including actual investment earnings or losses thereon, after six years of service under a graded vesting schedule beginning the second year. A participant also becomes 100% vested upon reaching retirement age of 65 (as defined by the Plan), Plan termination, or upon death or permanent disability while employed by the Plan Sponsor.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms cannot be greater than five years. The notes must be adequately secured and bear interest at a rate commensurate with local prevailing rates. The rate of interest on existing notes at December 31, 2024, ranged from 10.00% to 10.50% on notes maturing through July 2029. Principal and interest payments are made ratably through payroll deductions.

Forfeited accounts: Amounts not vested upon termination of employment are forfeited by participants and are used to fund future Plan Sponsor contributions or to pay Plan expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts outstanding. During 2024, approximately \$1,000 of forfeitures were used to fund a portion of the 2024 Plan Sponsor matching contribution.

Payment of benefits: Upon termination of service, a participant may elect distribution of the value of the participant's vested account balance under one, or any combination, of the following methods: (a) payment in a lump-sum, (b) payment in installments over a period not exceeding the life expectancy of the participant or (c) involuntary cash-out. Participants may also elect to hold their investments in the Plan, unless their account balance is less than \$7,000, in which case the account balance is automatically distributed in cash or rolled over to another plan or individual retirement account if elected. If the vested balance of the participant's account does not exceed \$1,000 at the termination of service date, then the account balance must be distributed in a single lump-sum cash payment as soon as administratively feasible following the termination date. Voluntary withdrawals of a participant's account balance while still employed are allowed upon attainment of retirement age by the participant or with respect to rollovers from other plans, at any time and for any reason. The Plan also allows for in-service distributions to participants who have attained at least age 59½. The Plan does not allow hardship distributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties: Participants are allowed to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment balances have occurred since December 31, 2024, or will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Investment valuation and income recognition: The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, Custodians and other third parties. See Note 4 for a discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as notes are fully secured by participants' account balances. If a participant ceases to make note payments, and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded in accordance with the Plan document.

Notes receivable from participants are classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Participant contributions: Participant contributions are recognized in the period related to the participant's compensation (even if not yet withheld).

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses incurred to maintain the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of payment of benefits and notes receivable are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses reduce total investment results.

Subsequent events: The Plan Administrator has evaluated subsequent events through September 22, 2025, the date these financial statements were available to be issued.

Note 3. Information Certified or Provided by the Custodians

The following is a summary of the Plan's investment asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by the Plan Administrator and agreed to or derived from information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodians. The Plan Administrator has obtained certifications from the Custodians that the information provided to the Plan Administrator by the Custodians related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

The Custodians also certified to the completeness and accuracy of \$710,682 of net appreciation in fair value of investments, \$592,848 of interest and dividends related to the aforementioned investments and \$7,359 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the unadjusted quoted market prices for identical assets in active markets for the shares of the funds held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The group annuity contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participants' withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of the equity wash provision, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

The group annuity contract permits Empower Annuity Insurance Company of America to terminate the agreement with at least 60 days' advance written notice.

The Plan adopted a nonstandardized preapproved plan sponsored by Ascensus LLC. Ascensus LLC has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the preapproved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions and Administrative Expenses

Transactions with the Custodians qualify as party-in-interest transactions. Certain expenses paid by the Plan to the Custodians, as well as other service providers, are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. In addition, certain Plan investments are shares of mutual funds and a group annuity contract managed by affiliates of the Custodians.

Certain administrative functions are performed by employees of the Plan Sponsor. No such employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan Sponsor and are excluded from these financial statements.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
