Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.



Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

1. Description of Plan

The following description of The MITRE Corporation (the Corporation) Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a comprehensive description of the Plan's provisions.

General

The Plan was established as of August 1, 1981, to provide employees of the Corporation a tax effective opportunity to provide for their retirement. The Plan is a defined contribution plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan. The Investment Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. This Plan is established pursuant to Section 403(b) of the Internal Revenue Code (the Code).

Employees of the Corporation are eligible to join the Plan during the 60-day period beginning with the date of hire. Once enrolled, participants must remain in the Plan. If an employee does not enter the Plan within the initial 60-day period, participation in the unmatched A4 contributions, as defined below, is optional from day 61 of employment until the five-year anniversary of their hire date. On the five-year anniversary of the employee's hire date, enrollment in the Plan is mandatory.

Plan Administration

Plan investments are managed by the Fidelity Management Trust Company (FMTC), Teachers Insurance and Annuity Association of America (TIAA), College Retirement Equities Fund (CREF), AXA Equitable Life Insurance Company (AXA), and Metropolitan Life Insurance Company (Met Life) which act as the Plan's custodians.

Participant Accounts

Each participant's account is credited with allocations of the Corporation's contributions, investment earnings, administrative expenses, and revenue credits. Allocations are based upon participant earnings or account balances, as defined by the Plan. Investment income is allocated to participant accounts on a daily basis. Participant requested transactions are charged directly to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various options offered by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be fully repaid within five years or within ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are repaid directly to the Plan's custodians. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

Payment of Benefits

Account balances, valued as of the next day after termination, are distributable to participants upon termination of employment with the Corporation. Disbursements are made in the form of lump-sum distributions, installments, fixed period annuities (two to 30 years, for example), or lifetime annuities. Payment may be deferred until the participant reaches age 72. Effective January 1, 2023 participants may defer until they reach age 73.

Contributions

Each year, participants may make contributions to the Plan subject to certain Internal Revenue Service (IRS) limitations. Participants who have obtained age 50 before the end of the year are eligible to make catch-up contributions. Participants make contributions to the Plan in accordance with Plan documents on three levels:

Level 1 - A1 Employee's Required Contributions (A1) are contributed at 2% of the participant's base salary, up to the Social Security Taxable Wage Base (\$168,600 in 2024 and \$160,200 in 2023) plus an additional 4.7% of that portion of the participant's base salary, which exceeds the Social Security Taxable Wage Base. These contributions are not considered "elective contributions" (\$23,000 and in 2024 and \$22,500 in 2023) that are subject to IRS limitations.

Level 2 - A2 Employee Voluntary Matched Contributions (A2) are elective contributions determined by the participant based on 1% to 10% of the participant's base salary, up to the Social Security Taxable Wage Base (\$168,600 in 2024 and \$160,200 in 2023) plus an additional 1% to 6% of that portion of the participant's base salary which exceeds the Social Security Taxable Wage Base. The Corporation provides matching contribution based on 25% of the A2 participant contribution (A3 contributions).

Level 3 - A4 Employee Voluntary Unmatched Contribution (A4) are elective contributions determined by the participant not to exceed certain IRS limitations.

Participants may contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans, as defined by the Plan.

Vesting

The Corporation's contributions are immediately vested. Participants are vested immediately in their contributions plus actual earnings thereon.

Investment Options

Participants may elect to invest contributions in the funds offered by TIAA, CREF, Met Life, and FMTC. On a daily basis, a participant may change investment options and redirect account balances between funds. Contributions to investments in AXA funds are frozen.

Forfeitures

As of December 31, 2024 and 2023, forfeited accounts arising from uncashed stale-dated checks totaled \$355,613 and \$23,219, respectively. Forfeited amounts can be used to reduce the Corporation's contribution obligations to the Plan.

2. Summary of Accounting Policies

Annual Reporting Requirements

Prior to January 1, 2009, TIAA and CREF maintained records at a contract, not plan, level. TIAA and CREF administratively did provide accounting records and supporting documentation at the plan level relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As such, neither the Corporation nor TIAA and CREF have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Advisory Committee determines the Plan's valuation policies in utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit responsive investment contracts with TIAA and CREF (see Note 5) are valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals and expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Management fees and record-keeping costs are paid by the Plan and allocated to the Plan participants based on participant account balances. TIAA, CREF, AXA, Met Life, and FMTC administrative expenses reduce fund earnings. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are presented net of appreciation in fair value of investments. All other fees are paid by the Corporation and excluded from these financial statements.

Other Income

Other income consists of revenue-sharing agreements with the custodians as an incentive to remain with them. These amounts are allocated to the participants based on participant balances. Other income for the Plan year ended December 31, 2024 was \$7,056,051.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC, AXA, TIAA, CREF, and Met Life, qualified institutions.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuity Contracts - The variable annuity contracts are registered investment contracts that invest principally in real estate, equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. Units held in the variable annuity contracts are valued at NAV based on the fair market value of the underlying investments of the account less its liabilities. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. Account investments and fund holdings are primarily valued using external appraisals, market quotations, or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. Money market account holdings are generally valued at amortized cost. The objectives of the accounts vary based on the nature of the account and are described more fully in the accounts' prospectus.

Traditional Annuity Contracts - The non-fully benefit responsive (NFBR) fixed annuity contracts, composed of Met Life and traditional annuity contracts, are reported at fair value as approximated by contract value. Fair value is determined using discounted cash flow model. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals and expenses. The TIAA Traditional Annuity contracts are not available for sale or transfer on any securities exchange. The fixed annuity account is subject to various restrictions (see Note 5).

Pooled Separate Account - The pooled separate account is valued at the NAV based on the market value of the underlying real estate holdings or other real estate related investments. Although the underlying assets of the pooled separate account cannot be quickly sold and converted to liquid assets, TIAA and CREF provides the pooled separate account with a liquidity guarantee. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

Self-Directed Brokerage Accounts - Participants can elect to direct their Plan assets into individual securities by establishing a Plan level brokerage account. The Plan's investments in the self-directed brokerage account are held in mutual funds. Investments in brokerage accounts are reported at fair value. The Plan receives prices for investments in brokerage accounts, from a nationally recognized pricing service, that are based on observable market transactions.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment objectives for the variable annuity contracts measured using the net asset or unit value are as follows:

- (a) *Equities* - The investment objective is to invest in a broad diversified portfolio of foreign and domestic common stocks to meet the specified objective of the contract.
- (b) *Bond Market* - The investment objective is to invest in fixed-income securities to meet specified long-term rate of return.
- (c) *Money Market* - The investment objective is to invest in short-term securities or instruments that present minimal credit risk to provide liquidity and preserve capital.
- (d) *Multi-Asset* - The investment objective is to invest in domestic and foreign stocks, bonds, and other equity securities of companies that meet certain social criteria, including specified environmental, social, and governance criteria.

5. Investment Contracts

The Plan invests in fully benefit responsive and a non-fully benefit responsive investment contracts with TIAA and CREF. TIAA and CREF maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. There are no underlying investments other than the general assets of the insurance company. There are no reserves against contract value for credit risk of the contract issuer or otherwise. This investment option is offered in a variety of formats, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The investment contract issuer is contractually obligated to repay the

principal and a specified interest rate to the Plan, subject to the claims paying ability of TIAA and CREF.

RA account balances may only be withdrawn over ten annual payments. GRA account balances are available for lump-sum withdrawals only within 120 days after termination of employment and are subject to a 2.50% surrender charge. RAs and GRAs are not considered to be fully benefit responsive investment contracts as defined by ASC 962, because this provision is considered to restrict participants' "reasonable access" to their contract balances.

SRAs, GSRAs, and Met Life are considered fully benefit responsive investment contracts, because they are fully liquid and immediately cashable once a participant terminates employment with the Corporation (unless they are pledged as collateral on contract loans).

The Plan invests in fully benefit responsive investment contracts with Met Life. The Met Life contracts are backed by the General Account of Metropolitan Life Insurance Company. The General Account portfolio consists primarily of public and private securities, commercial and residential mortgages, and U.S. agency securities. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate to the Plan, subject to the claims paying ability of Met Life.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by FMTC, TIAA and CREF, and Met Life. FMTC, TIAA and CREF, Met Life, and AXA are the custodians as defined by the Plan, and therefore, these transactions in such investments qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. Fees paid indirectly to investment managers to FMTC, TIAA and CREF, and AXA are considered exempt party-in-interest transactions. The Corporation pays directly any other fees related to the Plan's operations. Notes receivable from participants are also exempt party-in-interest transactions. The Plan also receives revenue credits from FMTC and TIAA and CREF which are also exempt party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would remain 100% vested in their capitalized contributions.

8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

10. Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.
