### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

Effective January 1, 2023, the Plan was renamed Alliance for Empowerment, Inc. 401(k) Plan, the Plan was amended for Alliance for Empowerment, Inc. (Alliance) to become the Plan sponsor, and for Able2 Enhancing Potential, Inc. (Able2) and Capabilities, Inc. (Capabilities) to become participating employers in the Plan. The Plan is a defined contribution plan covering all eligible employees of Alliance, Able2, and Capabilities. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Prior to January 1, 2023, the Plan name was Able2 Enhancing Potential, Inc. 401(k) Plan and Able2 was the Plan Sponsor.

Alliance was formed in July 2022 as a New York not-for-profit corporation to support and assist other organizations as their active parent. Effective July 1, 2022, Alliance became the sole corporate member of Able2 and Capabilities (a separate not-for-profit organization). Effective September 1, 2022, Alliance became a participating employer in the Plan. Effective January 1, 2023, Capabilities became a participating employer in the Plan.

#### **Administration**

Alliance sponsors and administers the Plan. Chemung Canal Trust Company serves as the trustee and custodian of the Plan's assets.

#### **Eligibility**

Employees of Alliance, Able2 and Capabilities who have completed thirty days of service and are age eighteen or older are eligible to enter the Plan and begin making employee elective contributions. Participants become eligible for employer safe harbor matching contributions after completion of one year of service and the attainment of age twenty-one. A year of service was determined by the period of time a participant is employed.

#### **Contributions**

The Plan allows eligible employees to make voluntary contributions, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). The Plan is a safe harbor 401(k) Plan. In order for the Plan to maintain safe harbor status, a safe harbor matching contribution equal to 100% of participant deferrals that do not exceed 4% of the participant's annual compensation must be made.

#### **Rollover Contributions**

The Plan will accept direct rollover contributions from a qualified plan, as defined by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, allocations of Plan earnings or losses, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants direct the investment of all contributions into the various options offered by the Plan.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are fully vested in all contributions and earnings or losses thereon.

### **Payment of Benefits**

Upon termination of service or attaining the age of 59 ½, a participant may elect to receive a lump sum amount equal to the value of their account or to rollover the benefits to another plan. Effective January 1, 2024, participants whose vested account balance is \$7,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan. Prior to January 1, 2024, participants whose vested account balance was \$5,000 or less at the time of termination were subject to the involuntary cash-out provisions of the Plan.

### **Hardship Withdrawals**

Participants may receive distributions up to 100% of their elective deferral, employer safe harbor matching, and vested employer non-safe harbor matching account balances (inclusive of earnings (losses) thereon), in the form of a hardship withdrawal upon meeting the financial hardship requirements outlined in the Plan document.

### **Notes Receivable from Participants**

Plan participants may borrow up to the lesser of \$50,000 or 50% of the amount of the participant's account balance in the Plan. Loan terms range from one to five years, unless the loan is used for the purchase of a primary residence, in which case the term may be determined by the Plan administrator. Participant loans from the Plan are secured by their account balances and bear interest at the prime rate plus 2.0%. Principal and interest is paid ratably through bi-weekly payroll deductions.

### **Forfeitures**

There were no forfeited non-vested balances at December 31, 2024 and 2023.

### **Plan Administrative Expenses**

The Plan sponsor pays certain administrative costs of the Plan, and certain costs are passed through to participants.

### **Transfer of Assets to the Plan**

On January 1, 2023, Capabilities became a participating employer of the Plan. On January 10, 2023, plan assets totaling \$486,597 were transferred into the Plan from Capabilities previous Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investments**

Investments are stated at fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value of Financial Instruments**

The Plan uses various valuation techniques in determining fair value. Generally accepted accounting principles establish a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Fair value of the Plan's money market funds and mutual funds is determined based on quoted market prices. Cash is recorded at cost which approximates fair value.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

### **Estimates**

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and notes. Actual results could differ from those estimates and such differences may be significant.

### 3. INVESTMENTS

#### Certified Investment Information

Chemung Canal Trust Company, the trustee, has certified to the completeness and accuracy of information included in the financial statements and supplemental schedule as of and for the years ended December 31:

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets classified as level 2 or level 3 at December 31, 2024 and 2023 and there were no changes in the valuation methodologies during 2024 and 2023.

### 4. TAX STATUS

The Plan has received its latest opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the non-standardized defined contribution pre-approved plan's qualified status. The Plan opinion letter has been relied upon by this Plan. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

## **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of the ERISA and the IRC.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Chemung Canal Trust Company is the trustee of the Plan and Alliance is the Plan Sponsor. Able2 and Capabilities are participating employers in the Plan. As such, transactions between Chemung Canal Trust Company, Able2, Alliance, Capabilities and the Plan qualify as party-in-interest transactions. Additionally, certain plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

## **7. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of December 31, 2024 and 2023, respectively, and for the years ended December 31, 2024 and 2023.

## **8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 23, 2025, which is the date the financial statements were available to be issued.
