Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Saval Foods, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Saval Foods, LLC (the Company) effective June 1, 1993. The Plan covers substantially all employees of the Company, with the exception of non-resident aliens and those covered by a collective bargaining agreement. Eligible employees may enter the Plan on the first day of the calendar quarter following the attainment of age 21 and completion of 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective July 2, 2024, to change the Plan name from Saval Foods Corporation 401(k) Plan to Saval Foods, LLC 401(k) Plan.

Participant Contributions

Participants may elect to defer up to 75% of their eligible annual compensation, as defined by the Plan agreement, not to exceed the maximum allowable contributions under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023. Participants may also make Roth contributions into the Plan and rollover contributions into the Plan from other qualified plans.

The Plan has an automatic enrollment feature whereby an eligible employee who does not elect to contribute a specific percentage of his or her compensation or does not affirmatively elect not to contribute to the Plan will be automatically enrolled to contribute to the Plan at a rate of 2% of current compensation.

Company Contributions

The Company may provide matching and/or profit-sharing contributions to eligible participants at the discretion of the Company's management. During the years ended December 31, 2024 and 2023, the Company elected to make a matching contribution of 50% of the first 4% of the participants' elective deferrals contributed to the Plan on a per-payroll basis. Company matching contributions totaled \$249,266 and \$239,453, net of forfeitures for the years ended December 31, 2024 and 2023, respectively.

Participants are eligible for discretionary profit-sharing contributions if they have completed at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Company did not make a discretionary profit-sharing contribution.

Participant Accounts

Each participant's account is participant-directed and contributions are credited with the investment options selected by each participant. Plan earnings, losses and administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000 and a participant may have no more than one note outstanding at any given time. Notes are collateralized by the participant's vested account balance. Note repayments are to be made through payroll deductions with interest based on interest rates determined by the Plan administrator based on the prevailing interest rates at the time of loan issuance charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence which originated prior to April 30, 2017 must be repaid within ten years. Effective May 1, 2017, notes for the purchase of a primary residence must be repaid within fifteen years.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant (or their beneficiary, in the event of death) may elect to receive either a lump sum distribution of their vested account balance, or installment payments for those participants who must receive required minimum distributions. Prior to retirement, distributions from the Plan are payable in the form of a lump sum. If the balance is \$1,000 or less, the terminated participant's vested balance can be distributed immediately with or without the participant's consent. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. In-service withdrawals of amounts contributed by the participant may be requested by a participant upon attainment of age 59 ½, retirement (age 65), or at any time from rollover contributions into the Plan. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan elected to allow for certain additional distribution events as follows: (a) participants may take penalty-free early distributions in cases of domestic abuse wherein eligible participants may withdraw up to the lesser of \$10,000 or 50% of their vested account balance, provided the distribution occurs within one year of the domestic abuse incident, subject to specific provisions, (b) the Plan permits distributions of up to \$22,000 for expenses incurred as a result of a federally declared disaster, in accordance with the permanent disaster relief rules established under SECURE 2.0, in which such federally declared disaster distributions are not subject to the 10 percent additional tax and are taken into account as gross income over 3 years, subject to specific repayment options, and (c) the Plan permits terminal illness penalty tax exceptions. A formal amendment incorporating all SECURE 2.0 provisions is expected to be adopted no later than December 31, 2026, in accordance with IRS guidelines. As of September 24, 2025, the Plan has not been formally amended for these provisions.

Payment of Benefits – cont'd

Distributions and withdrawals are subject to the applicable provisions of the Plan agreement. As of December 31, 2024 and 2023, there were no assets of the Plan allocated to participants who elected to withdraw from the Plan, but had not received such distributions prior to year-end.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions, plus earnings thereon, is based on years of service according to the following schedule:

Upon death, disability, or normal retirement, a participant becomes 100% vested in their Company discretionary matching and profit-sharing contributions.

Forfeitures

All forfeitures resulting from the withdrawal of participants prior to vesting are retained in the Plan and may be used to pay administrative expenses or reduce Company contributions. A forfeiture will occur in the Plan year that a participant receives a distribution of their entire vested balance or, if they do not receive a distribution, after five consecutive one-year breaks in service. There were \$714 and \$1,005 of forfeitures available for such reductions as of December 31, 2024 and 2023, respectively. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023. Forfeitures totaling \$26,508 and \$15,273 were applied to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively.

Plan Expenses

All administrative expenses are required to be paid by the Trustee with assets of the Plan, unless paid by the Company, at its discretion. During the years ended December 31, 2024 and 2023, the Company elected to pay a portion of the Plan's direct expenses. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur that materially affect participant account balances and amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fully benefit-responsive contract is stated at contract value. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to the fully-benefit responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

The Financial Account Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Fair Value Measurement – cont'd.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Interest income is recorded on the accrual basis. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through September 24, 2025, the date the financial statements were available to be issued and determined there were no material subsequent events that warrant disclosure.

3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years then ended was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan invests in investment contracts through the Great-West Investment Fixed Account Series II (the Fund). The Fund meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. The Trustee has represented that fair value equals contract value for the Fund in which the Plan invests. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Fund invests primarily in traditional investment contracts, which is recorded at the contract rate. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed interest contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS – cont'd.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(k) of the Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

The Plan administrator does not believe that the occurrence of any events that might limit the ability of the Plan to transact with the contract issuer at contract value or that would limit the ability of the Plan to transact with the participants at contract value is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

The Plan administrator does not believe that the occurrence of any such event is probable.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by the Trustee. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. INCOME TAX STATUS

The Plan adopted a standardized prototype plan with a deferral arrangement with Empower Trust Company, LLC (the Prototype) which received a favorable opinion letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, is exempt from taxation. Subsequent to the issuance of the favorable opinion letter, the Plan was amended. Once qualified, the Prototype and the Plan are required to operate in conformity with the Code to maintain their qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

8. EXCESS CONTRIBUTIONS PAYABLE

During the years ended December 31, 2024 and 2023, the Plan failed to comply with non-discrimination rules. As a result of failing these tests, the Plan was required to refund the excess contributions to certain affected participants. As of December 31, 2024 and 2023, corrections were required to be made totaling \$22,019 and \$20,252, respectively, and are recorded as excess contributions payable in the accompanying statements of net assets available for benefits. The corrections were made in March 2025 and March 2024, respectively.
