Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gateway Dealer Network 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 26, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and the related statements of changes in net assets available for benefits for the period ended December 26, 2024 (in Liquidation) and the year ended December 31, 2023 (Ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 26, 2024 and December 31, 2023, and for the period ended December 26, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in *Note 5* to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in *Note 1* to the financial statements, the Board of Directors of Gateway Dealer Network, LLC, the Plan's sponsor, voted on February 12, 2024, to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the accrual basis used in presenting the December 31, 2023 financial statements to the liquidation basis used in presenting the December 26, 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of the Plan

General and Plan Termination

The following description of the Gateway Dealer Network 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan’s provisions.

The Plan was a defined contribution plan sponsored by Gateway Dealer Network, LLC (the “Company”) for the benefit of its employees who have at least 1,000 hours of service and are age 19 or older.

On February 12, 2024, the Plan Sponsor approved the termination of the Plan, and the Plan amendment became effective on that day. As of that date, no additional employees could become eligible, no further contributions were allowed, and all employees were fully vested in the Plan. The Plan was fully liquidated as of December 26, 2024.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Sentry Life Insurance Company (“Sentry”) serves as Plan custodian and recordkeeper.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions were also permitted. In addition to pre-tax employee deferrals, Roth elective deferrals were also permitted. Contributions were subjected to certain limitations.

Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Company made safe harbor matching contributions of 100% of the first 3% of employees’ salary deferral and 50% of the following 2% that was deferred for a total match up to 4%. Company profit-sharing contributions and additional match contributions were discretionary as determined by the Company’s Board of Directors. There were no such contributions in 2024 or 2023.

Participant Investment Account Options

Each participant had the option of directing his or her contributions into any of the various options offered by the Plan and may change the allocation daily.

The Plan Document also included an automatic deferral feature whereby a participant was treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provided for an annual increase in the percentage deferred and was ultimately capped at 10%.

Participant Accounts

Each participant’s account was credited with the participant’s contribution, the Company’s contribution and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefits to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their voluntary contributions and safe harbor matching contributions plus earnings thereon. Vesting in the Company's profit sharing and discretionary match contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested after five years of continuous service. The non-vested balance was forfeited upon termination of service. Forfeitures could be used to reduce Company contributions, restore forfeitures or to pay Plan expenses. At December 26, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$46,348, respectively. Forfeitures of \$0 and \$12,180 were used in 2024 and 2023, respectively, to pay Plan expenses. Forfeitures of \$80,269 were allocated to participant accounts in 2024.

Payment of Benefits

Upon termination of service for reasons other than death, a participant may have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or payments over a period, as defined. For termination of service on account of death, the entire account balance was to be paid to all beneficiaries by December 31 of the calendar year of the fifth anniversary of the participant's death. At December 26, 2024 and December 31, 2023, there were no participants that had elected to withdraw from the Plan but had not yet been paid.

Notes Receivable from Participants

The Plan Document included provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan was \$1,000. The maximum amount of a participant's loan was determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans were covered by demand notes and were repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant was paying the loan in full. Interest on the loans was based on local prevailing rates as determined by the Plan Administrator. Principal and interest was paid ratably through biweekly payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying 2023 financial statements were prepared on the accrual basis of accounting. Due to the termination of the Plan, the accompanying 2024 financial statements were prepared on the liquidation basis of accounting.

This change in basis had no impact on the Plan's financial statements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Quoted market prices, if available, were used to value investments.

Pooled separate accounts were valued at estimated fair value as provided by Sentry.

Fully benefit-responsive investment contracts were valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

Plan Tax Status

Effective March 1, 2022, the Plan was amended and restated to operate under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Sentry Life Insurance Company. This prototype Plan Document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt. The Plan has been amended since adopting the prototype; however, the Plan Administrator believes that the Plan and related trust were designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

Note 3: Transfer of Plan Assets

Effective June 5, 2023, the Plan was amended and restated, and the GDN Southwest 401(k) Plan was merged into the Plan. The GDN Southwest 401(k) Plan assets were transferred to the Plan into funds comparable to those offered by the previous custodian. The conversion initiated a “Black Out” period for the Plan beginning June 2, 2023 and continued through June 16, 2023. During this period, funds could not be applied to the employee-selected funds with the custodian or withdrawn from the Plan until the custodian had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited and held in the fiduciary until the completion of the Black Out period. At the end of the Black Out period, these funds were transferred to the Gateway Dealer Network 401(k) Plan and invested in funds as requested by each participant.

Note 4: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There were no significant changes in the valuation techniques during the period ended December 26, 2024 and year ended December 31, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments were classified within Level 1 of the valuation hierarchy. If quoted market prices were not available, then fair values were estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates and cash flows. Such investments were classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs were not available, investments were classified within Level 3 of the hierarchy. There were no Level 1 or Level 3 investments held by the Plan.

Note 5: Certification of Plan Custodian

The Plan Administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Sentry Life Insurance Company, a qualified institution, certified the following investment information included in the accompanying financial statements is complete and accurate:

Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 26, 2024 and December 31, 2023.

Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period ended December 26, 2024 and the year ended December 31, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 6: Investment Contract with Insurance Company

The Plan participated in a fully benefit-responsive investment contract, the Guaranteed Fund, with Sentry Life Insurance Company ("Sentry") for the period ended December 26, 2024 and year ended December 31, 2023.

Sentry maintained the contributions in a general account. The accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers were contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contracts were fully benefit responsive, therefore, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuers or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events included the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator did not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, was probable.

Note 7: Related Party and Party-in-Interest Transactions

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, an employee organization whose members were covered by the Plan, a person who owned 50% or more of such an employer or relatives of such persons.

The Plan invested in a guaranteed investment account with Sentry.

The Plan invested in certain funds managed by the custodian, which is a related party to the Plan. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

Note 8: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$4,518 were not remitted within the required time period for year ended December 31, 2022.

Note 9: Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Subsequent Events

Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.
