Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of McConnell Golf 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of McConnell Golf 401(k) Profit Sharing Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of McConnell Golf 401(k) Profit Sharing Plan (the "Plan") provides only general information for the Plan sponsored by McConnell Golf, LLC (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on January 1, 1990. The Plan covers all non-union, resident employees of the Company who have reached age 21 and have completed one year of service (1,000 hours). Effective January 1, 2024, the Plan was amended to reduce the service requirement to 500 hours within a consecutive 12-month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Assets of the Plan are held by a plan custodian selected by the plan sponsor. The Company acts as the Plan's sponsor.

Contributions

Each year participants may elect to defer up to 100% of their pre-tax or after-tax ("Roth") annual compensation, subject to the contribution limits imposed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes matching contributions in an amount equal to 50% of the first 5% of employees' eligible contributions. The Company may decide to make an additional contribution at the discretion of the Company's Board of Trustees, but is not required to do so. There were no additional discretionary contributions in 2024. The Plan permits rollover contributions from other qualifying retirement plans.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and allocations of plan earnings. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount contributed to the Plan. Vesting in the Company's matching and discretionary contribution portion of their accounts is based on the years of credited service. Participants are fully vested after completing five years of credited service.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$5,995. Forfeitures can be used to pay administrative expenses or to reduce employer matching contributions as permitted by the Plan's provisions. During the year ended December 31, 2024, the Plan used \$5,648 of forfeited accounts to reduce employer matching contributions.

1. Description of Plan (Continued)

Payment of Benefits

Generally, the participant becomes eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. For retirement, death or disability, the participant may receive 100% of their account balance in a lump sum amount, or in installments, as defined. Participants who terminate their employment will receive their vested account balance under the same options as above. If the vested balance is less than \$5,000, a lump sum distribution is made. Effective January 1, 2024, this amount increased to \$7,000. Participants are also eligible to make in-service withdrawals once they attain age 59½.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their elective deferral contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the excess of the highest outstanding loan balance in the last 12 months over the current outstanding balance as of the date of the new loan. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participants' accounts and bear a fixed interest rate at the prime rate plus 1.0% (8.50% at December 31, 2024) as determined on the date of the newly issued loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 and 2023 were \$135,633 and \$138,552, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are comprised of a guaranteed investment contract and mutual funds. The Plan's investments are reported at fair value except for the guaranteed investment contract, which is valued at contract value (see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Realized and unrealized appreciation and depreciation in the value of investments are allocated to the participant accounts based on participant holdings in each fund.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

3. Federal Income Taxes

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. Plan management believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the employer portion of their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, the custodian of the Plan, and Empower Trust Company, LLC, the trustee of the Plan, (collectively "Empower"), and was not subject to audit for the years ended December 31:

6. Fair Value Measurements (Continued)

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 Inputs are based on significant other observable inputs such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

7. Guaranteed Investment Contract

The Talcott Fixed Account (the “Fund”) is a fully benefit-responsive guaranteed investment contract, whose principal objective is to maintain a competitive fixed interest rate and a minimum guaranteed rate of return. The fixed account is invested in the general asset account of Talcott Resolution Life Insurance Company (“Talcott”) and is guaranteed by Talcott’s claims paying ability. Talcott’s general account is primarily invested in investment grade fixed income securities.

7. Guaranteed Investment Contract (Continued)

The fixed account is credited with interest at a rate declared by Talcott on a quarterly basis. The declared interest rate is determined for any quarter at the discretion of Talcott. It will guarantee the declared interest rate applicable to any quarter to the end of the quarter in which the change was applied. The declared interest rate will be declared before the start of the quarter to which the rate applies. Talcott will determine the minimum guaranteed interest rate such that the net surrender value shall meet or exceed the non-forfeiture amount pursuant to the state's standard non-forfeiture law.

8. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-in-Interest Transactions

Plan investments are managed by Empower, the custodian and trustee of the Plan. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the custodian, trustee, and other parties-in-interest for investment management and administrative services amounted to \$102,231 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

10. Reconciliation to Form 5500

The financial statements show the Plan's investments as mutual funds. Because all of these mutual funds are held under a single contract, Empower has reported the investments as a pooled separate account in the Form 5500.

11. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 22, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective starting at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
