Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Morton Community Bank 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Morton Community Bank 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 - PLAN DESCRIPTION

The following description of the Morton Community Bank 401(k) Retirement Plan (Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan includes all companies in the control group. Morton Community Bank and Hometown-U, Inc. are wholly-owned subsidiaries of Hometown Community Bancorp, Inc. Hometown Community Bancorp, Inc. also owns an 80.01% stake in David Vaughan Investments, LLC.

Hometown-U, Inc. was formerly known as James Unland & Co. James Unland & Co. operated as an insurance agency. Effective June 1, 2023, the business operations of James Unland & Co. were sold to Financial Risk Partners, Corp. In connection with the sale, all employees of James Unland & Co. terminated employment and were hired by Financial Risk Partners, Corp.

The Administrator and Recordkeeper for the Plan is Alliance Pension Consultants. David Vaughan Investments, LLC is the Investment Advisor for the Plan and Charles Schwab Trust Bank is the Plan custodian.

General

The Plan is a defined contribution plan covering all employees of Morton Community Bank (Bank) as well as employees of Affiliated Employers, which includes Hometown-U, Inc. and David Vaughan Investments, LLC age 18 or older and having attained one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective June 10, 2023, the plan was amended to reduce the minimum age for participation in the plan from 21 to 18. Effective January 1, 2024, employees are eligible for discretionary profit sharing contributions if they are age 18 years or older, have completed six months of service, and are employed on the last day of the Plan year. Prior to 2024, employees were eligible for discretionary profit sharing contributions if they were 21 years or older with one year of service.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, or the maximum permissible amount under law, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various mutual fund investment options, a collective investment trust, or self-directed brokerage accounts offered by the Plan. Employer contributions to the Plan are at the sole discretion of the Bank and other Affiliated Employers and are invested as directed by the participants. There were no Bank or Hometown U, Inc. contributions for the years ended December 31, 2024 and 2023. Employer discretionary profit sharing contributions of \$739,139 and \$661,483 were made by David Vaughan Investments, LLC for the 2024 and 2023 Plan years, respectively.

Participant Accounts

Each employer's participant's account is credited with the participant's contribution and allocations of (a) the employer's discretionary contributions and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on the participant's eligible compensation or participant's account balance or participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions. Employer contributions vest based on a percentage of the total amount credited to the participant's account determined on the basis of the participant's number of years of service as shown below.

Notes Receivable From Participants

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid over a level amortization not less frequently than quarterly.

Payment of Benefits

On termination of service due to death, disability, retirement, or other termination, a participant or beneficiary may elect to either receive a lump sum amount equal to the value of the participant's vested account balance or equal monthly, quarterly, or annual installment payments over a period of years not longer than their life expectancy or the joint and last survivor life expectancies of the participant and their beneficiary. If a participant's vested account balance does not exceed \$5,000 at termination, it is distributed either in a single lump sum amount or rolled over to an individual retirement account. The Plan allows for in-service distributions if a participant reaches age 59 ½ subject to Plan provisions.

Payment of Benefits (Continued)

The Plan's hardship distribution provisions list the expenses and circumstances that qualify for a hardship distribution and require that participants certify they have insufficient cash or other liquid assets available to meet their hardship need. Employees are not required to temporarily suspend their elective deferrals during a hardship period.

Forfeited Accounts

Forfeited nonvested accounts can be used to reduce administrative expenses or Employer contributions. There was a balance of \$7,994 and \$0 at December 31, 2024 and 2023, respectively in the forfeited nonvested account. There were forfeitures of \$7,994 and \$0 used to reduce Employer contributions and administrative expenses for the years ended December 31, 2024 and December 31, 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding deduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Administrative Expenses

Administrative and operating expenses are paid either by the Plan or by the Bank. Total administrative expenses incurred by the Plan for the years ended December 31, 2024 and 2023 were \$120,662 and \$85,185, respectively.

Subsequent Events

Management evaluated subsequent events through September 17th, 2025, the date the financial statements were available to be issued.

NOTE 3 – CERTIFICATION OF INVESTMENT INFORMATION

For 2024 and 2023, Charles Schwab Trust Bank, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at the end of the year) as of December 31, 2024.

NOTE 4 - FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds and unit investment trusts are valued at the net asset value ("NAV"), based on quoted market prices in active markets, of shares held by the Plan at year end.

The collective investment trust is valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Self-directed brokerage accounts primarily consist of common stocks, U.S. Treasury securities, unit investment trusts, and mutual funds that are valued on the basis of readily determinable market prices. Common stocks and U.S. Treasury securities are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

For the 2024 and 2023 Plan years, David Vaughan Investments LLC was the investment advisor for the Plan and Charles Schwab Trust Bank was the qualified institution of the Plan. Fees paid to David Vaughan Investments for the years ended December 31, 2024 and 2023 were \$36,587 and \$35,615, respectively. For the 2024 and 2023 Plan years, Alliance Pension Consultants was the third party administrator of the Plan. Fees paid to Alliance Pension Consultants for the years ended December 31, 2024 and 2023 were \$69,695 and \$40,108, respectively.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

NOTE 7 - TAX STATUS

The Employers have adopted a non-standardized prototype plan designed by FIS Business Systems LLC. The IRS has determined and informed FIS Business Systems LLC by a letter dated June 30, 2020, that their prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype plan has been adopted and amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
