## **Independent Auditor's Report**

To the Plan Administrator  
The Edison Institute 403(b) TDA Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We were engaged to perform audits of the financial statements of The Edison Institute 403(b) TDA Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in Note 3, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. If the identified contracts, as reported by the plan administrator, were included, net assets would increase by approximately \$4,123,000 and \$3,956,000 as of December 31, 2024 and 2023, respectively. Further investment income of approximately \$486,000 and distributions of approximately \$319,000 related to such accounts, as identified by the plan administrator, have also been excluded from the accompanying statement of changes in net assets available for benefits for the years then ended. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

***Auditor's Responsibilities for the Audits of the Financial Statements***

However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

***Supplemental Schedules Required by ERISA***

The supplemental schedules of assets held at end of year as of December 31, 2024 and nonexempt transactions for the year ended December 31, 2024 are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

### Note 1 - Plan Description

The following description of The Edison Institute 403(b) TDA Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible full-time, part-time, and seasonal employees of The Edison Institute (the "Institute"), as determined according to the provisions of the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides employees the opportunity to contribute a portion of their compensation as a pretax deferral subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants are eligible to contribute to the Plan immediately upon hire unless they are considered an excluded employee. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions in which the employer will contribute a percentage of the employee's eligible compensation based on the employee's elective deferral percentage. The Plan provides for employer matching contributions of 200 percent of the participant's contribution, not to exceed 3 percent of the employee's eligible compensation.

Full-time employees are eligible to participate and receive employer matching contributions immediately. Part-time or seasonal employees are eligible to receive employer matching contributions on the January 1 or July 1 coincident with or following the earlier of (1) the one-year period beginning on their hire date provided they have completed 1,000 hours during that initial period with the Institute or (2) the last day of the plan year commencing after their date of hire in which they complete 1,000 hours of service. Additionally, part-time or seasonal employees must reach the age of 21 to be eligible for employer matching contributions.

The Institute also provides for a discretionary matching contribution in an amount to be determined from year to year at the Institute's discretion, which is allocated to qualified participants in the ratio of each qualified participant's compensation to the total compensation of all qualifying participants. There were no employer discretionary matching contributions for the years ended December 31, 2024 and 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Institute's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Benefit Payments**

Distribution of a participant's elective deferrals and any employer contributions are payable upon termination of employment, the inurrence of a disability, or attainment of the age of 59½. Distributions may be received in the form of a lump sum, partial payments, installment payments, or an annuity amount. Certain amounts invested in the Teachers Insurance and Annuity Association of America (TIAA) Traditional Annuity may not be distributed in a lump sum (see redemption restrictions below).

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

**Note 1 - Plan Description (Continued)**

***Redemption Restrictions***

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Transfers from the Transfer Payout Annuity (TPA) and Group Retirement Annuity (GRA) contracts must be paid out in 10 annual installments. Withdrawals from the GRA contract are available within 120 days after termination of employment, subject to a 2.5 percent surrender charge; otherwise, they must be paid over 10 annual installments or 84 monthly systematic payments, respectively. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals.

***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Institute's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Institute 100 percent after two years of service.

***Forfeitures***

If a participant is not fully vested on their termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future institute contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$11,919 and \$4,888, respectively.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by TIAA and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF), Voya Retirement Insurance and Annuity Company (VRIAC), and Voya Institutional Trust Company (VITC) or their affiliates. TIAA-CREF, VRIAC, and VITC are the service providers of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

During the year ended December 31, 2022, a nonexempt transaction with a party in interest occurred when assets of the Plan, totaling \$1,542, were inadvertently refunded to the plan sponsor. This transaction is reported within the schedule of nonexempt transactions. The plan sponsor corrected this transaction by contributing lost earnings to the Plan in 2024.

***Termination***

While it has not expressed any intent to do so, the Institute has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except as noted below.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

The TIAA Traditional Annuity is a guaranteed annuity account issued by TIAA that invests in the general assets of TIAA. TIAA considers the Group Supplemental Retirement Annuity (GSRA) contract to be benefit responsive. TIAA considers the following contracts to be non-benefit responsive: GRA and TPA. The benefit-responsive portion is reported at contract value. The non-benefit-responsive portion is reported at fair value. Since there are no specific securities in TIAA's general account related to these contracts and, due to the contract terms, including the frequency of the interest rate reset intervals, contract value is the best estimate of the fair value. The Voya Fixed Plus Account III is considered a fully benefit-responsive unallocated contract valued at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals.

The registered investment companies are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. The pooled separate account is valued at NAV (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets, which consist primarily of rental property subject to long-term leases, and has been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices reported in active markets. See Note 7 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$108,234 and \$121,227 for the years ended December 31, 2024 and 2023, respectively.

***Allocated Contracts***

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

***Administrative Expenses***

Various administrative costs are paid by the Institute.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 29, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Excluded Investments**

The Plan has excluded from investments in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023 certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. If the identified contracts, as reported by the various custodians, were included, net assets would increase by approximately \$4,123,000 and \$3,956,000 as of December 31, 2024 and 2023, respectively. Further, net investment income of approximately \$486,000 and \$341,000 and distributions of approximately \$319,000 and \$71,000 related to such accounts, as identified by the various custodians, have also been excluded from the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. GAAP requires these accounts and the related income and distributions be included in the accompanying financial statements.

**Note 4 - Certified Information**

TIAA-CREF, VRIAC, and VITC (the "Service Providers") hold certain of the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Service Providers.

The Plan has excluded certain assets from the statement of net assets available for benefits at December 31, 2024 and 2023 (see Note 3).

**Note 5 - Tax Status**

The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of IRC Section 403(b). Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has not yet requested or received a determination letter.

**Note 6 - Annuity Contracts**

The Plan has benefit-responsive investment contracts with TIAA-CREF and VRIAC.

The total TIAA Traditional Annuity balance was \$3,886,174 and \$3,846,237 at December 31, 2024 and 2023, respectively. Based on the terms of the contracts, a portion of the TIAA annuity is considered benefit responsive. The benefit-responsive portion totaled \$3,045,318 and \$2,909,723 at December 31, 2024 and 2023, respectively. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Voya Fixed Plus account balance was \$82,948 and \$72,569 at December 31, 2024 and 2023, respectively, and is considered benefit responsive.

**Note 6 - Annuity Contracts (Continued)**

The Voya Fixed Plus account is an obligation of VRIAC's general account, which supports all of VRIAC's insurance and annuity commitments. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. When establishing interest crediting rates for this product, VRIAC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The minimum crediting rate under the VRIAC contract is 1.00 percent.

Interest is credited on the TIAA Traditional Annuity contract balances using a vintages approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, minimum crediting rates are between 1.00 percent and 3.00 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contracts described above are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Note 7 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

**Note 7 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan has excluded certain assets from the statement of net assets available for benefits at December 31, 2024 and 2023 (see Note 3). The following tables present information about the included plan assets measured at fair value on a recurring basis at December 31, 2024 and 2023:
