## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Cooley Incorporated Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cooley Incorporated Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

## **1. Description of the Plan**

The following description of the Cooley Incorporated Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

### ***General***

The Plan is a participant-directed defined contribution 401(k) plan established on October 1, 1983 covering substantially all employees of Cooley, Incorporated (the Employer or Plan Administrator). Employees of the Employer who have completed one month of service and have attained the age of 18 are eligible to become participants in the Plan on that date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Retirement Committee, consisting of certain officers and members of the Employer's Board of Directors, administers the Plan on behalf of the Employer. As administrator, the committee has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) is the appointed trustee of the Plan, and acts at the direction of the Plan Administrator.

### ***Contributions***

Participants may elect to contribute any percentage of their eligible pretax compensation, not to exceed annual limitations as provided by the Internal Revenue Code (IRC). Participants may designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Employer may contribute a discretionary matching contribution based on deferral contributions made during each Plan year. For the year ended December 31, 2024, the Employer elected to contribute 50% of the first 6% of participants' eligible compensation deferred into the Plan. The Employer may also make additional discretionary contributions to the Plan as determined by the Employer's Board of Directors. These contributions will be allocated based on a calculation factoring individual Plan participants' compensation in proportion to total compensation of all Plan participants. There were no additional discretionary contributions made to the Plan during the year ended December 31, 2024.

Plan participants are automatically enrolled into the Plan with their deferral rate set at 6% (increased from 4% effective February 1, 2024) of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Upon enrollment into the Plan, a participant may direct contributions among various investment vehicles that invest in a variety of equity securities and mutual funds with varying investment goals and risks.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Employer's contribution, and their allocation of the Plan's earnings. The allocation of earnings and losses is based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions and actual earnings thereon. Vesting in the Employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. Participants are 10% vested upon completion of one year of service, 20% upon completion of two years of service, and 100% upon completion of three years of service. Each participant shall be 100% vested in their account upon death, disability, attainment of early retirement age (55) coupled with completion of three years of service, or attainment of normal retirement age (65).

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the participant's loan fund. Note terms range from 1 to 5 years, or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant with a vested benefit (excluding rollovers) exceeding \$7,000 (increased from \$5,000 effective January 1, 2024) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly, quarterly or annual installments over a period of not more than the assumed life expectancy of the participant. For termination of service for other reasons or a lesser vested benefit, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's vested balance is less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 but is less than \$7,000 (increased from \$5,000 effective January 1, 2024), the amount will be rolled over to an individual retirement plan designated by the Plan Administrator.

Financial hardship withdrawals are also permitted with self-certification of financial hardship by the participant, subject to limitations imposed by the IRC.

Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed. The Plan also provides for mandatory distributions to participants upon reaching the Required Minimum Distribution age, as defined.

In 2024, the Plan adopted certain provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, including an increase in the automatic cashout threshold from \$5,000 to \$7,000. Additional SECURE 2.0 provisions may also apply based on plan design and future regulatory guidance.

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing three years of service forfeit the non-vested portion of their accounts. At December 31, 2024 and 2023, forfeitures available amounted to \$2,544 and \$3,067, respectively. Forfeitures are retained in the Plan and may be used to pay administrative expenses of the Plan or to reduce Employer contributions. During 2024, forfeitures of \$21,994 were used by the Employer to offset Employer contributions.

***Plan Termination***

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Contributions***

Participant deferral and Employer matching contributions are recorded weekly when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary contributions are made at the end of each year, if applicable.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

Effective July 12, 2024, the Plan allows auto-portability of certain small account balances of terminated participants, whereby a third-party service provider will locate the terminated participant's new employer and transfer the terminated participant's account balance to an active account in the new employer's plan. If, after a period of two years, a new employer cannot be located, the terminated participant's account balance will be automatically rolled over into an IRA with a third-party vendor. Participants have the option to opt out of this auto-portability service.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3).

The Plan invests in the Fidelity Advisor Stable Value Fund (FASVF), which is a common collective trust fund. The Plan's interest in the FASVF is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust at year end. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document.

***Excess Contributions Refundable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year end.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds that accounted for approximately 65% and 67% of total Plan investments as of December 31, 2024 and 2023, respectively.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Fund:* The carrying amount of the money market fund is valued at deposit amount plus accrued interest, as determined according to stated terms.

*Common Collective Trust Fund:* The Plan invests in the Fidelity Advisor Stable Value Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities and money market funds. It is valued at NAV of units held by the Plan. The NAV, as provided by Fidelity, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan level.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan’s investments in money market and mutual funds are reported at level 1 within the fair value hierarchy.

**4. Income Tax Status**

The Plan has been designed using a volume submitter plan document designed by Fidelity Management & Research Co. (Fidelity Management). Fidelity Management received a determination letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. Summary of Information Certified by the Trustee**

**6. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500 and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**7. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are held and managed by Fidelity. Fidelity is also the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Fidelity for administrative services of \$26,372 for the year ended December 31, 2024. The Plan also made payments of \$22,000 to its independent investment advisor during 2024. Participant notes receivable also qualify as party-in-interest transactions.
